- a. the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;
  - b. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended; provided further, that the amendments made to such item (f) by section two of this act shall survive the expiration as provided in subdivision c of section 3 of chapter 68 of the laws of 2015;
