- AN ACT to amend the election law, in relation to authorizing electronic absentee ballot applications

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (c) of subdivision 2 of section 8-400 of the 1 2 election law, as amended by chapter 321 of the laws of 1988, is amended 3 to read as follows: 4 (c) All applications requesting that a ballot be delivered to the 5 voter or an agent by mail must be mailed to the board of elections not 6 later than the seventh day before the election for which a ballot is first requested or, for applications requesting in-person delivery of 7 8 the ballot to the voter or an agent at the board of elections, must be 9 delivered to such board not later than the day before such election. In 10 addition to postal or personal delivery of the application to the board 11 of elections, the board of elections shall accept delivery of absentee ballot applications: (i) by telephone facsimile transmission to a phone 12 number which shall be designated by the board of elections; (ii) as an 13 14 attachment to an electronic mail transmission sent to an electronic mail 15 address which shall be designated by the board of elections; and (iii) 16 through an online electronic absentee ballot application filing system which shall be established by the state board of elections and which 17 18 shall transmit each application to the appropriate board of elections 19 for processing. email address and telephone facsimile number required by this 1 the section and shall provide a link to the online electronic filing system 2 established pursuant to this section. An application delivered to the 3 4 board of elections by electronic means shall be an original application 5 without necessity for a subsequent conforming paper submission and shall б be deemed filed when received by the board of elections, except if 7 received by electronic means after business hours or extended hours as designated by this chapter, such application shall be deemed received as 8 9 of the next day on which the board is open to receive absentee ballot 10 applications. Nothing in this section shall be construed to prevent the 11 application of the electronic signature provisions of the state technology law with respect to applications for an absentee ballot. 12 13 § 2. Subdivision 2 of section 10-107 of the election law, as added by 14 chapter 104 of the laws of 2010, is amended to read as follows: 15 2. Irrespective of the preferred method of transmission designated by 16 a military voter, a military voter's original completed voter registration application[, military ballot application] and military ballot must 17 be returned by mail or in person notwithstanding that a prior copy was 18 19 sent to the board of elections by facsimile transmission or electronic 20 mail. A completed military ballot application submitted by facsimile 21 transmission or electronic mail or through an electronic filing system established by the state board of elections shall be an original appli-22 cation and no conforming paper submission shall be required. 23 24 § 3. Subdivision 2 of section 11-203 of the election law, as added by 25 chapter 104 of the laws of 2010, is amended to read as follows: 26 2. Irrespective of the preferred method of transmission designated by 27 a special federal voter, a special federal voter's original completed voter registration application[, special federal ballot application] and 28 29 special federal ballot must be returned by mail or in person notwith-30 standing that a prior copy was sent to the board of elections by facsim-31 ile transmission or electronic mail. A completed special federal ballot 32 application submitted by facsimile transmission or electronic mail or 33 through an electronic filing system established by the state board of elections shall be an original application and no conforming paper 34 35 submission shall be required. 36 § 4. This act shall take effect on the first of January next succeed-

37 ing the date on which it shall have become a law.
