AN ACT to amend the public health law, in relation to the fee for issuance of birth and death records in the city of Jamestown

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 4173 of the public health law, as amended by chapter 524 of the laws of 2007, is amended to read as follows:

3 3. [The] (a) Except as otherwise provided in paragraph (b) of this 5 <u>subdivision</u>, the registrar shall be entitled to a fee of ten dollars[7 except in the county of Chemung and the county of Monroe and the county 7 of Onondaga and the county of Tompkins whereby such fee shall be set by 8 the county health commissioner and in the city of Oswego whereby such fee shall be set by the Oswego common council, up to the amount charged 9 10 by the commissioner as prescribed in subdivision two of section forty-11 one hundred geventy four of this title | for each certification of birth or death or for each certified copy or certified transcript of any 12 13 record of a birth or of a death or for a certification that a search discloses no record of a birth or of a death, furnished by him or her to 14 15 an applicant, except that no fee shall be charged for a search, certification of birth or death or certified copy or certified transcript of a 17 birth or a death record to be used for school entrance, employment certificate or for purposes of public relief or government compensation 18 or when required by the veterans administration to be used in determin-19 20 ing the eligibility of any person to participate in the benefits made available by the veterans administration, provided, however, that if 22 such registrar is a city clerk, town clerk or village clerk, he or she shall collect such fees for and on behalf of the city, town or village in which he or she serves, provided, however, that an amount equivalent 25 to the sum of such fees shall be paid at least monthly by such city,

- 3 (b) Notwithstanding the provisions of paragraph (a) of this subdivi4 sion, in the counties of Chemung, Monroe, Onondaga and Tompkins the fee
 5 shall be set by the county health commissioner, and in the cities of
 6 Oswego and Jamestown the fee shall be set by the city legislative body.
 7 In such counties and cities the fee may be set up to the amount charged
 8 by the commissioner as prescribed in subdivision two of section forty9 one hundred seventy-four of this title.
