AN ACT to amend the environmental conservation law, in relation to prohibiting the use of glyphosate and products containing glyphosate in certain parks, playgrounds and picnic areas

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

(a) Glyphosate means a synthetic compound that is a non-selective systemic herbicide, also known as N-(phosphonomethyl) glycerine with a chemical formula of C3H8N05P. (b) "Municipality" means a city, county, town, village, public benefit corporation or school district or and improvement district within a city, county, town or village, or any combination thereof. 3. The department is authorized to promulgate such rules and regu- lations as it shall deem necessary to implement the provisions of this section.
