AN ACT to amend the mental hygiene law, in relation to the heroin and opioid addiction wraparound demonstration services program; and to amend chapter 32 of the laws of 2014, amending the mental hygiene law relating to the heroin and opioid addiction wraparound demonstration services program, in relation to the effectiveness thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 19.18-a of the mental hygiene law, as amended by section 1 of part C of chapter 69 of the laws of 2016, is amended to read as follows:

§ 19.18-a Heroin and opioid addiction wraparound services [demonstruction] program.

- 1. The commissioner, in consultation with the department of health shall develop a heroin and opioid addiction wraparound services [demonstration] program. This program shall provide wraparound services to adolescent and adult patients during treatment, including, but not limited to, inpatient and outpatient treatment, and shall be available to such patients for a clinically appropriate period for up to nine months after completion of such treatment program. The commissioner shall identify and establish where the wraparound services [demonstration] program will be provided.
- 15 2. Wraparound services shall include;
 - (a) Case management services which address:
- 17 (i) Educational resources;
- 18 (ii) Legal services;

- 19 (iii) Financial services;
- 20 (iv) Social services;
- 21 (v) Family services; and
- 22 (vi) Childcare services;

- (b) Peer supports, including peer to peer support groups;
- (c) Employment support; and

- 4 3. Not later than June 30, 2018, the commissioner shall provide the governor, the temporary president of the senate, the speaker of the assembly, the chair of the senate standing committee on alcoholism and drug abuse and the chair of the assembly committee on alcoholism and 7 drug abuse with a written evaluation of the $\left[\frac{\text{demonstration}}{\text{demonstration}}\right]$ program. 9 Such evaluation shall, at a minimum, address the overall effectiveness 10 of this [demonstration] program, identify best practices for wraparound services provided under this [demonstration] program, and any additional 11 wraparound services that may be appropriate within each type of program 12 operated, regulated, funded, or approved by the office and address 13 14 whether continuation or expansion of this [demonstration] program is 15 recommended. The written evaluation shall be made available on the 16 office's website.
- 17 § 2. Section 2 of chapter 32 of the laws of 2014, amending the mental 18 hygiene law relating to the heroin and opioid addiction wraparound 19 services demonstration program, as amended by section 2 of part C of 20 chapter 69 of the laws of 2016, is amended to read as follows:
- 21 § 2. This act shall take effect immediately [and shall expire and be 22 deemed repealed March 31, 2019].
- 23 § 3. This act shall take effect immediately.
