AN ACT to amend the education law, in relation to exempting BOCES capital expenditures from limitations upon local school district tax levies; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph c of subdivision 2 of section 2023-a of the education law, as amended by section 1 of subpart C of part C of chapter 20 of the laws of 2015, is amended to read as follows:

c. "Capital local expenditures" means (i) the taxes associated with budgeted expenditures resulting from the financing, refinancing, acquisition, design, construction, reconstruction, rehabilitation, improvement, furnishing and equipping of, or otherwise providing for school district capital facilities or school district capital equipment, including debt service and lease expenditures, and transportation capital debt service, and (ii) the school district's share of capital local expenditures, as defined in subparagraph (i) of this paragraph, for boards of cooperative educational services as authorized pursuant to section nineteen hundred fifty of this title and approved by the commissioner,

subject to the approval of the qualified voters where required by law. ~~[The commissioner of taxation and finance shall, as appropriate, promulgate rules and regulations which may provide for adjustment of capital local expenditures to reflect a school district's share of~~

3 § 2. Subparagraph 1 of paragraph b of subdivision 4 of section 1950 of
4 the education law, as amended by chapter 474 of the laws of 1996, is
5 amended to read as follows:

6 (1) Prepare, prior to the annual meeting of members of the boards of
7 education and school trustees, held as provided in paragraph o of this
8 subdivision, a tentative budget of expenditures for the program costs, a
9 tentative budget for capital costs, and a tentative budget for the
10 administration costs of the board of cooperative educational services.
11 Such budgets shall include the proposed budget for the upcoming school
12 year, the previous school year's actual costs and the current school
13 year's projected costs for each object of expenditure. Such program,
14 capital and administrative budgets shall be separately delineated in
15 accordance with the definition of program, capital and administrative
16 costs which shall be promulgated by the commissioner after consultation
17 with school district officials and the director of the budget. Personal
18 service costs for each budget shall include the number of full-time
19 equivalent positions funded and total salary and, except as noted here-
20 in, fringe benefit costs for such positions by program. Each program
21 budget shall also include the local and statewide unit costs of such
22 programs and services proposed for the upcoming school year, such actual
23 unit costs for the previous school year, and the current school year's
24 projected unit costs, all established in accordance with paragraph d of
25 this subdivision. The capital budget shall include facility construction
26 and lease expenditures authorized pursuant to paragraphs p, t and u of
27 this subdivision, payments for the repayment of indebtedness related to
28 capital projects, payments for the acquisition or construction of facil-
29 ities, sites or additions, provided that such budget shall contain a
30 rental, operations and maintenance section that will include base rent
31 costs, total rent costs, operations and maintenance charges, cost per
32 square foot for each facility rented or leased by such board of cooper-
33 ative educational services, and any and all expenditures associated with
34 custodial salaries and benefits, service contracts, supplies, utilities,
35 maintenance and repairs for such facilities, and that such budget shall
36 include the annual debt service and total debt for all facilities
37 financed by bonds or notes of the component districts, annual rental and
38 lease payments and total rental and lease costs for all facilities rent-
39 ed by such board; such capital budget shall also include expenditures
40 resulting from court judgments and orders from administrative bodies or
41 officers, and, to the extent a board's administrative budget has been
42 adopted, one-time costs incurred in the first year in which an employee
43 retires. The administrative budget shall include, but need not be limit-
44 ed to, office and central administrative expenses, traveling expenses
45 and salaries and benefits of supervisors and administrative personnel
46 necessary to carry out the central administrative duties of the supervi-
47 sory district, any and all expenditures associated with the board, the
48 office of district superintendent, general administration, central
49 support services, planning, and all other administrative activities.
50 Such administrative budget shall also specify the amount of supplementa-
51 ry salary and benefits, if any, which the board determines should be
52 paid to the district superintendent of schools and the board shall
53 append to such budget a detailed statement of the total compensation to
54 be paid the district superintendent of schools by the board, including a
55 delineation of the salary, annualized cost of benefits and any in-kind
56 or other form of remuneration to be paid, plus, commencing with the

1 presentation of the budget for the nineteen hundred ninety-seven--nine-
2 ty-eight school year, a list of items of expense eligible for reimburse-
3 ment on expense accounts in the ensuing school year and a statement of
4 the amount of expenses paid to the district superintendent of schools in
5 the prior year for purposes of carrying out his or her official duties;
6 provided, however, any school district's share of capital local expendi-
7 tures of a board of cooperative educational services, as defined in
8 subparagraph (ii) of paragraph c of subdivision two of section two thou-
9 sand twenty-three-a of this title, and approved by the commissioner
10 shall not be included in a school district's tax levy pursuant to such
11 section.

12 § 3. This act shall take effect immediately; provided that the amend-
13 ments to paragraph c of subdivision 2 of section 2023-a of the education
14 law made by section one of this act shall be subject to the repeal of
15 such section and shall be deemed repealed therewith; provided, further,
16 that the amendments to subparagraph 1 of paragraph b of subdivision 4 of
17 section 1950 of the education law made by section two of this act shall
18 expire on the same date and manner as section 13 of part A of chapter 97
19 of the laws of 2011, as amended.
