- AN ACT to direct the commissioner of education to appoint a media literacy advisory committee to study the teaching of media literacy; and to amend the education law, in relation to creating a media literacy advisory committee to annually review policy and procedures on media literacy

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. For purposes of this act, "media literacy" shall be considered a broad term that encompasses consumption and production of media and digital products and is defined as the ability to access, analyze, evaluate, act and create with all forms of communication, and encompasses the foundational skills of digital citizenship and internet safety including the norms of appropriate, responsible, healthy behavior, and cyberbullying prevention.

8 § 2. The commissioner of education, in cooperation with experts in 9 media literacy, the board of regents of the university of the state of 10 New York, and stakeholders including educators and parents, shall 11 appoint a media literacy advisory committee ("committee") to conduct a 12 study on teaching of media literacy in schools.

S 3. The committee shall make a report of its findings, including any recommendations for legislative action as it may deem necessary and appropriate, best practices for instruction that provides guidance about thoughtful, safe, and strategic uses of online and other media resources and education on how to apply critical thinking skills when consuming
