AN ACT to amend the general business law, in relation to exempting white collar boxers from provisions related to combative sports

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 1021 of the general business law, as added by chap-
2 ter 32 of the laws of 2016, is amended to read as follows:

3 § 1021. Exceptions. The provisions of this article except as provided
4 in subdivision twelve of section one thousand fifteen of this article
5 shall not be construed to apply to any sparring or boxing contest or
6 exhibition conducted under the supervision or the control of the New
7 York state national guard or naval militia where all of the contestants
8 are members of the active militia; nor to any such contest or exhibition
9 where the contestants are all amateurs, sponsored by and under the
10 supervision of any university, college, school or other institution of
11 learning, recognized by the regents of the state of New York; nor to any
12 business entity incorporated for the purposes of providing instruction
13 and evaluation in a combative sport to customers for the purposes of
14 health and fitness, personal development, self-defense or participation
15 in amateur events conducted by an authorized sanctioning entity; nor to
16 any such contest or [~~exhibitions~~] exhibition where the contestants are
17 all amateurs sponsored by and under the supervision of the American
18 Olympic Association or, in the case of boxing, the U.S. Amateur Boxing
19 Federation or its local affiliates or the American Olympic Association;
20 nor to any such contest or exhibition where the contestants are all
21 white collar boxers sponsored by or under the supervision of the United
22 States White Collar Boxing, Inc.; nor except as to the extent provided
23 otherwise in this article, to any professional wrestling contest or
24 exhibition as defined in this article. For the purposes of this
25 section, the term "white collar boxer" shall mean a person who is not a

1 professional boxer nor an amateur registered with the U.S. Amateur
2 Boxing Federation, and who engages in boxing or sparring contests or
3 exhibitions where no cash prizes are awarded to participants, and where
4 the prize competed for shall not exceed, in value, thirty-five dollars
5 or a maximum amount established by the United States White Collar
6 Boxing, Inc. Any individual, association, corporation or club, except
7 elementary or high schools or equivalent institutions of learning recog-
8 nized by the regents of the state of New York, who or which conducts an
9 amateur contest or a white collar boxing contest pursuant to this
10 section must register with the U. S. Amateur Boxing Federation or its
11 local affiliates or the United States White Collar Boxing, Inc. and
12 abide by [~~its~~] the rules and regulations of the appropriate sanctioning
13 body.

14 § 2. This act shall take effect immediately.
