AN ACT to amend the public health law, in relation to adding substances to the schedules of controlled substances

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Subdivision (b) of schedule I of section 3306 of the public health law is amended by adding nine new paragraphs 56, 57, 58, 59, 60, 61, 62, 63 and 64 to read as follows:
- 4 (56) 3,4-dichloro-N-{(1-dimethylamino)cyclohexylmethyl}benzamide. Some trade or other names: AH-7921.
- 6 (57) N-(1-phenethylpiperidin-4-yl)-N-phenlyacetamide (Acetyl Fenta-7 nyl).
- 8 (58) -(1-phenethylpiperidin-4-yl)-N-phenylbutyramide (Butyryl Fenta-9 nyl).
- 10 (59) N-{1-{2-hydroxy-2-(thiophen-2-yl)ethyl}piperidin-4-yl}- N-phenyl-11 propionamide (Beta-Hydroxythiofentanyl).
