AN ACT to amend the environmental conservation law, in relation to hunting in Seneca county; and to amend chapter 73 of the laws of 2015 amending the environmental conservation law relating to authorizing hunting in the county of Seneca, in relation to making such provisions permanent

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the 2 environmental conservation law is amended by adding a new item (1) to 3 read as follows:
