AN ACT to amend the education law, in relation to admission of certain unvaccinated students to public schools

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The education law is amended by adding a new section 3201-b 2 to read as follows:

- § 3201-b. Procedure for religious exemption from vaccination require-4 ment. 1. Legislative intent. The legislature hereby finds and declares 5 that to effectuate the provisions of subdivision nine of section twen-6 ty-one hundred sixty-four of the public health law, a uniform form that shall be used by parents is necessary.
- 2. The definitions of terms in section twenty-one hundred sixty-four 8 of the public health law shall apply to this section. This section shall 9 only apply with respect to admission or receiving of a child into a 10 11 school or attending a school referred to in section one of article eleven of the New York state constitution, including a charter school, 13 pursuant to subdivision nine of section twenty-one hundred sixty-four of 14 the public health law.
- 15 3. Where a child's parent, parents or guardian claim that section 16 twenty-one hundred sixty-four of the public health law shall not apply
