AN ACT to amend the social services law, in relation to mandating training of direct care workers in adverse childhood experiences (ACEs)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The social services law is amended by adding a new section 20-d to read as follows:

§ 20-d. Training of direct care workers in adverse childhood experiences. 1. As used in this section:

(a) "Direct-care employees" means the employees of domestic violence shelters, safe dwellings, and domestic violence programs identified by the certifying organization to receive training, which shall include, but not be limited to, the directors and coordinators of such shelters, dwellings, and programs, and any individual or employee performing or required to perform similar responsibilities.

(b) "Certifying organization" means an organization designated by the federal department of health and human services to coordinate statewide improvements within local communities, social services systems, and programming regarding the prevention and intervention of domestic violence in New York state.

(c) "Adverse childhood experiences" or "ACEs" means stressful or traumatic experiences experienced during childhood, which are strongly related to the development and prevalence of a wide range of health problems throughout a person's lifetime, including, but not limited to physical or sexual abuse; domestic violence; parental mental illness; substance abuse; and incarceration.

1 2. The office of temporary and disability assistance and the office of
2 children and family services shall, within amounts appropriated for such
3 purpose, contract exclusively with an entity, or with entities in part-
4 nership, to develop a training program for direct-care employees to
5 identify individuals who have experienced ACEs, develop effective strat-
6 egies for assisting and interacting with such individuals, and locate
7 programs and services to which such individuals with ACEs may be
8 referred to help build the individual's resilience. Such entity, or
9 entities in partnership, shall be experienced in providing trauma-in-
10 formed, victim-centered training on domestic violence, child abuse, and
11 ACEs. Such entity, or entities in partnership, shall be responsible for
12 providing such training to direct-care employees.

13 3. All direct-care employees shall be required to participate in such
14 training program. Such training shall be provided at no cost to such
15 employees.

16 4. The office of temporary and disability assistance and the office of
17 children and family services shall, within amounts appropriated for such
18 purpose, contract with a certifying organization to provide a certif-
19 ication of completion to each direct-care employee who satisfies the
20 requirements of such training program.

21 § 2. This act shall take effect on the one hundred eightieth day after
22 it shall have become a law. Effective immediately, the addition, amend-
23 ment and/or repeal of any rule or regulation necessary for the implemen-
24 tation of this act on its effective date are authorized to be made and
25 completed by the commissioner of the office of children and family
26 services on or before such date.
