**WHEREAS,** Recently, Angela Connolly-Coyle successfully completed a contract with the United War Veterans Council; throughout her tenure, she was responsible for recruiting and managing 300+ volunteers, mobilizing community support, and engaging with both long-time and potential partners to honor, support, and serve America's veterans; and

**WHEREAS,** Throughout her esteemed career, Angela Connolly-Coyle has worked on many other high-profile assignments such as Project Manager for a Florida-based fund for Iraq and Afghanistan veterans and their families, Program Manager for both the Leary Firefighters Foundation and the FDNY Counseling Service Unit; in 1984, she founded and served as Director of the New York City Child Abuse Prevention Program; and
