**WHEREAS,** Even though Christina Wolfe Snyder is still fighting cancer and has endured 17 surgeries, her will to succeed and thrive has always

remained strong; today, her cleaning company, Wolfe's Cleaning Services, has grown into a prosperous business; and

**WHEREAS,** Well-known throughout her community for her positive attitude and strong work ethic, Christina Wolfe Snyder won a contract to clean the 115 units of The Falls Apartments; one year later, she was hired as the Director of Operations and Events for the apartment complex; and

**WHEREAS,** It is the sense of this Legislative Body that those who enhance the quality of life in their community and have shown a long and sustained commitment to the maintenance of high standards in their profession, certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
