AN ACT to amend the environmental conservation law, in relation to hunting in the county of Broome

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907

§ 4. This act shall take effect immediately, provided that:

a. the amendments to item (i) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such item pursuant to section 2 of chapter 73 of the laws of 2015, as amended, when upon such date section two of this act shall take effect; and

b. the amendments to item (i) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended, when upon such date section three of this act shall take effect.
