AN ACT to amend the environmental conservation law, in relation to hunting in the county of Broome west of the Susquehanna river; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the
2 environmental conservation law is amended by adding a new item (n) to

§ 3. Paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law is amended by adding a new item (1) to read as follows:

<u>(1) The county of</u>	<u>Deer and bear, the</u>	<u>Pistol, shotgun,</u>
<u>Broome west of the</u>	<u>first Saturday after</u>	<u>crossbow, muzzle</u>
<u>Susquehanna river</u>	<u>November 15 through</u>	<u>loading firearm,</u>
<u>except within the</u>	<u>first Sunday after</u>	<u>rifle or long</u>
<u>city of Binghamton</u>	<u>December 7</u>	<u>bow only</u>

§ 4. Item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by chapter 199 of the laws of 2016, is amended to read as follows:

(f) Southern tier,	Deer and bear, first	Pistol, shotgun,
central and Western	Monday after November	crossbow, muzzle
region, except those	15 through first	loading firearm
counties or portions	Tuesday after	or long bow only
thereof listed in	December 7

§ 5. This act shall take effect immediately, provided that:

a. the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;

b. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended; provided further, that the amendments made to such item (f) by section two of this act shall survive the expiration as provided in subdivision c of section 3 of chapter 68 of the laws of 2015;

c. sections three and four of this act shall take effect upon the expiration and reversion of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as provided in section 13 of chapter 600 of the laws of 1993, as amended; and

d. nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2019, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed.
