AN ACT to amend the estates, powers and trusts law and the surrogate's court procedure act, in relation to making technical corrections related to marriage equality

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraphs 6 and 7 of paragraph (a) of section 4-1.1 of 2 the estates, powers and trusts law, as amended by chapter 595 of the 3 laws of 1992, are amended to read as follows:

4 (6) One or more grandparents or the issue of grandparents (as herein-5 after defined), and no spouse, issue, parent or issue of parents, oneб half to the surviving [paternal] grandparent or grandparents of one 7 parental side, or if neither of them survives the decedent, to their issue, by representation, and the other one-half to the surviving 8 [maternal] grandparent or grandparents of the other parental side, or if 9 10 neither of them survives the decedent, to their issue, by represen-11 tation; provided that if the decedent was not survived by a grandparent 12 or grandparents on one side or by the issue of such grandparents, the whole to the surviving grandparent or grandparents on the other side, or 13 if neither of them survives the decedent, to their issue, by represen-14 tation, in the same manner as the one-half. For the purposes of this 15 subparagraph, issue of grandparents shall not include issue more remote 16 17 than grandchildren of such grandparents.

18 (7) Great-grandchildren of grandparents, and no spouse, issue, parent, 19 issue of parents, grandparent, children of grandparents or grandchildren 20 of grandparents, one-half to the great-grandchildren of the [paternal] 21 grandparents <u>of one parental side</u>, per capita, and the other one-half to 22 the great-grandchildren of the [maternal] grandparents <u>of the other</u> 23 <u>parental side</u>, per capita; provided that if the decedent was not

Paragraph (d) of section 6-2.2 of the estates, powers and trusts 5 law, as amended by chapter 480 of the laws of 1995, is amended to read б as follows: 7 (d) A disposition of real property, or a disposition on or after Janu-8 ary first, nineteen hundred ninety-six of the shares of stock of a coop-9 erative apartment corporation allocated to an apartment or unit together 10 with the appurtenant proprietary lease, to persons who are not legally
