- AN ACT to amend the tax law, in relation to authorizing the county of Putnam to exempt from county sales and compensating use taxes certain clothing and footwear, during the period commencing on August fourteenth and through August twenty-third, two thousand eighteen

The People of the State of New York, represented in Senate and Assembly, do enact as follows:
