AN ACT to amend the parks, recreation and historic preservation law, relation to establishing the Nissequogue River state park

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The parks, recreation and historic preservation law is 2 amended by adding a new section 13.32 to read as follows:

§ 13.32 Nissequoque River state park. 1. The commissioner shall designate, pursuant to section 13.03 of this article, those parcels of land specified in subdivision two of this section to be the part of the state park system to be known as the "Nissequogue River state park".

2. The Nissequoque River state park shall constitute those lands dedicated by the commissioner as the Nissequoque River state park in 1999, in addition to approximately 365.68± acres more or less of state lands 10 within the former Kings Park Psychiatric Center, including two parcels aggregating 4.2± acres more or less located adjacent to a cemetery that is located on the western extremity of the 365.68± acre parcel.

East, a distance of 36.02 feet to a point; and 8) Northeasterly along a curve to the right of radius 22 23.50 feet, an arc distance of 19.51 feet to a point on the aforemen-23 tioned Southwesterly margin of St. Johnland Road, the chord for the 24 25 above described curve being North 53 deg. 27 min. 31 sec. East 18.95 26 feet; thence along said Southwesterly margin the following two (2) 27 courses: 1) Southeasterly along a curve to the left of radius 505.67 feet, an arc distance of 88.97 feet to a point, a chord for the above 28 29 described curve being South 60 deg. 27 min. 02 sec. East 88.85 feet and 30 2) Southeasterly along a curve to the left of radius 1699.33 feet, an 31 arc distance of 229.13 feet to the point or place of beginning, the 32 chord for the above described curve being South 69 deg. 21 min. 12 sec. 33 East 228.95 feet containing 2.68± acres of land.
