- AN ACT to amend the parks, recreation and historic preservation law, the vehicle and traffic law, the state finance law and the environmental conservation law, in relation to the creation of an ATV trail fund and the use of ATVs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative intent and purpose. In order to best organize 2 and sustain an environmentally sensitive statewide system of trails for 3 all terrain vehicles, the legislature hereby creates an ATV trail fund. 4 The control and supervision of the trail fund shall be maintained by the office of parks, recreation and historic preservation upon consultation 5 6 with the department of environmental conservation. The trail fund is 7 created for the purpose of designating state, municipal and private lands as part of a statewide network of ATV trails. Fees obtained by the 8 9 office of parks, recreation and historic preservation for the mainte-10 nance of the trail fund shall be divided between administration, 11 enforcement, education and remediation and maintenance, construction and development of the statewide trail system. It is the purpose of this 12 13 act to promote the safe and proper use of all terrain vehicles for 14 recreation and commerce in this state by encouraging their use and 15 development, while minimizing detrimental effects of such use upon the 16 environment.

17 § 2. Title D of the parks, recreation and historic preservation law is 18 amended by adding a new article 26 to read as follows:

5	§ 26.01 Trail plan. The department shall prepare a statewide all-ter-
б	rain vehicle trail plan providing for recreational use of "all terrain
7	vehicles" or "ATVs" on permitted state and municipal lands and ATV
8	designated trails on private lands to establish a statewide network of
9	ATV trails. For purposes of this article, "ATV" means an all terrain
10	vehicle as defined in section twenty-two hundred eighty-one of the vehi-
11	cle and traffic law.
12	§ 26.03 Rules and regulations. 1. The department shall promulgate
13	regulations for the use of ATVs with a view towards achieving maximum
14	use of ATVs and minimizing the detrimental effect thereof upon the envi-
15	ronment. Nothing in this section shall prohibit the department or the
16	department of environmental conservation pursuant to section 9-0303 of
17	the environmental conservation law from authorizing other ATV use on
18	state owned lands. The commissioner shall adopt rules and regulations
19	relating to and including, but not limited to the following:
20	a. Use of ATVs insofar as fish and wildlife resources and natural
21	resources of the state.
22	b. Use of ATVs on public lands under the jurisdiction of the depart-
23	ment, providing for incorporating recreational and sportsman use into
24	UMPs developed for such lands.
25	<u>c. Uniform signs or markers.</u>
26	d. Requirements for protection of private property or therein occa-
27	sioned by the use of ATVs.
28	e. Establishment of a comprehensive ATV information and safety educa-
29	tion and training program, including provision for the issuance of ATV
30	operation and safety certificates for operation of ATVs by youthful
31	operators and adult operators without a valid driver's license.
32	f. Requirements that new connector trails must comply with state laws
33	and regulations and, where applicable for state-owned lands, comply with
34	a unit management plan and be subject to full public review and hear-
35	ings.
36	g. Requirements for municipalities for the designation of ATV use on
37	other public lands must be consistent with environmental impact assess-
38	ments as prescribed by 6 NYCRR Part 617, and paragraph b of subdivision
39	one and paragraph m of subdivision two of section 3-0301 and section
40	8-0113 of the environmental conservation law.
41	h. Provisions for current trails and trails pending approval on or
42	before the effective date of this article are preserved in perpetuity
43	and nothing shall restrict the use of commissioner policy three (CP3)
44	permits issued by the department of environmental conservation on these
45	trails.
46	i. Provisions prohibiting the use of ATVs on state owned lands classi-
47	fied as the following: Albany Pine Bush, Long Island Pine Barrens, or
48	land or water classified as primitive or cance pursuant to the master
49	plan for management of state land.
50	2. Operation by youthful operators shall be as follows:
51	a. Persons between ten and fourteen years old must hold a valid safety
52	certificate and be accompanied by an adult.
53	b. Persons between fifteen and eighteen years old must hold a valid
54	safety certificate or driver's license.

§ 3. Subdivision 1 of section 2282 of the vehicle and traffic law, 1 as 2 amended by chapter 402 of the laws of 1986, is amended to read as follows: 3 4 1. Except as hereinafter provided, no person shall operate any ATV 5 within the state on lands other than those privately owned by the ATV б owner unless such ATV has been registered and numbered in accordance 7 with the provisions of this article, and the registration number for 8 such ATV is in full force and effect and displayed as provided under 9 this article and regulations promulgated thereunder. 10 § 4. Paragraph (g) of subdivision 4 of section 2282 of the vehicle and 11 traffic law, as amended by chapter 402 of the laws of 1986, is amended and a new paragraph (h) is added to read as follows: 12 13 (g) Annual fees shall not be prorated and such fees shall be applica-14 ble to a year or any portion of a year. [Notwithstanding any inconsist-15 ent provision of this section, the difference collected between the fees 16 set forth in paragraphs (a) and (b) of this subdivision in effect on and after September first, two thousand nine and the fees set forth in such 17 paragraphs in effect prior to such date shall be deposited to the credit 18 19 of the dedicated highway and bridge trust fund.] 20 (h) Fees collected pursuant to this section shall be deposited into 21 the ATV trail fund established pursuant to section ninety-nine-bb of the 22 state finance law, and used only for those purposes enumerated in such 23 section. 24 § 5. Subdivision 12 of section 2282 of the vehicle and traffic law, as added by chapter 671 of the laws of 1985, is amended to read as follows: 25 26 12. Out of state ATV registration. (a) The registration provisions of 27 this article shall not apply to non-resident owners who have registered their ATVs in compliance with the registration and licensing laws of the 28 29 state, province, district or country of residence, provided that the ATV 30 is appropriately identified in accordance with the laws of the state of 31 residence. The provisions of this subdivision shall not apply to a resi-32 dent of another state, province, district or country which does not have 33 an ATV registration and identification law. Nothing in this subdivision 34 shall be construed to authorize the operation of any ATV contrary to the 35 provisions of this article. 36 (b) Non-resident owners who have registered their ATVs in compliance 37 with the registration and licensing laws of a jurisdiction out of the 38 state, or who reside in a jurisdiction which does not have an ATV registration and identification law, shall pay an annual fee, equal to that 39 40 provided for pursuant to paragraph (b) of subdivision four of this section to lawfully operate such ATV in the state on lands other than 41 42 those privately owned by the ATV owner. § 6. Section 2404 of the vehicle and traffic law, as added by chapter 43 44 402 of the laws of 1986, paragraph (e) of subdivision 1 and subdivision 45 3 as amended by chapter 554 of the laws of 2005, is amended to read as 46 follows: 47 § 2404. Operating rules. 1. No person shall operate an ATV: 48 (a) at a rate of speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards 49 then existing or faster than fifty-five miles per hour; 50 51 (b) in a careless, reckless or negligent manner so as to unreasonably 52 endanger the person or property of another or cause injury or damage 53 thereto; 54 (c) on the tracks or right-of-way of an operating railroad; 55 (d) in any tree nursery or planting in a manner that damages or 56 destroys growing stock, or creates a substantial risk thereto;

(e) while pulling a person on skis or drawing or towing a sleigh, 1 sled, toboggan, inflatable device or trailer which carries or transports 2 any person unless attached by a rigid support, connection or towbar; 3 4 (f) on the frozen surface of public waters: within one hundred feet of 5 any person other than a person riding on an ATV except at the minimum б speed required to maintain forward movement of the ATV, nor within one 7 hundred feet of a fishing shanty or shelter except at the minimum speed 8 required to maintain forward movement of the ATV nor on an area which 9 has been cleared of snow for skating purposes unless the area is neces-10 sary for access to the public water; 11 (g) within one hundred feet of a dwelling between midnight and six 12 a.m., at a speed greater than minimum required to maintain forward move-13 ment of the ATV; 14 (h) on public lands, other than highways, or on private property of 15 another while in an intoxicated condition or under the influence of 16 narcotics or drugs; 17 (i) on state lands under the jurisdiction of the department of environmental conservation and on conservation easements under such depart-18 19 ment's jurisdiction or on state lands under the jurisdiction of the 20 office of parks, recreation and historic preservation, except as specif-21 ically authorized by the department of environmental conservation pursuant to section 9-0303 of the environmental conservation law and as 22 authorized by the office of parks, recreation and historic preservation 23 pursuant to article twenty-six of the parks, recreation and historic 24 25 preservation law; 26 (j) on private lands unless expressly permitted; or 27 (k) while failing or refusing to comply with law enforcement. 28 2. The operator of an ATV shall: 29 (a) stop and yield to an authorized ambulance, civil defense, or 30 police ATV or police vehicle being operated as an emergency vehicle and 31 approaching from any direction; 32 (b) comply with any lawful order or direction of any police officer or 33 other person duly empowered to enforce the laws relating to ATVs; 34 (c) keep the ATV lights on between sunset and sunrise; 35 (d) wear a helmet; 36 (e) comply with the rules of the road including but not limited to 37 adherence to signage, posted speed limits, traveling on the right edge 38 of the paved/road surface and riding single file. 3. [No person shall ride on or in a sleigh, sled, toboggan, inflatable 39 40 device or trailer which is being towed or trailed by an ATV unless attached by a rigid support, connection or towbar. 41 4. A person operating an ATV shall ride only upon the permanent and 42 regular seat attached thereto, and such operator shall not carry any 43 44 other person nor shall any other person ride on an ATV unless such ATV 45 is designed to carry more than one person, in which event a passenger 46 may ride upon the permanent and regular seat if designed for two 47 persons, or upon another seat firmly attached to the ATV at the rear or 48 side of the operator. 49 5. For the purposes of title seven of this chapter, an ATV shall be a 50 motor vehicle and the provisions of such title shall be applicable to 51 ATVs. 52 [6-] 4. Local laws and ordinances. Nothing contained in this article 53 shall be deemed to limit the authority of a county, city, town or 54 village from adopting or amending a local law or ordinance which imposes 55 stricter restrictions and conditions on the operation of ATVs than are 56 provided or authorized by this section so long as such local law or

5	§ 2411. <u>1.</u> Liability for negligence. Negligence in the use [ef] or
6	operation of an ATV shall be attributable to the owner. Every owner of
7	an ATV used or operated in this state on lands other than those private-
8	ly owned by the ATV owner must be insured. Owners of ATVs used or oper-
9	ated in this state shall be liable and responsible for death or injury
10	to [person] persons or damage to property resulting from negligence in
11	the use or operation of such ATV [by any person using or operating the
	same with the permission, express or implied, of such owner, provided,
12	however, that such operator's negligence shall not be attributed to the
13	
14	owner as to any claim or cause of action accruing to the operator or his
15	legal representative for such injuries or death].
16	2. Duties of ATV owners and operators. It is recognized that driving
17	an ATV is a voluntary activity that may be hazardous. It shall be the
18	duty of ATV owners and operators:
19	(a) To keep their ATVs in proper working order.
20	(b) To follow any and all other rules of conduct as are prescribed
21	pursuant to section 26.03 of the parks, recreation and historic preser-
22	vation law.
23	(c) Not to operate an ATV in any area not designated for driving ATVs.
24	(d) Not to operate an ATV beyond the conditions that limit speed.
25	(e) To familiarize themselves with rules of the trail.
26	(f) Not to leave the scene of any accident resulting in personal inju-
27	ry or damage to the property beyond the trail.
28	§ 8. The state finance law is amended by adding a new section 99-bb to
29	read as follows:
30	§ 99-bb. ATV trail fund. 1. There is hereby established in the joint
31	custody of the commissioner of parks, recreation and historic preserva-
32	tion and the comptroller a fund to be known as the "ATV trail fund".
33	2. The ATV trail fund shall consist of moneys appropriated thereto,
34	and funds transferred from any other fund or source including the
35	payment of fees pursuant to section twenty-two hundred eighty-two of the
36	vehicle and traffic law.
37	3. Ten percent of all moneys in the ATV trail fund shall be available
38	for the administrative costs of administering such fund. Forty-five
39	percent of all moneys in the ATV trail fund shall be made available for
40	the maintenance, construction and development of the statewide trail
41	system. Forty-five percent of all moneys in the ATV trail fund shall be
42	made available for enforcing and educating the public about the
43	provisions of article twenty-six of the parks, recreation and historic
44	preservation law.
45	4. Monies shall be payable from the fund on the audit and warrant of
46	the state comptroller on vouchers approved and certified by the commis-
47	sioner of parks, recreation and historic preservation.
48	§ 9. Paragraph (a) of subdivision 1 of section 2281 of the vehicle and
49	traffic law, as amended by chapter 319 of the laws of 1997, is amended
50	to read as follows:
51	(a) "All terrain vehicle" or "ATV" means any self-propelled vehicle
52	which is manufactured for sale for operation primarily on off-highway
53	trails or off-highway competitions and only incidentally operated on
54	public highways providing that such vehicle does not exceed seventy
55	inches in width, or one thousand <u>five hundred</u> pounds dry weight.
56	Provided, however, this definition shall not include a "snowmobile" or

     § 2414. Trespass violation fine. Operators of ATVs which have been

   cited for trespass shall be fined one hundred dollars for a first

   violation; two hundred dollars for a second violation within three
   hundred sixty-five days of the initial violation; and five hundred
10

   dollars for subsequent violations within three hundred sixty-five days
   of the initial violation. The money collected from the fines shall be
12

   put into the ATV trail fund established by section ninety-nine-bb of the
14
   state finance law and shall be split fifty percent for enforcement,

   education and remediation and the other fifty percent for trail mainte-
16
   nance and trail construction and development.

      § 11. Section 1-0303 of the environmental conservation law is amended
   by adding four new subdivisions 26, 27, 28, and 29 to read as follows:

Persons with qualifying disabilities to whom the department has 23 24 issued a permit and a companion may use ATVs at the locations authorized 25 by such permit and pursuant to the terms and conditions of such permit. 26 Such authorization shall comply with the requirements of section twen-27 ty-four hundred five of the vehicle and traffic law and other applicable 28 law. 29 g. ATVs may be used on state land under the department's jurisdiction 30 for appropriate administrative, law enforcement, and emergency purposes. 31 h. The provisions of this subdivision shall only apply to lands within 32 the boundaries of the Adirondack park and the Catskill park or under the 33 jurisdiction of the department on or before January first, two thousand 34 nineteen.

35 § 13. This act shall take effect immediately.
