Introduced by Sens. GIANARIS, HOYLMAN, KRUEGER, PARKER, SANDERS, SQUADRON -- read twice and ordered printed, and when printed to be committed to the Committee on Finance -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the executive law and the general municipal law, in relation to prohibiting the provision of assistance in the enforcement of a certain United States Executive Order relating to protecting the nation from foreign terrorist entry, within the state

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Notwithstanding any provision of law to the contrary, no  
2 employee or officer of the port authority of New York and New Jersey  
3 shall provide any aid, resources, assistance, or support to any federal  
4 employee or representative in enforcing the provisions of a United  
5 States Executive Order issued on January 27, 2017 regarding Protecting  
6 the Nation from Foreign Terrorist Entry into the United States, nor may  
7 any resources or facilities of the port authority of New York and New  
8 Jersey be used for such purpose.

9 § 2. The provisions of this act shall only apply to any employees or  
10 officers of the port authority of New York and New Jersey working within  
11 the boundaries of the state of New York and shall only apply on proper-  
12 ties wholly within the boundaries of the state of New York.

13 § 3. The executive law is amended by adding a new section 233 to read  
14 as follows:

15 § 233. Port authority immigration participation. Notwithstanding any  
16 provision of law to the contrary, no member of the division of state  
17 police shall provide any aid, resources, assistance or support to any  
18 federal employee or representative enforcing the provisions of a United  
19 States Executive Order issued on January twenty-seventh, two thousand  
20 seventeen regarding Protecting the Nation from Foreign Terrorist Entry  
21 into the United States.

1     § 4. The general municipal law is amended by adding a new section  
2 205-h to read as follows:

3     § 205-h. Port authority immigration participation. Notwithstanding  
4 any provision of law to the contrary, no police officers employed by a  
5 city with a population of one million or more shall provide any aid,  
6 resources, assistance or support to any federal employee or represen-  
7 tative in enforcing the provision of a United States Executive Order  
8 issued on January twenty-seventh, two thousand seventeen regarding  
9 Protecting the Nation from Foreign Terrorist Entry into the United  
10 States.

11     § 5. This act shall take effect immediately and shall apply only in  
12 the state of New York in a matter consistent with chapter 154 of the  
13 laws of 1921.
