AN ACT to amend the tax law, in relation to creating a wage tax credit for employers who employ New York national guard men and women, reservists, volunteer firefighters and EMS personnel

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 210-B of the tax law is amended by adding two new 2 subdivisions 53 and 54 to read as follows:

53. Employment of New York national quard and reserve members wage tax 4 credit. (a) Allowance of credit. A taxpayer shall be allowed a credit, 5 in the amount of one thousand five hundred dollars, against the tax imposed by this article for each member of the New York national quard and reserves which it employs. Provided, however, such taxpayer shall comply with the Uniformed Services Employment and Reemployment Rights Act, as found in section 4301 et seq. of title 18 of the United States Code; and provided further that such person shall have been employed for at least six months.

12 (b) Application of credit. The credit allowed under this subdivision for any taxable year shall not reduce the tax due for such year to less 13 14 than the minimum amount prescribed in paragraph (d) of subdivision one 15 of section two hundred ten of this article. If, however, the amount of 16 credits allowed under this subdivision for any taxable year reduces the

1 tax to such amount, any amount of credit thus not deductible in such taxable year shall be treated as an overpayment of tax to be credited or refunded in accordance with the provisions of section one thousand 3 eighty-six of this chapter. Provided, however, the provisions of subsection (c) of section one thousand eighty-eight of this chapter notwithstanding, no interest shall be paid thereon.

- 54. Employment of volunteer firefighters and emergency medical 7 8 services (EMS) first responder personnel wage credit. (a) Allowance of 9 credit. A taxpayer shall be allowed a credit of one thousand five hundred dollars, against the tax imposed by this article, for each 10 11 volunteer firefighter and EMS first responder personnel which it employs; provided that such person shall have been employed for at least 12 13 six months.
- 14 (b) Application of credit. The credit allowed under this subdivision 15 for any taxable year shall not reduce the tax due for such year to less 16 than the minimum amount prescribed in paragraph (d) of subdivision one 17 of section two hundred ten of this article. If, however, the amount of credits allowed under this subdivision for any taxable year reduces the 18 tax to such amount, any amount of credit thus not deductible in such 19 20 taxable year shall be treated as an overpayment of tax to be credited or 21 refunded in accordance with the provisions of section one thousand 22 eighty-six of this chapter. Provided, however, the provisions of subsection (c) of section one thousand eighty-eight of this chapter 23 notwithstanding, no interest shall be paid thereon. 24

3. Section 606 of the tax law is amended by adding two new 40 subsections (ccc) and (iii) to read as follows: 41

42 (ccc) Employment of New York national guard and reserve member credit. 43 (1) Allowance of credit. A taxpayer shall be allowed a credit, as here-44 inafter provided, against the tax imposed by this article if they employ New York national quard and reserve members. Provided, however, they 45 shall comply with the Uniformed Services Employment and Reemployment 46 Rights Act, as found in section 4301 et seq. of title 18 of the United 47 States Code; and provided, further that such person shall have been 48 49 employed for at least six months. The amount of the credit shall be fifteen hundred dollars for each national quard member or reservist 50 51 employed.

52 (2) Application of credit. If the amount of the credit allowed under this subsection for any taxable year shall exceed the taxpayer's tax for

such year, the excess shall be treated as an overpayment of tax to be credited or refunded in accordance with the provisions of section six hundred eighty-six of this article, provided, however, that no interest 3 4 shall be paid thereon.

- (3) Carryover. If the amount of credit allowable under this subsection for any taxable year shall exceed the taxpayer's tax for such year, the excess may be carried over to the following year or years, and may be deducted from the taxpayer's tax for such year or years.
- 9 (iii) Employment of volunteer firefighters and EMS first responder personnel wage credit. (1) Allowance of credit. A taxpayer shall be 10 11 allowed a credit, as hereinafter provided, against the tax imposed by this article for each volunteer firefighter and EMS first responder 12 personnel which it employs; provided that such person shall have been 13 14 employed for at least six months. The amount of the credit shall be fifteen hundred dollars for each volunteer firefighter and EMS first 15 16 responder employed.
- (2) Application of credit. If the amount of the credit allowed under this subsection for any taxable year shall exceed the taxpayer's tax for 18 19 such year, the excess shall be treated as an overpayment of tax to be 20 credited or refunded in accordance with the provisions of section six 21 hundred eighty-six of this article, provided, however, that no interest 22 shall be paid thereon.
- (3) Carryover. If the amount of credit allowable under this subsection 23 for any taxable year shall exceed the taxpayer's tax for such year, the 24 25 excess may be carried over to the following year or years, and may be 26 deducted from the taxpayer's tax for such year or years.
- 27 § 4. This act shall take effect immediately and shall apply to taxable 28 years beginning on and after January 1, 2020.
