AN ACT to amend the environmental conservation law, in relation to hunting in Genesee county; and to amend chapter 68 of the laws of 2015, amending the environmental conservation law, relating to authorizing hunting in the county of Genesee, in relation to making such provisions permanent

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the
2 environmental conservation law is amended by adding a new item (1) to
3 read as follows:

4 <u>(1) The county of</u>	<u>Deer and bear, the</u>	<u>Pistol, shotgun,</u>
5 <u>Genesee</u>	<u>first Saturday after</u>	<u>crossbow, muzzle</u>

9 § 2. Section 3 of chapter 68 of the laws of 2015, amending the envi-
10 ronmental conservation law, relating to authorizing hunting in the coun-
11 ty of Genesee, is amended to read as follows:

12 § 3. This act shall take effect immediately, provided that:

13 a. the amendments to paragraph a of subdivision 2 of section 11-0907
14 of the environmental conservation law made by section one of this act
15 shall be subject to the expiration and reversion of such paragraph
16 pursuant to section 13 of chapter 600 of the laws of 1993, as amended;

b. the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended, and shall not affect the expiration of such item, pursuant to section 3 of chapter 142 of the laws of 2014, as amended[; and

~~c. nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2017, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed].~~

§ 3. Item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by chapter 199 of the laws of 2016, is amended to read as follows:

§ 4. This act shall take effect immediately; provided, however, that the amendments to section 11-0907 of the environmental conservation law, made by sections one and three of this act shall take effect upon the expiration and reversion of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as provided in section 13 of chapter 600 of the laws of 1993, as amended.
