AN ACT to amend the tax law, in relation to increasing the maximum award available under the historic preservation tax credit

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraph (A) of paragraph 1 of subsection (oo) of
2 section 606 of the tax law, as amended by section 1 of part F of chapter
3 59 of the laws of 2013, is amended to read as follows:
4 (A) For taxable years beginning on or after January first, two thou-
5 sand ten and before January first, two thousand [~~twenty~~] twenty-two, a
6 taxpayer shall be allowed a credit as hereinafter provided, against the
7 tax imposed by this article, in an amount equal to one hundred percent
8 of the amount of credit allowed the taxpayer with respect to a certified
9 historic structure under subsection (a) (2) of section 47 of the federal
10 internal revenue code with respect to a certified historic structure
11 located within the state. Provided, however, the credit shall not exceed
12 [~~five~~] seven million dollars in state fiscal year two thousand nine-
13 teen--two thousand twenty and nine million dollars in state fiscal year
14 two thousand twenty--two thousand twenty-one. For taxable years begin-
15 ning on or after January first, two thousand [~~twenty~~] twenty-two, a
16 taxpayer shall be allowed a credit as hereinafter provided, against the
17 tax imposed by this article, in an amount equal to thirty percent of the
18 amount of credit allowed the taxpayer with respect to a certified
19 historic structure under subsection (a)(2) of section 47 of the federal

4 § 2. Subparagraph (i) of paragraph a of subdivision 26 of section
5 210-B of the tax law, as added by section 17 of part A of chapter 59 of
6 the laws of 2014, is amended to read as follows:

7 (i) For taxable years beginning on or after January first, two thou-
8 sand ten and before January first, two thousand [~~twenty~~] twenty-two, a
9 taxpayer shall be allowed a credit as hereinafter provided, against the
10 tax imposed by this article, in an amount equal to one hundred percent
11 of the amount of credit allowed the taxpayer with respect to a certified
12 historic structure under subsection (c) (2) of section 47 of the federal
13 internal revenue code with respect to a certified historic structure
14 located within the state. Provided, however, the credit shall not exceed
15 [~~five~~] seven million dollars in state fiscal year two thousand nine-
16 teen--two thousand twenty and nine million dollars in state fiscal year
17 two thousand twenty--two thousand twenty-one.

18 § 3. Subparagraph (A) of paragraph 1 of subdivision (y) of section
19 1511 of the tax law, as amended by section 4 of part F of chapter 59 of
20 the laws of 2013, is amended to read as follows:

21 (A) For taxable years beginning on or after January first, two thou-
22 sand ten and before January first, two thousand [~~twenty~~] twenty-two, a
23 taxpayer shall be allowed a credit as hereinafter provided, against the
24 tax imposed by this article, in an amount equal to one hundred percent
25 of the amount of credit allowed the taxpayer with respect to a certified
26 historic structure under subsection (a)(2) of section 47 of the federal
27 internal revenue code with respect to a certified historic structure
28 located within the state. Provided, however, the credit shall not exceed
29 [~~five~~] seven million dollars in state fiscal year two thousand nine-
30 teen--two thousand twenty and nine million dollars in state fiscal year
31 two thousand twenty--two thousand twenty-one. For taxable years begin-
32 ning on or after January first, two thousand [~~twenty~~] twenty-two, a
33 taxpayer shall be allowed a credit as hereinafter provided, against the
34 tax imposed by this article, in an amount equal to thirty percent of the
35 amount of credit allowed the taxpayer with respect to a certified
36 historic structure under subsection (a)(2) of section 47 of the federal
37 internal revenue code with respect to a certified historic structure
38 located within the state. Provided, however, the credit shall not exceed
39 one hundred thousand dollars.

40 § 4. This act shall take effect immediately and shall apply to taxable
41 years beginning on and after January 1, 2018.
