AN ACT to amend the county law, in relation to the payment of salaries for certain district attorneys; and making an appropriation therefor

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Paragraph (c) of subdivision 11 of section 700 of the county law, as amended by section 1 of part E of chapter 412 of the laws of 1999, is amended to read as follows:
- (c) Commencing with the nineteen hundred eighty-seven calendar year, 5 the comptroller shall annually determine the amount of state aid payable to each county pursuant to paragraphs (a) [and ], (b) and (d) hereof for each calendar year and shall pay such amount on his audit and warrant to the chief fiscal officer of each such county during the month of September in each such year. Where a county first becomes entitled to state aid pursuant to paragraphs (a) [and (b) and (d) hereof on a day other 10 than January first, nineteen hundred ninety-nine or January first of any 11 other year thereafter, the amount of state aid payable to such county in 12 13 the year it first becomes entitled to such state aid shall be prorated 14 accordingly.
- 15 § 2. Subdivision 11 of section 700 of the county law is amended by 16 adding a new paragraph (d) to read as follows:

1 which is determined pursuant to section one hundred eighty-three-a of the judiciary law, shall be entitled to receive state aid in the amount 3 of one hundred percent of the difference between the amount required to 4 be paid to such district attorney pursuant to section one hundred eight-5 y-three-a of the judiciary law on and after April first, two thousand eighteen and the amount required to be paid pursuant to such section immediately prior to such date.

- § 3. The sum of one million six hundred thousand dollars (\$1,600,000), or so much thereof as may be necessary, is hereby appropriated to the department of audit and control out of any moneys in the state treasury in the general fund to the credit of the local assistance account, not 12 otherwise appropriated, and made immediately available, for the purpose of carrying out the provisions of this act. Such moneys shall be payable 13 14 on the audit and warrant of the comptroller to the chief fiscal officer 15 of each such county as prescribed by law.
- 16 § 4. This act shall take effect immediately.
