AN ACT to amend the vehicle and traffic law, in relation to establishing distinctive "Women Veterans" license plates; and to amend the state finance law, in relation to establishing the "women veterans support fund"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-y to read as follows:
- § 404-y. Distinctive "Women Veterans" license plates. 1. Any person residing in this state shall, upon request, be issued a distinctive "Women Veterans" license plate of a design approved by the commissioner. Application for said license plate shall be filed with the form and detail as the commissioner shall prescribe.
- 8 2. A distinctive plate issued pursuant to this section shall be issued in the same manner as other number plates upon the payment of the requ-9 lar registration fee prescribed by section four hundred one of this 10 11 article, provided, however, that an additional annual service charge of 12 twenty-five dollars shall be charged for such plate. Such additional 13 service charge shall be deposited pursuant to section four hundred four-14 oo of this article to the credit of the department of motor vehicles distinctive plate development fund, established by section ninety-five-g 15 of the state finance law, and shall be used for the production, design, 16 advertising and marketing of distinctive number plates; provided, howev-17 18 er, that additional annual service charges collected in excess of six 19 thousand dollars shall be deposited to the credit of the women veterans 20 support fund established pursuant to section ninety-five-i of the state 21 finance law.
- § 2. The state finance law is amended by adding a new section 95-i to 23 read as follows:

§ 95-i. Women veterans support fund. 1. There is hereby established in the joint custody of the commissioner of taxation and finance and the comptroller, a special fund to be known as the "women veterans support fund".

- 2. Such fund shall consist of all moneys collected pursuant to section four hundred four-y of the vehicle and traffic law, and all other moneys appropriated, credited or transferred thereto from any other fund or source pursuant to law.
- 3. Moneys of the fund shall be expended by the New York state division of veterans' affairs' women veterans' services. These funds shall be used for women veterans homelessness, counseling and other programs that support women veterans.
- § 3. 1. A distinctive plate established pursuant to section 404-y of the vehicle and traffic law, as added by section one of this act, shall only be designed, produced and issued upon the delivery to the department of motor vehicles of a surety bond in the amount of six thousand dollars, which shall be executed by a surety company authorized by the department of financial services to transact business in this state. Provided, however, that if the commissioner of motor vehicles shall have received prior to the plate design, production and issuance at least two 21 hundred orders for such distinctive plate together with the additional 22 annual service charge applicable to each such order, which shall be 23 non-refundable, no such surety bond shall be required. All such service 24 charges shall be deposited pursuant to the provisions of section 404-oo of the vehicle and traffic law to the credit of the department of motor vehicles distinctive plate development fund established by section 95-g of the state finance law and shall be used for the design, production, advertising and distribution of distinctive license plates in accordance with such section 95-g.
- 2. If, upon the expiration of two years following the date upon which distinctive plates in the series are first available for sale, two hundred or more sets of such plates are sold, a bond delivered pursuant to this section shall be discontinued. If fewer than two hundred sets of such plates are sold by such time, the department of motor vehicles 34 shall be entitled to recover against the bond an amount proportionate to such shortfall.
- § 4. This act shall take effect on the one hundred eightieth day after 38 it shall have become a law; provided, however, that section three of this act shall take effect immediately; provided further, however, that 39 effective immediately, the addition, amendment and/or repeal of any rule 40 or regulation necessary for the implementation of this act on its effec-41 tive date are authorized and directed to be made and completed on or 43 before such effective date.
