- AN ACT to amend the vehicle and traffic law, in relation to eliminating additional fees for special license plates issued to veterans

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 1-a of section 404 of the vehicle and traffic 2 law, as amended by chapter 105 of the laws of 2017, is amended to read 3 as follows:

1-a. The commissioner may issue special number plates to applicants 4 5 who are members of veterans organizations in the same manner as other б number plates are issued pursuant to this article. Such special number plates shall be issued [only] upon [(a)] payment of [a one-time service 7 8 charge of ten dollars in addition to ] the regular registration fee 9 prescribed by section four hundred one of this article, and  $[\frac{b}{b}]$ 10 submission of proof, satisfactory to the commissioner, that the applicant is presently a member of the veterans organization for which such 11 plate is requested. Such membership shall be verified annually by the 12 applicant. Application for such plates shall be made in accordance with 13 14 regulations promulgated by the commissioner with respect to the issuance 15 of such plates. Provided, however, that nothing contained herein shall 16 be deemed to supersede the provisions of section four hundred four-d, four hundred four-e, four hundred four-h, four hundred four-i, four 17 18 hundred four-j, four hundred four-k, four hundred four-p, four hundred 19 four-aa, or four hundred four-dd of this article.
