AN ACT to amend the penal law, in relation to sexual assault against a child by a person in a position of trust

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraphs (b) and (d) of subdivision 1 of section 70.02 of the penal law, paragraph (b) as amended by chapter 1 of the laws of 2013 and paragraph (d) as amended by chapter 7 of the laws of 2007, are amended to read as follows:

section 490.30, and criminal possession of a chemical weapon or biological weapon in the third degree as defined in section 490.37.

- 3 (d) Class E violent felony offenses: an attempt to commit any of the felonies of criminal possession of a weapon in the third degree as defined in subdivision five, six, seven or eight of section 265.02 as a lesser included offense of that section as defined in section 220.20 of 7 the criminal procedure law, persistent sexual abuse as defined in 8 section 130.53, aggravated sexual abuse in the fourth degree as defined 9 in section 130.65-a, sexual assault against a child by a person in a 10 position of trust in the second degree as defined in section 130.98, falsely reporting an incident in the second degree as defined in section 11 240.55 and placing a false bomb or hazardous substance in the second 12 13 degree as defined in section 240.61.
- 14 § 2. Section 130.00 of the penal law is amended by adding a new subdi-15 vision 14 to read as follows:
  - 14. "Person in a position of trust" means any person who is charged with any duty or responsibility for the health, education, welfare or supervision of a child, either independently or through another person, no matter how brief.
  - § 3. The penal law is amended by adding three new sections 130.97, 130.98 and 130.99 to read as follows:
- § 130.97 Sexual assault against a child by a person in a position of 22 trust in the first degree.
  - A person is guilty of sexual assault against a child by a person in a position of trust in the first degree when he or she subjects a child less than eleven years old to sexual contact and when such person is a person in a position of trust with respect to such child.
  - Sexual assault against a child by a person in a position of trust in the first degree is a class C felony.
  - § 130.98 Sexual assault against a child by a person in a position of trust in the second degree.
  - A person is guilty of sexual assault against a child by a person in a position of trust in the second degree when he or she subjects a child less than fourteen years old to sexual contact and when such person is a person in a position of trust with respect to such child.
  - Sexual assault against a child by a person in a position of trust in the second degree is a class E felony.
  - § 130.99 Sexual assault against a child by a person in a position of trust in the third degree.
  - A person is guilty of sexual assault against a child by a person in a position of trust in the third degree when he or she subjects a child less than eighteen years old to sexual contact and when such person is a person in a position of trust with respect to such child.
- 44 Sexual assault against a child by a person in a position of trust in 45 the third degree is a class A misdemeanor.
- 46 § 4. This act shall take effect on the first of November next succeed-47 ing the date on which it shall have become a law.
