AN ACT to amend the education law, in relation to admission of certain unvaccinated students to public schools

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The education law is amended by adding a new section 3201-b to read as follows:

§ 3201-b. Procedure for religious exemption from vaccination requirement. 1. The definitions of terms in section twenty-one hundred sixtyfour of the public health law shall apply to this section. This section 6 shall apply notwithstanding any general, special, local law or rule or regulation to the contrary. This section shall only apply with respect to admission or receiving of a child into a school, or attending a school, referred to in section one of article eleven of the New York 10 state constitution, including a charter school.

2. Where a child's parent, parents or quardian claim that section twenty-one hundred sixty-four of the public health law shall not apply 12 to the child because the parent, parents, or guardian hold genuine and sincere religious beliefs which are contrary to the practices required in such section, the child shall be deemed to have complied with that 16 section and no certificate under that section shall be required as a 17 prerequisite to such child being admitted or received into school or attending school, provided that the parent, parents or quardian file 18 with the school a religious beliefs exemption form under subdivision 20 three of this section.
