AN ACT authorizing the city of Schenectady to alienate certain parcels of land used as parkland and to acquire other parcels of land to replace such parkland

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the city of Schenec-2 tady, acting by and through its governing body, is hereby authorized to discontinue as parklands and alienate the lands more particularly described in section three of this act, and to sell and convey such parklands upon such other terms and conditions as determined by the governing body of the city of Schenectady to the Boys & Girls Club for the purpose of constructing a new Boys & Girls Club facility at Quacken-8 bush Park.

- § 2. The authorization contained in section one of this act shall take 10 effect only upon the condition that the city of Schenectady shall acquire and dedicate the lands of equal or greater fair market value described in section four of this act as additional parklands of the city.
- § 3. The lands authorized by section one of this act to be discontin-14 15 ued as parklands and conveyed to the Boys & Girls Club consists of 1.35 acres and are described as follows: 16
- 17 All that certain tract, piece, or parcel of land situate, lying and 18 being in the City of Schenectady, County of Schenectady and State of New York and being more particularly bounded and described as follows: 19
- Beginning at a point on the division line of lands herein described as 20 21 Lot 1 on the south and lands now or formerly of Schenectady City School

§ 5. In the event that the parklands to be dedicated by the city of Schenectady pursuant to this act are not equal to or greater than the fair market value of the parkland to be discontinued and conveyed, city of Schenectady shall dedicate the difference of the fair market value of the lands to be alienated and the lands to be dedicated for the acquisition of additional parklands and/or for capital improvements to existing park and recreational facilities.

6. In the event that the city of Schenectady received any funding 54 support or assistance from the federal government for the purchase, maintenance or improvement of the parklands set forth in section three of this act, the discontinuance and alienation of such parkland authorS. 6401--A 4

1 ized by the provisions of this act shall not occur until the city of 2 Schenectady has complied with any federal requirements pertaining to the 3 alienation or conversion of such parklands, including satisfying the 4 secretary of the interior that the alienation or conversion complies 5 with all conditions which the secretary of the interior deems necessary 6 to assure the substitution of other lands shall be equivalent in fair 7 market value and usefulness to the lands being alienated or converted. § 7. This act shall take effect immediately.
