AN ACT to amend the financial services law, in relation to a public education program about the rights of consumers

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

13	toring services; (c) credit reporting; (d) the contents of and access to
14	credit scores; (e) the definition of private information as defined in
15	section eight hundred ninety-nine-aa of the general business law; (f)
16	notification requirements under section eight hundred ninety-nine-aa of
17	the general business law; (g) mitigating the effects of a breach of
18	private information; and (h) the rights of consumers over their personal
19	information as it is related to third parties.
20	2. The superintendent shall submit on or before December first next
21	succeeding the effective date of this section and annually thereafter, a
