- AN ACT to amend the economic development law, in relation to the composition of an advisory panel on employee-owned enterprises within the division of small business services; and to amend a chapter of the laws of 2017, amending the economic development law, relating to establishing an advisory panel on employee-owned enterprises within the division of small business services, as proposed in legislative bills numbers S. 5349-A and A. 8179, in relation to the expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (a) of subdivision 3 and subdivision 5 of 2 section 139 of the economic development law, as added by a chapter of 3 the laws of 2017, amending the economic development law, relating to 4 establishing an advisory panel on employee-owned enterprises within the 5 division of small business services, as proposed in legislative bills 6 numbers S. 5349-A and A. 8179, are amended to read as follows:

7 (a) The advisory panel shall consist of [twelve] thirteen members, 8 including:

9 (i) the commissioner, or his or her designee, who shall be designated 10 as chair of the advisory panel;

11 (ii) the commissioner of labor, or his or her designee;

12 (iii) the commissioner of tax and finance, or his or her designee; and 13 (iv) [nine] ten members to be appointed as follows: [three] four shall be appointed by the governor, two shall be appointed by the speaker of 14 the assembly, two shall be appointed by the temporary president of the 15 senate, one shall be appointed by the minority leader of the assembly, 16 17 and one shall be appointed by the minority leader of the senate. Such 18 appointed members shall represent entities and organizations with expertise related to employee-owned enterprises or business development, 19 20 particularly those with an emphasis on small businesses, minority and 21 women-owned businesses, and veteran-owned businesses, including, but not 22 limited to:

Section 2 of a chapter of the laws of 2017, amending the economic 23 development law, relating to establishing an advisory panel on employ-24 ee-owned enterprises within the division of small business services, as proposed in legislative bills numbers S. 5349-A and A. 8179, is amended 25 26 to read as follows: 27 § 2. This act shall take effect immediately and shall expire October 28 1, [2018] 2019 when upon such date the provisions of this act shall be 29 deemed repealed. 30 3. This act shall take effect immediately, provided however that § 31 section one of this act shall take effect on the same date and in the 32 same manner as a chapter of the laws of 2017, amending the economic 33 development law, relating to establishing an advisory panel on employ-34 ee-owned enterprises within the division of small business services, as 35 proposed in legislative bills numbers S. 5349-A and A. 8179, takes 36 effect.
