AN ACT to amend the vehicle and traffic law and the transportation law, in relation to enhancing the ability of the state to enforce state and federal law relating to motor carriers, commercial drivers and bus operators and to increase penalties for violations of state law relating thereto (Part A); to amend the highway law, in relation to roadside rest areas (Part B); to amend the transportation law, in relation to enhancing the ability of the state to enforce state and federal law relating to the safety of rail fixed guideway public transportation systems under the oversight of the public transportation safety board (Part C); to amend the public authorities law, in relation to agreements for fiber optics (Part D); to amend the transportation law, in relation to authorizing the department of transportation to charge one hundred twenty dollars for a semi-annual inspection of certain for-profit fleets (Part E); to amend the highway law and the transportation corporations law, in relation to occupancy of the state right of way for a fee; and to amend the general municipal law, in relation to small wireless facilities development (Part F); to amend the vehicle and traffic law, in relation to seat belt requirements, proper safety restraints for children under the age of 8, prohibiting the use of mobile telephones and portable electronic devices by persons under the age of 18, and permitting junior license holders to operate a vehicle in New York City; and to amend the vehicle and traffic law and the public officers law, in relation to authorizing political subdivisions and commuter railroads to establish demonstration programs and to implement railroad grade crossing monitoring systems by means of photo devices (Part G); to amend part FF of chapter 55 of the laws of 2017 relating to motor vehicles equipped with autonomous vehicle technology, in relation to demonstrations and tests; in relation to the submission or reports; and in relation to extending the effectiveness thereof; relates to demonstrations and testing of motor vehicles

law, the cooperative corporations law, the executive law, the general associations law, the general business law, the limited liability company law, the not-for-profit corporation law, the partnership law, the private housing finance law, the arts and cultural affairs law, the real property law and the tax law, in relation to streamlining the process by which service of process is served against a corporate or other entity with the secretary of state; and to repeal certain provisions of the real property law relating thereto (Part T); to amend the general municipal law, in relation to brownfield opportunity areas (Part U); to repeal section 159-j of the executive law, relating to the local share requirement for providers under the federal community services block grant program (Part V); to amend the banking law, in relation to student loan servicers (Subpart A); to amend the financial services law, in relation to student debt collectors (Subpart B); and to amend the education law, in relation to student loan debtors (Subpart C)(Part W); to amend chapter 584 of the laws of 2011, amending the public authorities law relating to the powers and duties of the dormitory authority of the state of New York relative to the establishment of subsidiaries for certain purposes, in relation to the effectiveness thereof (Part X); to amend part S of chapter 58 of the laws of 2016, amending the New York state urban development corporation act relating to transferring the statutory authority for the promulgation of marketing orders from the department of agriculture and markets to the New York state urban development corporation, in relation to the effectiveness thereof (Part Y); to amend the real property tax law, in relation to the taxation of forest land; to amend the environmental conservation law, in relation to timber harvest notification and the creation of forest protection and management programs; and to amend the state finance law, in relation to the procurement of wood and wood fiber projects (Part Z); to amend the state finance law and the environmental conservation law, in relation to the environmental protection fund, the hazardous waste remedial fund and the mitigation and remediation of solid waste sites; and to repeal certain provisions of the state finance law and the environmental conservation law relating thereto (Part AA); to amend the environmental conservation law, in relation to the donation of excess food and recycling of food scraps (Part BB); to amend the environmental conservation law, in relation to the Central Pine Barrens area and core preservation area (Part CC); authorizing utility and cable television assessments to provide funds to the department of health from cable television assessment revenues and to the departments of agriculture and markets, environmental conservation, office of parks, recreation and historic preservation, and state from utility assessment revenues (Part DD); authorizing the New York state energy research and development authority to finance a portion of its research, development and demonstration, policy and planning, and Fuel NY programs, as well as the department of environmental conservation's climate change program and the department of agriculture and markets' Fuel NY program, from an assessment on gas and electric corporations (Part EE); to amend the public authorities law, in relation to energy-related projects, programs and services of the power authority of the state of New York (Part FF); and to amend the public authorities law, in relation to the provision of renewable power and energy by the power authority of the state of New York (Part GG)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. This act enacts into law major components of legislation which are necessary to implement the state fiscal plan for the 2018-2019 state fiscal year. Each component is wholly contained within a Part identified as Parts A through GG. The effective date for each particular provision contained within such Part is set forth in the last section of such Part. Any provision in any section contained within a Part, including the effective date of the Part, which makes a reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Part in which it is found. Section three of this act sets forth the general effective date of this act.

PART A

Section 1. Subparagraph (iii) of paragraph (b) of subdivision 2 of section 510 of the vehicle and traffic law, as amended by chapter 349 of 1993, is amended to read as follows:

(iii) such registrations shall be suspended when necessary to comply with subdivision nine of section one hundred forty or subdivision four of section one hundred forty-five of the transportation law or with an out of service order issued by the United States department of transportation. The commissioner shall have the authority to deny a registration or renewal application to any other person for the same vehicle and may deny a registration or renewal application for any other motor vehicle registered in the name of the applicant where it has been determined that such registrant's intent has been to evade the purposes of this subdivision and where the commissioner has reasonable grounds to believe that such registration or renewal will have the effect of defeating the purposes of this subdivision. Any suspension issued pursuant to this subdivision by reason of an out of service order issued by the United States department of transportation shall remain in effect until such time as the commissioner is notified by the United States department of transportation or the commissioner of transportation that the order resulting in the suspension is no longer in effect.

§ 2. Subdivision 3 of section 145 of the transportation law, as added by chapter 635 of the laws of 1983, is amended to read as follows:

3. In addition to, or in lieu of, any sanctions set forth in this section, the commissioner may, after a hearing, impose a penalty not to exceed a maximum of five thousand dollars in any one proceeding upon any person if the commissioner finds that such person or officer, agent or employee thereof has failed to comply with the requirements of this chapter or any rule, regulation or order of the commissioner promulgated thereunder. Provided, however, that the commissioner may, after a hearing, impose a penalty not to exceed ten thousand dollars in a second proceeding for another violation committed within eighteen months and a penalty not to exceed twenty-five thousand dollars in a third proceeding for additional violations committed within eighteen months. If such penalty is not paid within four months, the amount thereof may be entered as a judgment in the office of the clerk of the county of Albany and in any other county in which the person resides, has a place of business or through which it operates. Thereafter, if said judgment has not been satisfied within ninety days, any certificate or permit held by any such person may be revoked upon notice but without a further hear-

ing. Provided, however, that if a person shall apply for a rehearing of the determination of the penalty pursuant to the provisions of section eighty-nine of this chapter, judgment shall not be entered until a determination has been made on the application for a rehearing. Further provided however, that if after a rehearing a penalty is imposed and such penalty is not paid within four months of the date of service of the rehearing decision, the amount of such penalty may be entered as a judgment in the office of the clerk of the county of Albany and in any other county in which the person resides, has a place of business or through which it operates. Thereafter, if said judgment has not been satisfied within ninety days, any certificate or permit held by any such person may be revoked upon notice but without a further hearing.

§ 3. This act shall take effect immediately.

PART B

Section 1. Subdivision 3 of section 20 of the highway law, as amended by chapter 736 of the laws of 1984, is amended to read as follows:

3. The commissioner may in his discretion develop such sites by providing any or all of the following: a water supply, sanitary facilities, parking space for automobiles or such other commercial or non-commercial facilities as are suitable for rest and relaxation stops by highway travelers. The commissioner may also permit the installation of vending machines dispensing such food, drink and other articles as he deems appropriate or desirable. Such sites shall be suitably marked and markings indicating their location may be erected on highways leading thereto.

§ 2. This act shall take effect immediately.

PART C

Section 1. Section 217 of the transportation law is amended by adding a new subdivision 9 to read as follows:

9. To enforce the requirements of section five thousand three hundred twenty-nine of title forty-nine of the United States Code, as amended from time to time, as it pertains to rail fixed guideway public transportation systems.

§ 2. This act shall take effect immediately.

PART D

Section 1. Subdivision 6 of section 2897 of the public authorities law is amended by adding a new paragraph f to read as follows:

f. Notwithstanding anything to the contrary contained in this section, disposals for use of the New York state thruway authority's fiber optic system, or any part thereof, may be made through agreements based on set fees rather than public auction or negotiation, provided that:

(i) the thruway authority has determined the disposal of such property complies with all applicable provisions of this chapter;

(ii) disposal of such property is in the best interest of the thruway authority; and

(iii) the set fees established for use of the fiber optic system, or part thereof, will be based on an appraisal of the fair market value of the property.

Disposals of the fiber optic system, or any part thereof, will not require the explanatory statements required by this section.

§ 2. This act shall take effect immediately.

PART E

Section 1. The transportation law is amended by adding a new section 144 to read as follows:

§ 144. Fees and charges. The commissioner or authorized officer or employee of the department shall charge and collect one hundred twenty dollars for the inspection or re-inspection of all motor vehicles transporting passengers subject to the department's inspection requirements pursuant to section one hundred forty of this article, except such motor vehicles operated under contract with a municipality to provide state-wide mass transportation operating assistance eligible service or motor vehicles used primarily to transport passengers pursuant to subparagraphs (i), (iii) and (v) of paragraph a of subdivision two of section one hundred forty of this article. The department may deny inspection of any motor vehicle transporting passengers subject to the department's inspection requirements if such fee is not paid within ninety days of the date noted on the department invoice.

§ 2. This act shall take effect immediately.

PART F

Section 1. The first undesignated paragraph of subdivision 24-b of section 10 of the highway law, as amended by chapter 155 of laws of 1985, is amended to read as follows:

Have power, whenever such commissioner of transportation deems it is necessary as a result of work of construction, reconstruction or maintenance of state highways, to provide for the removal, relocation, replacement or reconstruction of privately, publicly or cooperatively owned water, storm and sewer lines and facilities, facilities for the transmission and/or distribution of communications, power, electricity, light, heat, gas, crude products, steam and other similar commodities, municipal utility facilities, or facilities of a corporation organized pursuant to the transportation corporations law that are located on privately owned property. Notwithstanding any other provision of any law, the commissioner of transportation may enter into an agreement with a fiber optic utility for occupancy of the state right of way, provided however, any provider occupying a right of way in fulfillment of a state grant award through the New NY Broadband Program shall not be subject to a fee for such occupancy, and provided further, any fee for occupancy charged to a fiber optic utility shall be prohibited from being passed through in whole or in part as a fee, charge, increased service cost, or by any other means by a fiber optic utility to any person or entity that contracts with such fiber optic utility for service, and provided further that any compensation received by the state pursuant to such agreement shall be deposited by the comptroller into the special obligation reserve and payment account of the dedicated highway and bridge trust fund established pursuant to section eighty-nine-b of the state finance law. If such work requires additional property or if it is necessary that the relocation of such facilities be made to other property, he may acquire such property as may be necessary for the purposes of this subdivision, in the same manner as other property is acquired for state highway purposes pursuant to this chapter, and he and the owner of such facilities may enter into a written agreement to convey such property as deemed necessary for the purposes of this subdivision

1 to such owner on terms beneficial to the state. The expense of such
2 removal, relocation, replacement or reconstruction and cost of property
3 acquisition shall be a proper charge against funds available for the
4 construction, reconstruction or maintenance of state highways. Except
5 when such facilities are owned by a corporation organized pursuant to
6 the transportation corporations law, the work of such removal, relo-
7 cation, replacement or reconstruction shall be performed by contract in
8 the same manner as provided for state highways in article three of this
9 chapter, or, by the use of departmental forces and equipment and of
10 materials purchased therefor, unless the commissioner of transportation
11 consents to having the owner of such facilities provide for the work of
12 such removal, relocation, replacement or reconstruction. In the case
13 where such facilities are owned by a corporation organized pursuant to
14 the transportation corporations law, the work of such removal, relo-
15 cation, replacement or reconstruction shall be provided for by such
16 corporation unless it consents to having the commissioner of transporta-
17 tion provide for such work to be performed by contract, in accordance
18 with specifications provided by such corporation, in the same manner as
19 provided for state highways in article three of this chapter, or, by the
20 use of departmental forces and equipment and of materials purchased
21 therefor. Upon the completion of the work, such facilities shall be
22 maintained by the owners thereof.

23 § 2. The transportation corporations law is amended by adding a new
24 section 7 to read as follows:

25 § 7. Agreement for fiber optic utility occupancy of state right of
26 way. Notwithstanding any other provision of any law, the commissioner of
27 transportation may enter into an agreement with a fiber optic utility
28 for occupancy of the state right of way, provided however, any provider
29 occupying a right of way in fulfillment of a state grant award through
30 the New NY Broadband Program shall not be subject to a fee for such
31 occupancy, and provided further, any fee for occupancy charged to a
32 fiber optic utility shall be prohibited from being passed through in
33 whole or in part as a fee, charge, increased service cost, or by any
34 other means by a fiber optic utility to any person or entity that
35 contracts with such fiber optic utility for service, and provided
36 further that any compensation received by the state pursuant to such
37 agreement shall be deposited by the comptroller into the special obli-
38 gation reserve and payment account of the dedicated highway and bridge
39 trust fund established pursuant to section eighty-nine-b of the state
40 finance law.

41 § 3. The general municipal law is amended by adding a new article 13-E
42 to read as follows:

43 ARTICLE 13-E

45 Section 300. Definitions.

46 301. Use of right of way.

47 302. Collocation of small wireless facilities and micro wireless
48 facilities.

49 303. Access to municipal corporation structures.

50 304. Local authority

51 305. Dispute resolution.

52 306. Indemnification.

53 § 300. Definitions. For the purposes of this article, the following
54 terms shall have the following meanings unless the context indicates
55 otherwise:

1 1. "Antenna" means communications equipment that transmits or receives
2 electromagnetic radio frequency signals used in the provision of wire-
3 less services.

4 2. "Applicable codes" means the New York State uniform fire prevention
5 and building code as adopted, and as may be amended, pursuant to article
6 eighteen of the executive law.

7 3. "Applicant" means any person or entity that files an application
8 with a municipal corporation to install or modify wireless facilities on
9 behalf of a communications service provider or wireless provider.

10 4. "Application" means a request submitted by an applicant to a local
11 government for a permit to collocate small wireless facilities; or to
12 approve the installation or modification of a utility pole or wireless
13 support structure.

14 5. "Application fee" means the one time fee charged to an applicant by
15 a municipal corporation for review of an application. The application
16 fee may not exceed the actual reasonable costs incurred by the municipal
17 corporation in connection with its review of the application.

18 6. "Pole" means: (i) a utility pole, other than a utility pole for
19 designated services, owned or operated by a municipal corporation in the
20 right of way, including a utility pole that provides lighting or traffic
21 control functions, including light poles, traffic signals, and struc-
22 tures for signage; and (ii) a pole or similar structure owned or oper-
23 ated by a municipal corporation in the right of way that supports only
24 wireless facilities.

25 7. "Base station" means wireless facilities or a wireless support
26 structure or utility pole that currently supports wireless facilities.
27 The term does not include a tower, as defined in 47 U.S.C. §
28 1.40001(b)(9), or associated wireless facilities.

29 8. "Collocate" means to install, mount, maintain, modify, operate, or
30 replace wireless facilities on or adjacent to a wireless support struc-
31 ture or utility pole. The term "collocation" has a corresponding mean-
32 ing.

33 9. "Communications service provider" means a cable operator, as
34 defined in 47 U.S.C. § 522(5); a provider of information service, as
35 defined in 47 U.S.C. § 153(24); a telecommunications carrier, as defined
36 in 47 U.S.C. § 153(51); or a wireless provider.

37 10. "FCC" means the Federal Communications Commission of the United
38 States.

39 11. "Fee" means a one-time charge.

40 12. "Law" means federal, state, or local law, statute, common law,
41 code, rule, regulation, order, or ordinance.

42 13. "Micro wireless facility" means a wireless facility that meets the
43 following qualifications: (i) is not larger in dimension than twenty-
44 four inches in length, fifteen inches in width, and twelve inches in
45 height; and (ii) any exterior antenna is no longer than eleven inches.

46 14. "Permit" means a written authorization required by a municipal
47 corporation to perform an action or initiate, continue, or complete a
48 project relating to the installation or modification of wireless facili-
49 ties.

50 15. "Person" means an individual, corporation, limited liability
51 company, partnership, association, trust, or other entity or organiza-
52 tion.

53 16. "Rate" means a recurring charge.

54 17. "Right of way" or "ROW" means the area on, below, or above a
55 public roadway, highway, street, sidewalk, alley, utility easement, or
56 similar property, but not including a federal interstate highway.

1 18. "Small wireless facility" means a wireless facility that meets
2 both of the following qualifications: (i) each antenna is located inside
3 an enclosure of no more than six cubic feet in volume or, in the case of
4 an antenna that has exposed elements, the antenna and all of its exposed
5 elements could fit within an imaginary enclosure of no more than six
6 cubic feet; and (ii) all other wireless equipment associated with the
7 facility is cumulatively no more than twenty-eight cubic feet in volume.
8 The following types of associated ancillary equipment are not included
9 in the calculation of equipment volume: electric meter, concealment
10 elements, telecommunications demarcation box, ground-based enclosures,
11 grounding equipment, power transfer switch, cut-off switch, and vertical
12 cable runs for the connection of power and other services.

13 19. "Substantial modification" means a proposed modification to an
14 existing wireless support structure or base station which will substan-
15 tially change the physical dimensions of the wireless support structure
16 or base station under the objective standard for substantial change
17 adopted by the Federal Communications Commission pursuant to 47 C.F.R. §
18 1.40001.

19 20. "Utility pole" means a pole or similar structure that is used in
20 whole or in part by a communications service provider or for electric
21 distribution, lighting, traffic control, signage, or a similar function.
22 Such term shall not include structures supporting only wireless facili-
23 ties.

24 21. "Utility pole for designated services" means a utility pole owned
25 or operated in the ROW by a municipal corporation, a public utility
26 district, an electric membership corporation, or a rural electric coop-
27 erative that is designed to, or used in whole or in part for the purpose
28 of carrying electric distribution lines or cables or wires for telecom-
29 munications, cable, or electric service.

30 22. "Wireless facility" means equipment at a fixed location that
31 enables wireless communications between user equipment and a communi-
32 cations network, including: (i) equipment associated with wireless
33 communications; and (ii) radio transceivers, antennas, coaxial or
34 fiber-optic cable, regular and backup power supplies, and comparable
35 equipment, regardless of technological configuration. The term includes
36 small wireless facilities and micro wireless facilities. The term does
37 not include the structure or improvements on, under, or within which the
38 equipment is collocated. The term does not include: (i) the structure or
39 improvements on, under, or within which the equipment is collocated; or
40 (ii) coaxial or fiber-optic cable that is between wireless structures or
41 utility poles or that is otherwise not immediately adjacent to or
42 directly associated with a particular antenna.

43 23. "Wireless infrastructure provider" means any person, including a
44 person authorized to provide telecommunications service in the state,
45 that builds or installs wireless communication transmission equipment,
46 wireless facilities or wireless support structures, but that is not a
47 wireless services provider.

48 24. "Wireless provider" means a wireless infrastructure provider or a
49 wireless services provider.

50 25. "Wireless services" means any services, whether at a fixed
51 location or mobile, provided using wireless facilities.

52 26. "Wireless services provider" means any person or entity that
53 provides wireless services.

54 27. "Wireless support structure" means a freestanding structure, such
55 as a monopole; tower, either guyed or self-supporting; billboard; or,
56 other existing or proposed structure designed to support or capable of

1 supporting wireless facilities. Such term shall not include a utility
2 pole.

3 § 301. Use of right of way. 1. Applicability. This section shall only
4 apply to the activities of a wireless provider within the right of way.

5 2. Exclusive use prohibited. A municipal corporation may not enter
6 into an exclusive arrangement with any person for use of the right of
7 way for the construction, operation, marketing, or maintenance of wire-
8 less facilities or wireless support structures or the collocation of
9 small wireless facilities or micro wireless facilities.

10 3. Right of way rates and fees. A municipal corporation may only
11 charge a wireless provider a rate or fee for the use of the right of way
12 with respect to the construction, installation, mounting, maintenance,
13 modification, operation, or replacement of a wireless facility or wire-
14 less support structure in the right of way, including collocation in
15 such right of way, if the municipal corporation charges other communi-
16 cations service providers or publicly, cooperatively, or municipally
17 owned utilities for the use of the right of way. If a municipal corpo-
18 ration is authorized by applicable law to charge a rate or fee to those
19 persons or entities, and does so, any such rate or fee for a wireless
20 provider must be: (i) limited to no more than the direct and actual cost
21 of managing the right of way; and (ii) competitively neutral with regard
22 to other users of the right of way, including investor, municipal corpo-
23 ration, or cooperatively owned entities. No rate or fee may: (i) result
24 in a double recovery where existing rates, fees, or taxes already
25 recover the direct and actual costs of managing the rights of way; (ii)
26 be in the form of a franchise or other fee based on revenue or customer
27 counts; (iii) be unreasonable or discriminatory; (iv) violate any appli-
28 cable law; or (v) exceed an annual amount equal to twenty dollars times
29 the number of utility poles or wireless support structures in the munic-
30 ipal corporation's geographic jurisdiction on which the wireless provid-
31 er has collocated a small wireless facility antenna. Notwithstanding the
32 foregoing, in recognition of the public benefits of the deployment of
33 wireless services, a municipal corporation is permitted, on a nondiscri-
34 minatory basis, to refrain from charging any rate or fee to a wireless
35 provider for the use of the right of way.

36 4. Rate or fee adjustment. Should a municipal corporation have an
37 existing rate or fee to construct, install, mount, maintain, modify,
38 operate, or replace a wireless facility or wireless support structure in
39 the ROW, including collocation in such ROW, controlled by the municipal
40 corporation and such rate or fee does not comply with the requirements
41 in subdivision three of this section, not later than six months follow-
42 ing the effective date of this article, the municipal corporation shall
43 implement a revised rate or fee to ensure compliance with such subdivi-
44 sion three for all affected persons.

45 5. Right of access. Subject to the provisions of this section and
46 approval of an application, if required, a wireless provider shall have
47 the right, as a permitted use not subject to zoning review or approval,
48 but subject to the issuance of a permit by the municipal corporation as
49 provided in this article, to collocate wireless facilities and
50 construct, modify, maintain, and operate utility poles, wireless support
51 structures, conduit, cable, and related appurtenances and facilities
52 along, across, upon, and under the ROW. Such structures and facilities
53 shall be so constructed and maintained as not to obstruct or hinder the
54 usual travel or public safety on such ROW or obstruct the legal use of
55 such ROW by other utilities. Each new or modified utility pole and wire-
56 less support structure installed in the ROW shall not exceed the greater

1 of (i) ten feet in height above the tallest existing utility pole in
2 place as of the effective date of this article located within five
3 hundred feet of the new pole in the same ROW; or (ii) fifty feet above
4 ground level. New wireless facilities in the ROW may not extend (i) more
5 than ten feet above an existing utility pole or wireless support struc-
6 ture in place as of the effective date of this article; or (ii) above
7 the height permitted for a new utility pole or wireless support struc-
8 ture under this section. Notwithstanding the foregoing:

9 a. Subject to this article, a wireless provider shall have the right
10 to construct, modify and maintain a utility pole, wireless support
11 structure, or wireless facility that exceeds these size limits along,
12 across, upon and under the ROW, subject to review in accordance with
13 applicable municipal zoning regulations; and

14 b. Applicants shall comply with nondiscriminatory undergrounding
15 requirements after obtaining prior zoning approval in areas zoned for
16 single family residential use, provided that such requirements shall not
17 prohibit the replacement of existing structures or result in an effec-
18 tive prohibition of services. In all other zoning districts, prior
19 zoning approval shall not be required for undergrounding new infrastruc-
20 ture associated with small wireless facilities.

21 6. No discrimination. The municipal corporation, in the exercise of
22 its administration and regulation related to the management of the ROW
23 must be competitively neutral with regard to other users of the ROW,
24 including that terms may not be unreasonable or discriminatory and may
25 not violate any applicable law.

26 7. Damage and repair. The municipal corporation may require a wireless
27 provider to repair all damage to the ROW directly caused by the activ-
28 ities of the wireless provider, while occupying, installing, repairing
29 or maintaining wireless facilities, wireless support structures, or
30 utility poles in the ROW and to return the ROW to its functional equiv-
31 alence before the damage pursuant to the competitively neutral, reason-
32 able requirements and specifications of the municipal corporation. If
33 the wireless provider fails to make the repairs reasonably required by
34 the municipal corporation within a reasonable time after written notice,
35 the municipal corporation may effect those repairs and charge the appli-
36 cable party the reasonable, documented actual cost of such repairs.

37 § 302. Collocation of small wireless facilities and micro wireless
38 facilities. 1. Applicability. The provisions of this section shall apply
39 to activities of a wireless provider within or outside of the right of
40 way.

41 2. Except as expressly provided in this article, no municipal corpo-
42 ration may regulate, prohibit or charge for the collocation of
43 small/micro wireless facilities.

44 3. Small wireless facilities and micro wireless facilities shall be
45 classified as permitted uses and not subject to zoning review or
46 approval if they are collocated: (i) in the right of way in any zoning
47 district; or (ii) outside the right of way in property not zoned exclu-
48 sively for single family residential use.

49 4. A municipal corporation may require an applicant to obtain one or
50 more permits to collocate a small wireless facility, provided such
51 permits are of general applicability and do not apply exclusively to
52 wireless facilities. A municipal corporation shall receive applications
53 for, process, and issue such Permits subject to the following require-
54 ments: (i) no municipal corporation may, directly or indirectly, require
55 an applicant to perform services unrelated to the collocation for which
56 approval is sought, such as in-kind contributions to the municipal

1 corporation, including reserving fiber, conduit, or pole space for the
2 municipal corporation; (ii) no applicant shall be required to provide
3 more information to obtain a permit than communications service provid-
4 ers that are not wireless providers; (iii) within ten days of receiving
5 an application, a municipal corporation shall determine and notify the
6 applicant whether the application is complete. If an application is
7 incomplete, the municipal corporation shall specifically identify what
8 information is missing; (iv) an application shall be processed on a
9 nondiscriminatory basis and shall be deemed approved if the municipal
10 corporation fails to otherwise approve or deny the application within
11 sixty days of receipt; and (v) a municipal corporation shall approve an
12 application unless it does not meet the requirements of this article.
13 The municipal corporation shall document the basis for any denial,
14 including the specific code provisions on which the denial was based,
15 and send the documentation to the applicant on or before the day the
16 municipal corporation denies the application. The applicant may cure the
17 deficiencies identified by the municipal corporation and resubmit the
18 application within thirty days of the denial without paying an addi-
19 tional application fee. The municipal corporation shall approve or deny
20 the revised application within thirty days. Any subsequent review shall
21 be limited to the deficiencies cited in the denial; (vi) an applicant
22 seeking to collocate small wireless facilities within the jurisdiction
23 of a single municipal corporation shall be allowed, at the applicant's
24 discretion, to file a consolidated application and receive a single
25 permit for the collocation of multiple small wireless facilities; (vii)
26 collocation for which a permit has been granted shall commence within
27 one year of approval and shall be pursued to completion; and (viii) no
28 municipal corporation may institute, either expressly or de facto, a
29 moratorium on: a. filing, receiving, or processing applications; or b.
30 issuing permits or other approvals, if any, for the collocation of small
31 wireless facilities.

32 5. Application fees shall be subject to the following requirements:
33 (i) a municipal corporation may charge an application fee only if such
34 fee is required for similar types of commercial development within the
35 municipal corporation's jurisdiction; (ii) a municipal corporation shall
36 only charge a fee for the actual, direct, and reasonable costs incurred
37 by the municipal corporation relating to the granting or processing of
38 an application. Such fees shall be reasonably related in time to the
39 incurring of such costs. Where such costs are already recovered by
40 existing fees, rates, or taxes paid by a wireless provider, no applica-
41 tion fee shall be assessed to recover such costs; (iii) a fee may not
42 include: a. travel expenses incurred by a third party in its review of
43 an application; or b. direct payment or reimbursement of third party
44 rates or fees charged on a contingency basis or a result-based arrange-
45 ment; (iv) in any controversy concerning the appropriateness of a fee,
46 the municipal corporation shall have the burden of proving that the fee
47 is reasonably related to the actual, direct, and reasonable costs
48 incurred by the municipal corporation; (v) total application fees, where
49 permitted, shall not exceed the lesser of the amount charged by the
50 municipal corporation for: a. a building permit for any similar commer-
51 cial construction, activity, or land use development; or b. one hundred
52 dollars each for up to five small wireless facilities addressed in an
53 application and fifty dollars for each additional small wireless facili-
54 ty addressed in the application.

55 6. No municipal corporation shall require an application for: (i)
56 routine maintenance; (ii) the replacement of wireless facilities with

1 wireless facilities that are substantially similar or the same size or
2 smaller; or (iii) the installation, placement, maintenance, operation or
3 replacement of micro wireless facilities that are strung on cables
4 between existing utility poles, in compliance with the national elec-
5 trical safety code. A municipal corporation may require a permit to work
6 within the right of way for such activities, if applicable. Any such
7 permits shall be subject to the requirements of this section.

8 § 303. Access to municipal corporation structures. 1. Collocation of
9 small wireless facilities on or adjacent to municipal corporation poles
10 and utility poles for designated services. (i) Exclusive arrangements
11 prohibited. A person owning or controlling municipal poles or utility
12 poles for designated services may not enter into an exclusive arrange-
13 ment with any person for the right to attach to or adjacent to such
14 poles.

15 (ii) Rates. a. The rates and fees for collocations on or adjacent to
16 municipal corporation poles or utility poles for designated services
17 shall be nondiscriminatory regardless of the services provided by the
18 collocating person; b. the rate to collocate on or adjacent to utility
19 poles for designated services may not exceed the annual recurring rate
20 that would be permitted under rules adopted by the FCC under 47 U.S.C. §
21 224(e) if the rates were regulated by the FCC or twenty dollars per year
22 per wooden utility pole or two hundred dollars per year per metal,
23 concrete, or fiberglass utility pole, whichever is less; c. the rate to
24 collocate on municipal corporation poles shall recover the actual,
25 direct, and reasonable costs related to the applicant's application for
26 and use of space on the municipal corporation pole; d. the total annual
27 rate for collocations and any activities related to such collocations
28 shall not exceed the lesser of actual, direct, and reasonable costs
29 related to the collocation on or adjacent to the pole or twenty dollars
30 per year per wooden utility pole or two hundred dollars per year per
31 metal, concrete, or fiberglass utility pole, whichever is less; e. in
32 any controversy concerning the appropriateness of a rate for a municipal
33 corporation's pole, the municipal corporation shall have the burden of
34 proving that the rates are reasonably related to the actual, direct, and
35 reasonable costs incurred for use of space on the pole for such period;
36 f. should a municipal corporation, municipally-owned or operated-per-
37 son, public utility district, or cooperative have an existing pole
38 attachment rate, fee, or other term that does not comply with the
39 requirements of this section, the municipal corporation, municipally-
40 owned or operated person, public utility district, or cooperative shall,
41 not later than six months following the effective date of this article,
42 reform such rate, fee, or term in compliance with this subdivision.

43 (iii) Rates, fees, and terms to be offered. Persons owning or control-
44 ling municipal corporation poles and utility poles for designated
45 services shall offer rates, fees, and other terms that comply with the
46 provision set forth in this section within the later of six months of
47 the effective date of this article or three months after receiving a
48 request to collocate its first small wireless facility on a municipal
49 corporation pole or a utility pole for designated services owned or
50 controlled by a municipal corporation.

51 2. Collocation on or adjacent to municipal corporation wireless
52 support structures and utility poles outside the right of way. A municip-
53 al corporation shall authorize the collocation of small wireless facil-
54 ities and micro wireless facilities on or adjacent to wireless support
55 structures and utility poles owned or controlled by a municipal corpo-
56 ration that are not located within the right of way to the same extent

1 the municipal corporation permits access to such structures for other
2 commercial projects or uses. Such collocations shall be subject to
3 reasonable and nondiscriminatory rates, fees, and terms as provided in
4 an agreement between the municipal corporation and the wireless provid-
5 er.

6 § 304. Local authority. Subject to the provisions of this article and
7 applicable federal law, a municipal corporation may continue to exercise
8 zoning, land use, planning and permitting authority within its territo-
9 rial boundaries, including with respect to wireless support structure
10 and utility poles; except that no municipal corporation shall have or
11 exercise any jurisdiction or authority over the design, engineering,
12 construction, installation, or operation of any small wireless facility
13 or micro wireless facility located in an interior structure or upon the
14 site of any campus, stadium, or athletic facility not otherwise owned or
15 controlled by the municipal corporation, other than to comply with
16 applicable codes. Nothing in this article authorizes the state or any
17 political subdivision, including a municipal corporation, to require
18 wireless facility deployment or to regulate wireless services.

19 § 305. Dispute resolution. Courts of competent jurisdiction shall have
20 jurisdiction to determine all disputes arising under this article.

21 § 306. Indemnification. No municipal corporation shall require a
22 wireless provider to indemnify and hold the municipal corporation and
23 its officers and employees harmless against any claims, lawsuits, judg-
24 ments, costs, liens, losses, expenses or fees, except when a court of
25 competent jurisdiction has found that the negligence of the wireless
26 provider while installing, repairing or maintaining caused the harm that
27 created such claims, lawsuits, judgments, costs, liens, losses,
28 expenses, or fees or to require a wireless provider to obtain insurance
29 naming the municipal corporation or its officers and employees an addi-
30 tional insured against any of the foregoing.

31 § 4. This act shall take effect immediately; provided, however, that
32 section three of this act shall take effect on the thirtieth day after
33 it shall have become a law.

34 PART G

35 Section 1. Paragraph (c) of subdivision 3 of section 501 of the vehi-
36 cle and traffic law, as added by chapter 449 of the laws of 1989, is
37 amended to read as follows:

38 (c) in the city of New York, [~~driving shall be prohibited~~] from five
39 o'clock in the morning to nine o'clock in the evening, when accompanied
40 by a person at least twenty-one years of age and who is a duly licensed
41 parent, guardian, person in a position of loco parentis to the licensee,
42 driver education teacher, or driving school instructor, when operating a
43 vehicle equipped with dual brake controls.

44 § 2. Subdivision 2 of section 510-c of the vehicle and traffic law, as
45 amended by section 5 of part B of chapter 55 of the laws of 2014, is
46 amended to read as follows:

47 2. For purposes of this section, the term "serious traffic violation"
48 shall mean operating a motor vehicle in violation of any of the follow-
49 ing provisions of this chapter: articles twenty-five and twenty-six;
50 subdivision one of section six hundred; section six hundred one;
51 sections eleven hundred eleven, eleven hundred seventy, eleven hundred
52 seventy-two and eleven hundred seventy-four; subdivisions (a), (b), (c),
53 (d) and (f) of section eleven hundred eighty, provided that the
54 violation involved ten or more miles per hour over the established

1 limit; section eleven hundred eighty-two; subdivision [~~three-a~~] three-b
2 of section twelve hundred twenty-nine-c for violations involving use of
3 safety belts or seats by a child under the age of sixteen; and section
4 twelve hundred twelve of this chapter.

5 § 3. Subdivision 3 of section 1225-c of the vehicle and traffic law,
6 as added by chapter 69 of the laws of 2001, is amended and a new subdivi-
7 sion 2-a is added to read as follows:

8 2-a. No person under eighteen years of age shall operate a motor vehi-
9 cle upon a public highway while engaging in a call with a hand-held or
10 hands-free mobile telephone. For the purposes of this subdivision,
11 engaging in a call shall include making or receiving a call with a hand-
12 held or hands-free mobile telephone.

13 3. [~~Subdivision~~] Subdivisions two and two-a of this section shall not
14 apply to (a) the use of a mobile telephone for the sole purpose of
15 communicating with any of the following regarding an emergency situ-
16 ation: an emergency response operator; a hospital, physician's office or
17 health clinic; an ambulance company or corps; a fire department,
18 district or company; or a police department, (b) any of the following
19 persons while in the performance of their official duties: a police
20 officer or peace officer; a member of a fire department, district or
21 company; or the operator of an authorized emergency vehicle as defined
22 in section one hundred one of this chapter, or (c) except as applied to
23 persons under the age of eighteen years, the use of a hands-free mobile
24 telephone.

25 § 4. Paragraphs (a) and (b) of subdivision 2 of section 1225-d of the
26 vehicle and traffic law, as amended by section 8 of part C of chapter 58
27 of the laws of 2013, are amended to read as follows:

28 (a) "Portable electronic device" shall mean any hand-held mobile tele-
29 phone, as defined by subdivision one of section twelve hundred twenty-
30 five-c of this article, personal digital assistant (PDA), handheld
31 device with mobile data access, laptop computer, pager, broadband
32 personal communication device, two-way messaging device, electronic
33 game, or portable computing device, or any other [~~electronic~~] personal
34 wireless communications device when used to input, write, send, receive,
35 or read text or images for present or future communication, including
36 doing so for the purpose of SMS texting, emailing, instant messaging, or
37 engaging in any other form of electronic data retrieval or electronic
38 data communication.

39 (b) "Using" shall mean holding or making contact with a portable elec-
40 tronic device [~~while~~] for the purpose of viewing, taking or transmitting
41 images, playing games, or, for the purpose of present or future communi-
42 cation: performing a command or request to access a world wide web page,
43 composing, sending, reading, viewing, accessing, browsing, transmitting,
44 saving or retrieving e-mail, text messages, instant messages, or other
45 electronic data.

46 § 5. Subdivision 2 of section 1225-d of the vehicle and traffic law is
47 amended by adding a new paragraph (e) to read as follows:

48 (e) "Personal wireless communications device" (i) means a device
49 through which personal wireless services (as defined in section
50 332(c)(7)(C)(i) of the Communications Act of 1934 (47 U.S.C.
51 332(c)(7)(C)(i))) are transmitted; and

52 (ii) does not include a global navigation satellite system receiver
53 used for positioning, emergency notification, or navigation purposes.

54 § 6. Subdivision 4 of section 1225-d of the vehicle and traffic law,
55 as amended by section 10 of part C of chapter 58 of the laws of 2013, is
56 amended to read as follows:

1 4. A person who [~~holds~~] **uses** a portable electronic device in a
2 conspicuous manner while operating a motor vehicle or while operating a
3 commercial motor vehicle on a public highway including while temporarily
4 stationary because of traffic, a traffic control device, or other momen-
5 tary delays but not including when such commercial motor vehicle is
6 stopped at the side of, or off, a public highway in a location where
7 such vehicle is not otherwise prohibited from stopping by law, rule,
8 regulation or any lawful order or direction of a police officer is
9 presumed to be using such device, except that a person operating a
10 commercial motor vehicle while using a portable electronic device when
11 such vehicle is stopped at the side of, or off, a public highway in a
12 location where such vehicle is not otherwise prohibited from stopping by
13 law, rule, regulation or any lawful order or direction of a police offi-
14 cer shall not be presumed to be using such device. The presumption
15 established by this subdivision is rebuttable by evidence tending to
16 show that the operator was not using the device within the meaning of
17 this section.

18 § 7. Subdivision 3 of section 1229-c of the vehicle and traffic law,
19 as added by chapter 365 of the laws of 1984, is amended to read as
20 follows:

21 3. No person shall operate a motor vehicle unless such person is
22 restrained by a safety belt approved by the commissioner. No person
23 sixteen years of age or over shall be a passenger in [~~the front seat of~~]
24 a motor vehicle unless such person is restrained by a safety belt
25 approved by the commissioner.

26 § 8. Subdivision 13 of section 1229-c of the vehicle and traffic law,
27 as amended by chapter 20 of the laws of 2008, is amended to read as
28 follows:

29 13. Notwithstanding the provisions of subdivision four of this
30 section, no person shall operate a school bus for which there are no
31 applicable federal school bus safety standards unless all occupants are
32 restrained by a safety belt approved by the commissioner or, regarding
33 occupants age four or older but under age [~~seven~~] **eight**, are restrained
34 pursuant to subdivision one or two of this section.

35 § 9. The vehicle and traffic law is amended by adding a new section
36 1170-a to read as follows:

37 § 1170-a. Owner liability for failure of operator to obey signal indi-
38 cating approach of train. (a) 1. Notwithstanding any other provision of
39 law, any political subdivision as defined herein is hereby authorized
40 and empowered to adopt and amend a local law, ordinance or resolution
41 establishing a demonstration program imposing monetary liability on the
42 owner of a vehicle for failure of an operator thereof to comply with
43 section eleven hundred seventy of this article. Such demonstration
44 program shall empower a political subdivision to install and operate
45 railroad grade crossing photo violation-monitoring devices at any rail-
46 road sign or signal over which it has jurisdiction. The cost of the
47 photo violation monitoring devices may be borne by the political subdi-
48 vision, a commuter railroad operating within such political subdivision,
49 or a combination of both such political subdivision and commuter rail-
50 road pursuant to a memorandum of understanding.

51 2. Such demonstration program shall utilize necessary technologies to
52 ensure, to the extent practicable, that photographs produced by such
53 railroad grade crossing photo violation-monitoring systems shall not
54 include images that identify the driver, the passengers or the contents
55 of the vehicle. Notwithstanding any foregoing, no notice of liability
56 issued pursuant to this section shall be dismissed solely because a

1 photograph or photographs allow for the identification of the contents
2 of a vehicle, provided that such political subdivision has made a
3 reasonable effort to comply with the provisions of this paragraph.

4 (b) Within the jurisdiction of any such political subdivision which
5 has adopted a local law, ordinance or resolution pursuant to subdivision
6 (a) of this section, the owner of a vehicle shall be liable for a penal-
7 ty imposed pursuant to this section if such vehicle was used or operated
8 with the permission of the owner, express or implied, in violation of
9 section eleven hundred seventy of this article, and such violation is
10 evidence by information obtained from a railroad grade crossing photo
11 violation-monitoring system; provided, however, that no owner of a vehi-
12 cle shall be liable for a penalty imposed pursuant to this section where
13 the operator of such vehicle has been convicted of the underlying
14 violation of section eleven hundred seventy of this article.

15 (c) For purposes of this section, the following terms shall have the
16 following meaning:

17 1. "Owner" shall have the meaning provided in article two-B of this
18 chapter;

19 2. "Railroad grade crossing photo violation-monitoring system" shall
20 mean a vehicle sensor installed to work in conjunction with a railroad
21 sign or signal which automatically produces two or more photographs, two
22 or more microphotographs, a videotape or other recorded images of each
23 vehicle at the time it is used or operated in violation of section elev-
24 en hundred seventy of this article;

25 3. "Political subdivision" shall mean a county, city, town, or village
26 located in the metropolitan commuter transportation district, as such
27 district is defined in section twelve hundred sixty-two of the public
28 authorities law; and

29 4. "Commuter railroad" shall mean a railroad owned and operated by the
30 metropolitan transportation authority within the metropolitan commuter
31 transportation district, as such term is defined in section twelve
32 hundred sixty-two of the public authorities law.

33 (d) A certificate, sworn to or affirmed by a technician employed by
34 the commuter railroad or by the political subdivision in which the
35 charged violation occurred, or a facsimile thereof, based upon
36 inspection of photographs, microphotographs, videotape or other recorded
37 images produced by a railroad grade crossing photo violation-monitoring
38 system, shall be prima facie evidence of the facts contained therein.
39 Any photographs, microphotographs, videotape or other recorded images
40 evidencing such a violation shall be available for inspection in any
41 proceeding to adjudicate the liability for such violation pursuant to a
42 local law, ordinance or resolution adopted pursuant to this section.

43 (e) An owner liable for a violation of section eleven hundred seventy
44 of this article pursuant to a local law, ordinance or resolution adopted
45 pursuant to this section shall be liable for monetary penalties in
46 accordance with a schedule of fines and penalties to be established in
47 such local law, ordinance or resolution. The liability of the owner
48 pursuant to this section shall not exceed two hundred fifty dollars for
49 each violation; provided, however, that an adjudicating authority may
50 provide for an additional penalty not in excess of fifty dollars for
51 each violation for the failure to respond to a notice of liability with-
52 in the prescribed period of time.

53 (f) An imposition of liability under a local law, ordinance or resol-
54 ution adopted pursuant to this section shall not be deemed a conviction
55 as an operator and shall not be made part of the operating record of the

1 person upon whom such liability is imposed nor shall it be used for
2 insurance purposes in the provision of motor vehicle insurance coverage.

3 (g) 1. A notice of liability shall be sent by first class mail to each
4 person alleged to be liable as an owner for a violation of section elev-
5 en hundred seventy of this article pursuant to this section. Personal
6 delivery on the owner shall not be required. A manual or automatic
7 record of mailing prepared in the ordinary course of business shall be
8 prima facie evidence of the facts contained therein.

9 2. A notice of liability shall contain the name and address of the
10 person alleged to be liable as an owner for a violation of section elev-
11 en hundred seventy of this article pursuant to this section, the regis-
12 tration number of the vehicle involved in such violation, the location
13 where such violation took place, the date and time of such violation and
14 the identification number of the camera which recorded the violation or
15 other document locator number.

16 3. The notice of liability shall contain information advising the
17 person charged of the manner and the time in which he or she may contest
18 the liability alleged in the notice. Such notice of liability shall also
19 contain a warning to advise the person charged that failure to contest
20 in the manner and time provided shall be deemed an admission of liabil-
21 ity and that a default judgment may be entered thereon.

22 4. The notice of liability shall be prepared and mailed by the poli-
23 tical subdivision, or by any other entity authorized by such political
24 subdivision to prepare and mail such notification of violation.

25 (h) Adjudication of the liability imposed upon owners by this section
26 shall be by the court having jurisdiction over traffic infractions,
27 except that if such political subdivision has established an administra-
28 tive tribunal to hear and determine complaints of traffic infractions
29 constituting parking, standing or stopping violations such political
30 subdivision may, by local law, authorize such adjudication by such
31 tribunal.

32 (i) If an owner receives a notice of liability pursuant to this

An applicant for participation in the pilot program established pursuant to this article shall be an approved sponsor of an internet accident prevention course, pursuant to article twelve-C of this title, prior to the effective date of this article. In order to be approved for participation in such pilot program, the course must comply with provisions of law, rules and regulations applicable thereto. The commissioner may, in his or her discretion, impose a fee for the submission of each application. Such fee shall not exceed seven thousand five hundred dollars, which shall be deposited in the dedicated highway and bridge trust fund established pursuant to section eighty-nine-b of the state finance law.

§ 399-r. Regulations and fees. 1. The commissioner is authorized to promulgate any rules and regulations necessary to implement the provisions of this article and to insure that the internet pilot program, as approved by the commissioner, can validate: student identity at registration and throughout the course; participation throughout the

1 course; that time the requirements are met; and successful completion of
2 the course. Provided, however, that any rules and regulations promulgat-

11 (c) Penn Station Access; and

12 (d) 125th MNR and subway stations.

13 2. From time to time, the board of the metropolitan transportation
14 authority may create and establish transportation improvement subdis-
15 tricts as it deems necessary and appropriate provided that the planned
16 capital program elements in an approved capital program that are
17 expected to result in an increase in the fair market value of real prop-
18 erty in such transportation improvement subdistrict have an estimated
19 capital cost greater than one hundred million dollars.

20 3. Prior to the vote by the board of the metropolitan transportation
21 authority to create and establish a transportation improvement subdis-
22 trict, the following shall have occurred:

23 (a) The legal description of the boundaries of the transportation
24 improvement subdistrict shall have been prepared. A transportation
25 improvement subdistrict may be established anywhere within a city of a
26 population of one million or more that is within the metropolitan commu-
27 ter transportation district provided that a transportation improvement
28 subdistrict shall include only whole tax parcels, but shall extend no
29 further than one mile in any direction from any part of the transporta-
30 tion improvement.

31 (b) There shall have been an analysis performed by or on behalf of the
32 authority and submitted to the board of the metropolitan transportation
33 authority that indicates that the aggregate fair market value of the
34 real property within the proposed boundaries of such transportation
35 improvement subdistrict increased or is forecast to increase more than
36 it would have increased if no work performed or anticipated to be
37 performed pursuant to one or more capital program elements had occurred.
38 Such analysis shall identify generally the estimated level of average
39 incremental increase in the fair market value of real property within
40 the proposed transportation improvement subdistrict as a result of the
41 implementation of the specified capital program elements since nineteen
42 hundred eighty-one.

43 (c) The authority shall conduct a public hearing on the establishment
44 of such proposed transportation improvement subdistrict. Notice of the
45 hearing shall: (i) be written in a clear and coherent manner; (ii)
46 generally identify the boundaries of the proposed transportation
47 improvement subdistrict; (iii) state the percentage of the incremental
48 real property tax levied on all parcels within the proposed transporta-
49 tion improvement subdistrict that the authority proposes to be assessed;
50 (iv) provide the internet address where a detailed map of the boundaries
51 of the proposed transportation improvement subdistrict is publicly
52 accessible, together with a copy of the analysis provided to the board
53 of the metropolitan transportation authority pursuant to paragraph (b)
54 of this subdivision; (v) be sent to the mayor of a city with a popu-
55 lation of one million or more in which the proposed transportation
56 improvement subdistrict is located at least thirty days prior to such

1 public hearing; and (vi) be posted on the authority's website for at
2 least thirty days prior to such public hearing.

3 (d) After such hearing and at any time prior to the adoption of the
4 resolution recommending establishment of a transportation improvement
5 subdistrict, the authority may amend the boundaries of the recommended
6 transportation improvement subdistrict.

7 (e) The resolution by which the board of the metropolitan transporta-
8 tion authority shall establish a transportation improvement subdistrict
9 shall include a detailed statement of the reasons why the board consid-
10 ers that the proposed transportation improvement subdistrict has bene-
11 fitted or will benefit from implementation of the specified capital
12 program elements and shall specify the percentage of the incremental
13 real property tax levied on all parcels within each of the following
14 transportation improvement subdistricts that shall be assessed provided
15 that such percentage may not exceed fifty percent.

16 (f) Upon approval by the board of the metropolitan transportation
17 authority of a resolution establishing a transportation improvement
18 subdistrict, the authority shall add it to the list of approved trans-
19 portation improvement subdistricts set forth in article fifteen-D of the
20 real property tax law that it shall maintain on the authority's publicly
21 available website and also shall notify the metropolitan transportation
22 authority capital program review board.

23 (g) The adoption by the board of the metropolitan transportation
24 authority of a resolution establishing a transportation improvement
25 subdistrict shall not be subject to provisions of article eight, nine-
26 teen, twenty-four or twenty-five of the environmental conservation law,
27 or to any local law or ordinance adopted pursuant to such article.

28 § 4. The real property tax law is amended by adding a new article 15-D
29 to read as follows:

32 Section 1596. Definitions.

35 § 1596. Definitions. As used or referred to in this article, unless a
36 different meaning clearly appears from the context:

37 1. "Baseline real property tax" shall mean the total real property
38 taxes levied on a parcel last levied prior to the effective date of the
39 resolution of the metropolitan transportation authority establishing the
40 transportation improvement subdistrict in which such parcel is located
41 and shall also include any payments in lieu of taxes made with respect
42 to any such parcel.

43 2. "Incremental real property tax" shall mean that portion of the real
44 property taxes levied on a parcel each year in excess of the baseline
45 real property tax and shall include any payments in lieu of taxes made
46 with respect to any parcel.

47 3. "Real property" shall mean "real property" as defined in subdivi-
48 sion twelve of section one hundred two of this chapter.

49 4. "Parcel" shall mean a "parcel" as defined in subdivision eleven of
50 section one hundred two of this chapter.

51 5. "Taxing jurisdiction" shall mean a municipal corporation or special
52 district which imposes a charge upon real property located within a city
53 of a population of one million or more.

54 6. "Transportation improvement subdistrict" shall mean a transporta-
55 tion improvement subdistrict duly approved by the board of the metropol-
56 itan transportation authority pursuant to section twelve hundred sixty-

1 nine-h of the public authorities law and added to the list of such
2 transportation improvement subdistricts maintained by the metropolitan
3 transportation authority.

4 § 1597. Levying assessment. 1. For the sole purpose of providing an
5 additional stable and reliable dedicated funding source for the metro-
6 politan transportation authority, the New York city transit authority
7 and their subsidiaries to preserve, operate and improve essential trans-
8 it and transportation services in the metropolitan commuter transporta-
9 tion district, an assessment equal to not more than seventy-five percent
10 of the incremental real property tax levied on all parcels within each
11 of the following transportation improvement subdistricts shall be
12 levied, commencing, for each parcel in a transportation improvement
13 subdistrict, with the first levy of real property taxes on such parcel
14 occurring on or after the date of calculation of the baseline real prop-
15 erty tax for such parcel. For the transportation improvement subdis-
16 tricts established pursuant to subdivision two of section twelve hundred
17 sixty-nine-h of the public authorities law, such assessment shall
18 commence for each parcel in such subdistrict with the first levy of real
19 property taxes on such parcel on or after the date that the metropolitan

23 taxes on any parcel in such subdistrict following the approval of the

25 2. Notwithstanding any law to the contrary, the metropolitan transpor-
26 tation authority shall have no liability to any taxing jurisdiction or
27 to any real property taxpayer for any tax certiorari proceeding or any
28 other judicial or administrative proceeding commenced with respect to
29 any real property tax assessment.

30 § 1598. Collection of assessment. 1. Each taxing jurisdiction will
31 timely collect and pay over the assessment to the metropolitan transpor-
32 tation authority in a form and manner prescribed by such authority.

33 2. In the event that any taxing jurisdiction with responsibility for
34 collecting the transportation improvement subdistrict assessment does
35 not pay such assessments within thirty days of the receipt of such
36 assessment, the metropolitan transportation authority shall notify the
37 state comptroller in writing and such comptroller shall, upon review and
38 determination that an assessment was not paid, deduct any amount not
39 paid from any amount of state aid or any other state payment due to such
40 taxing jurisdiction. The state comptroller shall remit the amounts so
41 deducted and recovered to the metropolitan transportation authority.

42 § 5. This act shall take effect immediately.

43 PART M

44 Section 1. Legislative intent. Historically, under existing law, and
45 pursuant to its master lease with the New York city transit authority
46 (NYCT), the city of New York is required to pay for the capital needs of
47 the NYCT. This obligation has never ceased from the initial chapter
48 establishing the NYCT and transferring the operation of the city's
49 subway system to the NYCT in 1953. This legislation clarifies this long-
50 standing obligation and establishes a process for state assistance when
51 a disaster emergency is declared.

52 § 2. Subdivision 1 of section 1269-b of the public authorities law, as
53 amended by chapter 637 of the laws of 1996, is amended to read as
54 follows:

1 1. (a) On or before October first, nineteen hundred eighty-one, and
2 on or before October first of every fifth year thereafter, through and
3 including October first, nineteen hundred ninety-one, the authority
4 shall submit to the metropolitan transportation authority capital
5 program review board two capital program plans for the five year period
6 commencing January first of the following year;

7 (b) not later than ten days after the effective date of this paragraph
8 the authority shall submit to the metropolitan transportation authority
9 capital program review board two capital program plans for the five-year
10 period commencing January first, nineteen hundred ninety-five; and

11 (c) on or before October first, nineteen hundred ninety-nine and every
12 fifth year thereafter, the authority shall submit to the metropolitan
13 transportation authority capital program review board two capital
14 program plans for the five-year period commencing January first of the
15 following year.

16 For each of the periods described above, one such plan shall contain
17 the capital program for the transit facilities operated by the New York
18 city transit authority and its subsidiaries and for the Staten Island
19 rapid transit operating authority; the other such plan shall contain the
20 capital program for the railroad facilities, not including the Staten
21 Island rapid transit operating authority, under the jurisdiction of the
22 authority.

23 Each plan shall set system-wide goals and objectives for capital
24 spending, establish standards for service and operations, and describe
25 each capital element proposed to be initiated in each of the years
26 covered by the plan and explain how each proposed element supports the
27 achievement of the service and operational standards established in the
28 plan. Each plan shall also set forth an estimate of the amount of capi-
29 tal funding required each year and the expected sources of such funding,
30 except that for such capital funding required each year for transit
31 facilities operated by the New York city transit authority and its
32 subsidiaries, the city of New York shall provide in full all funding
33 required to meet the capital needs of the New York city transit authori-
34 ty in such plan. Each plan subsequent to the first such plan and each
35 proposed amendment or modification thereof shall also describe the
36 current status of each capital element included in the previously
37 approved plan, if any. Each plan shall be accompanied or supplemented by
38 such supporting materials as the metropolitan transportation authority
39 capital program review board shall require.

40 A capital element shall mean either a category of expenditure itemized
41 in a plan, as hereinafter provided, for which a specified maximum dollar
42 amount is proposed to be expended, or a particularly described capital
43 project within one or more categories for which no maximum expenditure
44 is proposed, but for which an estimate of expected cost is provided. A
45 capital element shall be deemed to have been initiated for purposes of
46 this section if in connection with such element the authority shall
47 certify that (i) purchase or construction contracts have been entered
48 into, obligating in the aggregate an amount exceeding ten percent of the
49 maximum or estimated cost of the element as set forth in a plan, (ii)
50 financing specific to the project has been undertaken, or (iii) in a
51 case where such element is limited to design or engineering, a contract
52 therefor has been entered into.

53 § 3. Section 1269-b of the public authorities law is amended by adding
54 a new subdivision 10 to read as follows:

55 10. In the case of a disaster emergency declared pursuant to section
56 twenty-eight of the executive law, where such disaster emergency relates

to the continuing failures and the condition of the track, signals and other infrastructure of the transit facilities operated by the New York city transit authority, the state may appropriate revenues it deems necessary and appropriate to fund the capital costs of repairs and construction deemed essential to ensure the continued safe and effective operation of such transit facilities. Upon any such appropriation, the city of New York shall, within sixty days, appropriate an identical sum to provide for capital repairs and construction.

§ 4. This act shall take effect immediately.

PART N

Section 1. Paragraph (a) of subdivision 5 of section 2879 of the public authorities law, as amended by chapter 531 of the laws of 1993, is amended to read as follows:

(a) Each corporation shall notify the commissioner of economic development of the award of a procurement contract for the purchase of goods or services from a foreign business enterprise in an amount equal to or greater than one million dollars simultaneously with notifying the successful bidder therefor. ~~[No corporation shall thereafter enter into a procurement contract for said goods or services until at least fifteen days has elapsed, except for procurement contracts awarded on an emergency or critical basis, or where the commissioner of economic development waives the provisions of this sentence.]~~ The notification to the commissioner of economic development shall include the name, address and telephone and facsimile number of the foreign business enterprise, a brief description of the goods or services to be obtained pursuant to the proposed procurement contract, the amount of the proposed procurement contract, the term of the proposed procurement contract, and the name of the individual at the foreign business enterprise or acting on behalf of the same who is principally responsible for the proposed procurement contract. Such notification shall be used by the commissioner of economic development solely to provide notification to New York state business enterprises of opportunities to participate as subcontractors and suppliers on such procurement contracts, to promote and encourage the location and development of new business in the state, to assist New York state business enterprises in obtaining offset credits from foreign countries, and to otherwise investigate, study and undertake means of promoting and encouraging the prosperous development and protection of the legitimate interest and welfare of New York state business enterprises, industry and commerce.

§ 2. Subdivision 7 of section 1209 of the public authorities law, as amended by section 1 of part 00 of chapter 54 of the laws of 2016, is amended to read as follows:

7. (a) Except as otherwise provided in this section, all purchase contracts for supplies, materials or equipment involving an estimated expenditure in excess of one ~~[hundred thousand]~~ million dollars and all contracts for public work involving an estimated expenditure in excess of one ~~[hundred thousand]~~ million dollars shall be awarded by the authority to the lowest responsible bidder after obtaining sealed bids in the manner hereinafter set forth. The aforesaid shall not apply to contracts for personal, architectural, engineering or other professional services. The authority may reject all bids and obtain new bids in the manner provided by this section when it is deemed in the public interest to do so or, in cases where two or more responsible bidders submit identical bids which are the lowest bids, award the contract to any of such

1 bidders or obtain new bids from such bidders. Nothing herein shall obli-
2 gate the authority to seek new bids after the rejection of bids or after
3 cancellation of an invitation to bid. Nothing in this section shall
4 prohibit the evaluation of bids on the basis of costs or savings includ-
5 ing life cycle costs of the item to be purchased, discounts, and
6 inspection services so long as the invitation to bid reasonably sets
7 forth the criteria to be used in evaluating such costs or savings. Life
8 cycle costs may include but shall not be limited to costs or savings
9 associated with installation, energy use, maintenance, operation and
10 salvage or disposal.

11 (b) Section twenty-eight hundred seventy-nine of this chapter shall
12 apply to the authority's acquisition of goods or services of any kind,
13 in the actual or estimated amount of fifteen thousand dollars or more,

Such study shall include, but not be limited to, an analysis of the history of minority and women-owned business enterprise programs and their effectiveness as a means of securing and ensuring participation by minorities and women, and a disparity analysis by market area and region of the state. Such study shall distinguish between minority males, minority females and non-minority females in the statistical analysis.

The director of the division of minority and ~~women-owned~~ women's business development is directed to transmit the disparity study to the governor and the legislature ~~[not later than August fifteenth, two thousand sixteen]~~, and to post the study on the website of the department of economic development.

Where the contracting agency states that a failure to remedy any notified deficiency in the utilization plan is a ground for disqualification the contractor shall be entitled to an administrative hearing, on a record, involving all grounds stated by the contracting agency. Such hearing shall be conducted by the appropriate authority of the contracting agency to review the determination of disqualification. A final administrative determination made following such hearing shall be reviewable in a proceeding commenced under article seventy-eight of the civil practice law and rules, provided that such proceeding is commenced within thirty days of the notice given by certified mail return receipt requested rendering such final administrative determination. Such proceeding shall be commenced in the supreme court, appellate division, third department and such proceeding shall be preferred over all other civil causes except election causes, and shall be heard and determined in preference to all other civil business pending therein, except election matters, irrespective of position on the calendar. Appeals taken to the court of appeals of the state of New York shall be subject to the same preference.

6. Where it appears that a contractor cannot, after a good faith effort, comply with the minority and women-owned business enterprise participation requirements set forth in a particular state contract, a contractor may file a written application with the contracting agency requesting a partial or total waiver of such requirements setting forth the reasons for such contractor's inability to meet any or all of the participation requirements together with an explanation of the efforts undertaken by the contractor to obtain the required minority and women-owned business enterprise participation. In implementing the provisions of this section, the contracting agency shall consider the number and types of minority and women-owned business enterprises ~~[located]~~ available to provide goods or services required under the contract in the region in which the state contract is to be performed, the total dollar value of the state contract, the scope of work to be performed and the project size and term. If, based on such considerations, the contracting agency determines there is not a reasonable availability of contractors on the list of certified business to furnish services for the project, it shall issue a waiver of compliance to the contractor. In making such determination, the contracting agency shall first consider the availability of other business enterprises located in the region and shall thereafter consider the financial ability of minority and women-owned businesses located outside the region in which the contract is to be performed to perform the state contract.

7. For purposes of determining a contractor's good faith effort to comply with the requirements of this section or to be entitled to a waiver therefrom the contracting agency shall consider:

(a) whether the contractor has ~~[advertised in general circulation media, trade association publications, and minority focus and women focus media and, in such event, (i) whether or not certified minority or women-owned businesses which have been solicited by the contractor exhibited interest in submitting proposals for a particular project by attending]~~ attended a pre-bid conference, if any, scheduled by the state agency awarding the state contract with certified minority and women-owned business enterprises; and

~~1 [(ii) whether certified businesses which have been solicited by the~~
~~2 contractor have responded in a timely fashion to the contractor's solici-~~
~~3 tations for timely competitive bid quotations prior to the contracting~~
~~4 agency's bid date; and]~~

5 (b) whether ~~[there has been]~~ the contractor provided timely written
6 notification of subcontracting opportunities on the state contract to
7 appropriate certified businesses that appear in the directory of certi-
8 fied businesses prepared pursuant to paragraph (f) of subdivision three
9 of section three hundred eleven of this article; and

10 (c) whether the contractor can reasonably structure the amount of work

(b) The director shall work with all municipal corporations that have a municipal minority and women-owned business enterprise program to develop standards to accept state certification to meet the municipal corporation minority and women-owned business enterprise certification standards.

(c) The director shall establish a procedure enabling the division to accept federal certification verification for minority and women-owned business enterprise applicants, provided said standards comport with those required by the state minority and women-owned business program, in lieu of requiring the applicant to complete the state certification process. The director shall promulgate rules and regulations to set forth criteria for the acceptance of federal certification.

2-b. Each business applying for minority or women-owned business enterprise certification pursuant to this section must agree to allow: (i) the department of taxation and finance to share its tax information with the division and (ii) the department of labor to share its tax and employer information with the division.

Following application for certification pursuant to this section, the director shall provide the applicant with written notice of the status of the application, including notice of any outstanding deficiencies[~~, within thirty days~~]. Within [~~sixty~~] thirty days of submission of a final completed application, the director shall provide the applicant

When a proposal consists of unit prices of items specified to be performed, the lowest bid shall be deemed to be that which specifically states the lowest gross sum for which the entire work will be performed, except for certain contracts awarded to minority or women-owned business enterprises as provided herein, including all the items specified in the proposal thereof. The lowest bid shall be determined by the commissioner of general services on the basis of the gross sum for which the entire work will be performed, arrived at by a correct computation of all the items specified in the proposal therefor at the unit prices contained in the bid. Provided, however, that where a responsible and reliable bidder certified as a minority-owned business enterprise or women-owned business enterprise pursuant to article fifteen-A of the executive law submits a bid of one million four hundred thousand dollars or less, as adjusted annually for inflation beginning January first, two thousand nineteen, the bid of the minority or women-owned business

enterprise shall be deemed the lowest bid unless it exceeds the bid of any other bidder by more than ten percent.

1. "Minority-owned business enterprise" means a business enterprise certified as such pursuant to article fifteen-A of the executive law.

2. "State contract" shall have the same meaning as in article fifteen-A of the executive law.

3. "Women-owned business enterprise" means a business enterprise certified as such pursuant to article fifteen-A of the executive law.

§ 181.10 Minority or women-owned business enterprise fraud in the third degree.

A person is guilty of minority or women-owned business enterprise fraud in the third degree when he or she knowingly provides materially false information or omits material information concerning the use or identification of a minority or women-owned business enterprise for the purpose of being awarded, or demonstrating compliance with the minority and women-owned business participation requirements of, a state contract.

Minority or women-owned business enterprise fraud in the third degree is a class A misdemeanor.

§ 181.20 Minority or women-owned business enterprise fraud in the second degree.

A person is guilty of minority or women-owned business enterprise fraud in the second degree when he or she knowingly provides materially false information or omits material information concerning the use or identification of a minority or women-owned business enterprise for the purpose of being awarded, or demonstrating compliance with the minority and women-owned business participation requirements of, a state contract, and the state contract is valued in excess of fifty thousand dollars.

Minority or women-owned business enterprise fraud in the second degree is a class E felony.

§ 181.30 Minority or women-owned business enterprise fraud in the first degree.

A person is guilty of minority or women-owned business enterprise fraud in the first degree when he or she knowingly provides materially false information or omits material information concerning the use or identification of a minority or women-owned business enterprise for the purpose of being awarded, or demonstrating compliance with the minority and women-owned business participation requirements of, a state contract, and the state contract is valued in excess of one million dollars.

Minority or women-owned business enterprise fraud in the first degree is a class D felony.

§ 14. The opening paragraph of subdivision (h) of section 121 of chapter 261 of the laws of 1988, amending the state finance law and other laws relating to the New York state infrastructure trust fund, as amended by section 1 of part CCC of chapter 59 of laws of 2017, is amended to read as follows:

§ 821. Definitions. As used in this article, the following terms shall have the following meanings:

1. "Contractor" shall mean an individual, a business enterprise, including a sole proprietorship, a partnership, a corporation, a not-for-profit corporation, or any other party to a state contract, or a bidder in conjunction with the award of a state contract or a proposed party to a state contract.

2. "Department" shall mean the department of labor.

3. "Director" shall mean the director of the division of minority and women's business development.

4. "Disparity study" shall mean the most recent study of disparities between the utilization of minority group members and women in the performance of state contracts and the availability of minority group members and women to perform such work by the director pursuant to article fifteen-A of this chapter.

5. "Division" shall mean the department of economic development's division of minority and women's business development.

6. "List of non-compliant contractors" shall mean a list of contractors and subcontractors, maintained by the division and published on the website of the division, that are ineligible to participate as contractors or subcontractors in the performance of state contracts for a term determined by the director.

7. "Minority group member" shall mean a United States citizen or permanent resident alien who is and can demonstrate membership in one of the following groups:

(a) Black persons having origins in any of the Black African racial groups;

1 (b) Hispanic persons of Mexican, Puerto Rican, Dominican, Cuban,
2 Central or South American of either Indian or Hispanic origin, regard-
3 less of race;

4 (c) Native American or Alaskan native persons having origins in any of
5 the original peoples of North America;

6 (d) Asian and Pacific Islander persons having origins in any of the
7 Far East countries, South East Asia, the Indian subcontinent or the
8 Pacific Islands.

9 8. "Non-compliant contractor" shall mean a contractor or subcontractor

10. "State contract" shall mean: (a) a written agreement or purchase order instrument, providing for a total expenditure in excess of fifty thousand dollars, whereby a state agency is committed to expend or does expend or grant funds in return for labor, services including but not limited to legal, financial and other professional services, supplies, equipment, materials or any combination of the foregoing, to be performed on behalf of, for, or rendered or furnished to the state agency; (b) a written agreement in excess of two hundred thousand dollars whereby a state agency is committed to expend or does expend or grant funds for the acquisition, construction, demolition, replacement, major repair or renovation of real property and improvements thereon; and (c) a written agreement in excess of two hundred thousand dollars whereby the owner of a state assisted housing project is committed to expend or does expend funds for the acquisition, construction, demolition, replacement, major repair or renovation of real property and improvements thereon for such project.

11. "Subcontractor" shall mean any individual or business enterprise that provides goods or services to any individual or business for use in the performance of a state contract, whether or not such goods or services are provided to a party to a state contract.

§ 822. Workforce participation goals. 1. The director, in consultation with the department, shall develop aspirational goals for the utilization of minority group members and women in construction trade, profession, and occupation.

(a) Aspirational goals for the utilization of minority group members and women must set forth the expected participation of minority group members and women in each construction trade, profession, and occupation, and shall be expressed as a percentage of the total hours of work to be performed by each trade, profession, and occupation based on the availability of minority group members and women within each trade, profession, and occupation.

(i) The aspirational goals shall set forth separate levels of expected participation by men and women for each minority group, and for Caucasian women, in each construction trade, profession, and occupation.

(ii) Aspirational goals for the expected participation of minority group members and women shall be established for each county of the state. The director may establish aspirational goals for the expected participation of minority group members and women for municipalities where the director deems feasible and appropriate.

(iii) The director shall, in establishing the aspirational goals, consider the findings of the most recent disparity study and any relevant data published by the United States Census Bureau.

1 (b) The director shall update the aspirational goals on a periodic
2 basis, no less than annually.

3 2. State agencies shall, for each invitation for bids, request for
4 proposals, or other solicitation that will result in the award of a
5 state contract, set forth the expected degree of workforce participation
6 by minority group members and women.

7 (a) Each workforce participation goal established by a state agency
8 shall set forth the expected level of participation by minority group
9 members and women in the performance of each trade, profession, and
10 occupation required in the performance of the contract.

11 (b) Goals for the participation of minority group members and women
12 shall set forth separate goals for each of the following groups in each
13 trade, profession, and occupation:

14 (i) Black men;

15 (ii) Black women;

16 (iii) Hispanic men;

17 (iv) Hispanic women;

18 (v) Native American men;

19 (vi) Native American women;

20 (vii) Asian men;

21 (viii) Asian women;

22 (ix) Caucasian women.

23 (c) In establishing workforce participation goals, state agencies
24 shall consider factors including, but not limited to:

25 (i) the findings of the disparity study;

26 (ii) any relevant data published by the United States Census Bureau;
27 and

28 (iii) if applicable, any aspirational goal established by the divi-
29 sion.

30 (d) In any case where a state agency establishes a workforce partic-
31 ipation goal on an invitation for bids, request for proposals, or other
32 solicitation that will result in the award of a state contract for
33 construction that deviates from the aspirational goal for construction
34 work in the county or municipality in which the work will be performed,
35 the state agency shall document numerical evidence demonstrating that
36 the application of the aspirational goal would not be practical, feasi-
37 ble, or appropriate.

38 3. Every contractor responding to an invitation for bids, request for
39 proposals, or other solicitation that will result in the award of a
40 state contract subject to workforce participation goals pursuant to this
41 section shall agree to make a good faith effort to achieve such work-
42 force participation goal or request a waiver of such goal.

43 (a) A contractor that certifies that it will make a good faith effort
44 to achieve a workforce participation goal shall provide with its
45 response to the applicable invitation for bids, request for proposals,
46 or other solicitation:

47 (i) A certification stating that the contractor will make a good faith
48 effort to achieve the applicable workforce participation goal and will
49 contractually require any subcontractors to the contractor to make a
50 good faith effort to achieve the applicable workforce participation goal
51 in any subcontracted work, which certification shall acknowledge that
52 failure by the contractor or any of its subcontractors to make a good
53 faith effort to achieve the applicable workforce participation goal may
54 result in a determination by the contracting state agency that the
55 contractor or its subcontractor is a non-compliant contractor;

1 (ii) The level of anticipated participation by minority group members
2 and women as employees to the contractor, or, if the state agency has
3 specifically indicated that such documentation is not required as part
4 of the response to the invitation for bids, request for proposals, or
5 other solicitation, a date certain for the submission of such documenta-
6 tion after the award of the state contract;

7 (iii) A list of all subcontractors anticipated to perform work on the
8 state contract and the level of anticipated participation by minority
9 group members and women as employees to each subcontractor, or, if the
10 state agency has specifically indicated that such documentation is not
11 required as part of the response to the invitation for bids, request for
12 proposals, or other solicitation, a date certain for the submission of
13 such documentation after the award of the state contract; and

14 (iv) Such other information as the contracting state agency shall
15 require.

16 (b) A contractor that requests a waiver of a workforce participation
17 goal shall provide with its response to the applicable invitation for
18 bids, request for proposals, or other solicitation:

19 (i) Numerical evidence setting forth why the achievement of the work-
20 force participation goal is not practical, feasible, or appropriate in
21 light of the trades, professions, and occupations required to perform
22 the work of the state contract;

23 (ii) Documentation of the contractor's efforts, and any efforts by
24 subcontractors to the contractor, to promote the inclusion of minority
25 group members and women in trades, professions, and occupations required
26 in the performance of the state contract;

27 (iii) The maximum feasible level of participation by minority group
28 members and women in each of the trades, professions, and occupations
29 required in the performance of the work of the state contract;

30 (iv) The level of anticipated participation by minority group members
31 and women as employees to the contractor;

32 (v) A list of all subcontractors anticipated to perform work on the
33 state contract and the level of anticipated participation by minority
34 group members and women as employees to each subcontractor; and

35 (vi) Any other relevant information evidencing that the contractor's
36 achievement of the workforce participation goal would not be practical,
37 feasible, or appropriate.

38 4. A state agency shall not award a state contract to a contractor
39 unless the contractor has (i) certified that it will make a good faith
40 effort to achieve the applicable workforce participation goal and
41 provided documentation of the workforce anticipated to perform the work
42 of the state contract or (ii) submitted a waiver request which the state
43 agency deems to reflect the maximum feasible participation of minority
44 group members and women in each of the trades, professions, and occupa-
45 tions required in performance of the work of the state contract.

46 (a) In the event that a contractor submits a certification or waiver
47 request that is accepted by the state agency, the state agency shall
48 establish in the state contract the expected level of participation by
49 minority group members and women in each of the trades, professions, and
50 occupations required in performance of the work of the state contract,
51 require that the contractor make good faith efforts to achieve such
52 workforce participation goals, require that the contractor require any
53 subcontractors to make a good faith effort to achieve the applicable
54 workforce participation goal in any subcontracted work, and indicate
55 that the failure of the contractor or any of its subcontractors to make
56 a good faith effort to achieve the workforce participation goal may

1 result in the contractor or subcontractor being deemed a non-compliant
2 contractor.

3 (b) In the event that a contractor fails to submit a certification,
4 waiver request, or any other information required by the state agency,
5 or the state agency determines that a contractor's waiver request does
6 not demonstrate that the applicable workforce participation goal is
7 impractical, unfeasible, or inappropriate, the state agency shall notify
8 the contractor of the deficiency in writing and provide the contractor
9 five business days to remedy the noticed deficiency. A state agency
10 shall reject any bid or proposal of a contractor that fails to timely
11 respond to a notice of deficiency or to provide documentation remedying
12 the deficiency to the satisfaction of the state agency.

13 (i) Where failure to remedy any notified deficiency in the workforce
14 utilization plan is a ground for disqualification, that issue and all
15 other grounds for disqualification shall be stated in writing by the
16 contracting state agency. The contractor shall be entitled to an admin-
17 istrative hearing, on a record, involving all grounds stated by the
18 contracting state agency in its notice of the contractor's disqualifica-
19 tion. Such hearing shall be conducted by the appropriate authority of
20 the contracting agency to review the determination of disqualification.
21 A final administrative determination made following such hearing shall
22 be reviewable in a proceeding commenced under article seventy-eight of
23 the civil practice law and rules, provided that such proceeding is
24 commenced within thirty days of the notice given by certified mail
25 return receipt requested rendering such final administrative determi-
26 nation. Such proceeding shall be commenced in the supreme court, appel-
27 late division, third department and such proceeding shall be preferred
28 over all other civil causes except election causes, and shall be heard
29 and determined in preference to all other civil business pending there-
30 in, except election matters, irrespective of position on the calendar.
31 Appeals taken to the court of appeals of the state of New York shall be
32 subject to the same preference.

33 § 823. Reporting. 1. State contracts shall require contractors to
34 submit, and to require any subcontractors to submit, to the contracting
35 state agency reports documenting the hours worked by employees of the
36 contractor and any subcontractors in the performance of the work of the
37 state contract. Such reports shall be submitted no less frequently than
38 monthly for state contracts for construction and quarterly for all other
39 state contracts. Such reports shall identify the race, ethnicity,
40 gender, and trade, profession, or occupation of each employee performing
41 work on a state contract.

42 2. State agencies shall submit periodic reports to the director, or
43 the designee of the director, concerning the participation of minority
44 group members and women in state contracts let by such agencies and such
45 state agencies' compliance with this article. Such reports shall be
46 submitted at such time, and include such information, as the director
47 shall require in regulations. State agencies shall make available their
48 facilities, books, and records for inspection, upon reasonable notice,
49 by the director or the director's designee.

50 3. The department shall provide such assistance as the director shall
51 require in carrying out the requirements of this section.

52 § 824. Enforcement. 1. Where it appears that a contractor cannot,
53 after a good faith effort, meet the workforce participation goals set
54 forth in a particular state contract, a contractor may file a written
55 application with the contracting state agency requesting a partial or
56 total waiver of such requirements. Such request shall set forth the

1 reasons for such contractor's inability to meet the workforce partic-
2 ipation goal, specifically describe the reasons for any deviations from
3 the anticipated workforce participation set forth in the contractor's
4 bid or proposal leading to the award of the state contract, and describe
5 the efforts by the contractor and any subcontractors to achieve the
6 maximum feasible participation of minority group members and women in
7 the performance of the work of the state contract. Where the contrac-
8 tor's inability to achieve the workforce participation goal on a state
9 contract is attributable to the failure of one or more subcontractors to
10 make good faith efforts to achieve the maximum feasible participation of
11 minority group members and women in the performance of the work of the
12 state contract, the contractor shall identify such subcontractor or
13 subcontractors to the contracting state agency.

14 2. A state agency shall grant a request for a waiver of workforce
15 participation goals on a state contract where:

16 (a) The contractor demonstrates that the contractor and its subcon-
17 tractors made good faith efforts to achieve the workforce participation
18 goal on the state contract, and that insufficient minority group members
19 or women were available in the trades, professions, and occupations
20 required to perform the work of the state contract; or,

21 (b) The contractor contractually required each of its subcontractors
22 to make a good faith effort to achieve the maximum feasible partic-
23 ipation of minority group members and women in the performance of the
24 subcontracted work, periodically monitored such subcontractors' deploy-
25 ment of minority group members and women in the performance of the
26 subcontracted work, provided notice to such subcontractors of any defi-
27 ciencies in their deployment of minority group members and women in the
28 performance of such subcontracted work, and could not achieve the work-
29 force participation goal for one or more trades, professions, or occupa-
30 tions without the good faith efforts of such subcontractors.

31 3. Where a state agency denies a contractor's request for a waiver of
32 workforce participation goals pursuant to this section, the state agency
33 shall recommend to the director and the department that the contractor
34 be deemed a non-compliant contractor.

35 4. Where a state agency grants a request for a waiver of workforce
36 participation goals pursuant to this section based on one or more
37 subcontractors' failure to make good faith efforts to achieve the maxi-
38 mum feasible participation of minority group members and women in the
39 performance of the subcontracted work, the state agency shall recommend
40 to the director and the department that the subcontractor be deemed a
41 non-compliant contractor.

42 5. Upon receipt of a recommendation from a state agency that a
43 contractor or subcontractor should be deemed a non-compliant contractor,
44 the director shall, with the assistance of the department, review the
45 facts and circumstances forming the basis of the recommendation and
46 issue a determination as to whether or not the contractor or subcontract-
47 or should be deemed a non-compliant contractor and, if so, the duration
48 of such status as a non-compliant contractor. In determining the dura-
49 tion of a contractor's or subcontractor's status as a non-compliant
50 contractor, the director shall consider:

51 (i) whether the contractor or subcontractor has previously been deemed
52 a non-compliant contractor;

53 (ii) the number of hours of expected participation by minority group
54 members and women lost as a result of the contractor's or subcontract-
55 or's failure to make good faith efforts to include minority group
56 members or women in the performance of one or more state contracts; and

(iii) whether the contractor or subcontractor has offered to provide employment opportunities, training, or other remedial benefits to minority group members or women in relevant trades, professions, or occupations.

6. A contractor or subcontractor deemed a non-compliant contractor by the director may request an administrative hearing before an independent hearing officer to appeal the determination of the director. The decision of the hearing officer shall be final and may only be vacated or modified as provided in article seventy-eight of the civil practice law and rules upon an application made within the time provided by such article.

7. Upon a final determination that a contractor or subcontractor is a non-compliant contractor, the director shall list the contractor or subcontractor as such on its website and indicate the term of such contractor's or subcontractor's status as a non-compliant contractor. A non-compliant contractor shall be ineligible to participate as a contractor or subcontractor on any state contract.

§ 825. Powers and responsibilities of the division. 1. The director shall post to the website of the division on or before April first of each year the aspirational goals for the utilization of minority group members and women in construction required pursuant to section eight hundred twenty-two of this article.

2. The director shall promulgate rules and regulations for the implementation of this article, including, but not limited to, procedures for the submission of certifications and workforce utilization plans by contractors, criteria for granting waivers of workforce participation goals, and the contents of reports by state agencies concerning their implementation of the requirements of this article.

3. The division shall, from time to time, review the facilities, books, and records of state agencies to ascertain the accuracy of their reports and their compliance with the requirements of this article. The department shall provide such assistance as the director shall require in carrying out the requirements of this section.

§ 826. Severability. If any clause, sentence, paragraph, section or part of this article shall be adjudged by any court of competent jurisdiction to be invalid, the judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part of this article directly involved in the controversy in which the judgment shall have been rendered.

§ 16. This act shall take effect on April 1, 2018; provided, however, that

In establishing the schedule and process for determining a guaranteed maximum price, the contract between the authorized state entity and the contractor shall:

~~[(i)]~~ (a) describe the scope of the work and the cost of performing such work;

~~[(ii)]~~ (b) include a detailed line item cost breakdown;

~~[(iii)]~~ (c) include a list of all drawings, specifications and other information on which the guaranteed maximum price is based;

~~[(iv)]~~ (d) include the dates for substantial and final completion on which the guaranteed maximum price is based; and

~~[(v)]~~ (e) include a schedule of unit prices; or

~~[3-]~~ (ii) Utilizing a lump sum contract in which the contractor agrees to accept a set dollar amount for a contract which comprises a single bid without providing a cost breakdown for all costs such as for equipment, labor, materials, as well as such contractor's profit for completing all items of work comprising the project which lump sum price may be negotiated and established by the authorized state entity based on a proposed guaranteed maximum price.

2. The design-build contract may include both lump sum elements and cost-plus not to exceed guaranteed maximum price elements, and also may provide for professional services on a fee-for-service basis.

(b) Capital projects undertaken by an authorized state entity may include an incentive clause in the contract for various performance objectives, but the incentive clause shall not include an incentive that exceeds the quantifiable value of the benefit received by the authorized state entity. ~~[(The)]~~ Notwithstanding the provisions of sections 136 and 137 of the state finance law, the authorized state entity shall establish such performance and payment bonds, bonds or other form of undertaking, as it deems necessary.

(6) for each community based organization which is an applicant or a co-applicant, a copy of its determination of tax exempt status issued by the federal internal revenue service pursuant to section 501 of the internal revenue code, a description of the relationship between the community based organization and the area that is the subject of the application, its financial and institutional accountability, its experience in conducting and completing planning initiatives and in working with the local government associated with the proposed brownfield opportunity area; and

(7) the financial commitments the applicant will make to the brownfield opportunity area for activities including, but not limited to, marketing of the area for business development, human resource services for residents and businesses in the brownfield opportunity area, and services for small and minority and women-owned businesses.

(2) areas with concentrations of known or suspected brownfield sites;

(3) areas for which the application demonstrates support from a municipality and a community based organization;

(4) areas showing indicators of economic distress including low resident incomes, high unemployment, high commercial vacancy rates, depressed property values; and

(5) areas with known or suspected brownfield sites presenting strategic opportunities to stimulate economic development, community revitalization or the siting of public amenities.

f. The commissioner, upon the receipt of an application for such assistance from a community based organization not in cooperation with the local government having jurisdiction over the proposed brownfield opportunity area, shall request the municipal government to review and state the municipal government's support or lack of support. The municipal government's statement shall be considered a part of the application.

g. Prior to making an award for assistance, the commissioner shall notify the temporary president of the senate and the speaker of the assembly.

h. Following notification to the applicant that assistance has been awarded, and prior to disbursement of funds, a contract shall be executed between the department and the applicant or co-applicants. The commissioner shall establish terms and conditions for such contracts as the commissioner deems appropriate in consultation with the secretary of state, including provisions to define: applicant's work scope, work schedule, and deliverables; fiscal reports on budgeted and actual use of funds expended; and requirements for submission of a final fiscal report. ~~b. Application for nomination of a brownfield opportunity area shall provide the following minimum community participation activities:];~~

~~[(2)]~~ (6) a public meeting on a brownfield opportunity area ~~[draft]~~ application for designation.

9. Financial assistance; advance payment. Notwithstanding any other law to the contrary, financial assistance pursuant to this section provided by the commissioner and the secretary pursuant to an executed contract may include an advance payment up to twenty-five percent of the contract amount.

10. The secretary shall establish criteria for brownfield opportunity area conformance determinations for purposes of the brownfield redevelopment tax credit component pursuant to clause (ii) of subparagraph (B) of paragraph ~~[(5)]~~ five of subdivision (a) of section twenty-one of the tax law. In establishing criteria, the secretary shall be guided by, but not limited to, the following considerations: how the proposed use and development advances the designated brownfield opportunity area plan's vision statement, goals and objectives for revitalization; how the density of development and associated buildings and structures advances the plan's objectives, desired redevelopment and priorities for investment; and how the project complies with zoning and other local laws and standards to guide and ensure appropriate use of the project site.

§ 2. This act shall take effect immediately.

PART V

Section 1. Section 159-j of the executive law is REPEALED.

§ 2. This act shall take effect October 1, 2018.

PART W

Section 1. This act enacts into law major components of legislation relating to student loan servicers and student debt relief consultants. Each component is wholly contained within a Subpart identified as Subparts A through C. The effective date for each particular provision contained within such Subpart is set forth in the last section of such Subpart. Any provision in any section contained within a Subpart, including the effective date of the Subpart, which makes a reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Subpart in which it is found.

SUBPART A

Section 1. The banking law is amended by adding a new article 14-A to read as follows:

§ 710. Definitions. 1. "Applicant" shall mean any person applying for a license to be a student loan servicer.

2. "Borrower" shall mean any resident of this state who has received a student loan or agreed in writing to pay a student loan or any person who shares a legal obligation with such resident for repaying a student loan.

3. "Borrower benefit" shall mean an incentive offered to a borrower in connection with the origination of a student loan, including but not limited to an interest rate reduction, principal rebate, fee waiver or rebate, loan cancellation, or cosigner release.

4. "Exempt organization" shall mean any banking organization, foreign banking corporation, national bank, federal savings association, federal credit union, or any bank, trust company, savings bank, savings and loan association, or credit union organized under the laws of any other state, or any person licensed or supervised by the department exempted by the superintendent pursuant to regulations promulgated in accordance with this article.

5. "Person" shall mean any individual, association, corporation, limited liability company, partnership, trust, unincorporated organization, government, and any other entity.

6. "Servicer" or "student loan servicer" shall mean a person licensed pursuant to section seven hundred eleven of this article to engage in the business of servicing any student loan of a borrower.

7. "Servicing" shall mean:

(a) receiving any payment from a borrower pursuant to the terms of any student loan;

(b) applying any payment to a borrower's account pursuant to the terms of a student loan or the contract governing the servicing of any such loan;

(c) providing any notification of amounts owed on a student loan by or on account of any borrower;

(d) during a period when a borrower is not required to make a payment on a student loan, maintaining account records for the student loan and communicating with the borrower regarding the student loan on behalf of the owner of the student loan promissory note;

1 (e) interacting with a borrower with respect to or regarding any
2 attempt to avoid default on the borrower's student loan, or facilitating
3 the activities described in paragraph (a) or (b) of this subdivision; or
4 (f) performing other administrative services with respect to a borrow-
5 er's student loan.

6 8. "Student loan" shall mean any loan to a borrower to finance postse-
7 condary education or expenses related to postsecondary education.

8 § 711. Licensing. 1. No person shall engage in the business of servic-
9 ing student loans owed by one or more borrowers residing in this state
10 without first being licensed by the superintendent as a student loan
11 servicer in accordance with this article and such regulations as may be
12 prescribed by the superintendent.

13 2. The licensing provisions of this subdivision shall not apply to any
14 exempt organization; provided that such exempt organization notifies the
15 superintendent that it is acting as a student loan servicer in this
16 state and complies with sections seven hundred nineteen and seven
17 hundred twenty-one of this article and any regulation applicable to
18 student loan servicers promulgated by the superintendent.

19 § 712. Application for a student loan servicer license; fees. 1. The

49 § 713. Application process to receive license to engage in the busi-
50 ness of student loan servicing. 1. Upon the filing of an application for
51 a license, if the superintendent shall find that the financial responsi-
52 bility, experience, character, and general fitness of the applicant and,
53 if applicable, the members, officers, partners, directors and principals
54 of the applicant are such as to command the confidence of the community
55 and to warrant belief that the business will be operated honestly, fair-
56 ly, and efficiently within the purpose of this article, the superinten-

1 dent shall thereupon issue a license in duplicate to engage in the busi-
2 ness of servicing student loans described in section seven hundred ten
3 of this article in accordance with the provisions of this article. If
4 the superintendent shall not so find, the superintendent shall not issue

38 § 714. Changes in officers and directors. Upon any change of any of
39 the executive officers, directors, partners or members of any student
40 loan servicer, the student loan servicer shall submit to the superinten-
41 dent the name, address, and occupation of each new officer, director,
42 partner or member, and provide such other information as the superinten-
43 dent may require.

44 § 715. Changes in control. 1. It shall be unlawful, except with the
45 prior approval of the superintendent, for any action to be taken which
46 results in a change of control of the business of a student loan servi-
47 cer. Prior to any change of control, the person desirous of acquiring
48 control of the business of a student loan servicer shall make written
49 application to the superintendent and pay an investigation fee as

45 regulation promulgated by the superintendent under and within the
46 authority of this article, or any other applicable law;

47 (b) any fact or condition exists which, if it had existed at the time

50 (c) a servicer does not cooperate with an examination or investigation

55 servicer, an individual controlling, directly or indirectly, ten percent
56 or more of the outstanding interests, or any person responsible for

1 servicing a student loan for the servicer indicates that it is not in
2 the public interest to permit the servicer to continue servicing student
3 loans;

4 (f) the servicer engages in an unsafe or unsound practice;

5 (g) the servicer is insolvent, suspends payment of its obligations, or
6 makes a general assignment for the benefit of its creditors; or

7 (h) a servicer has violated the laws of this state, any other state or
8 any federal law involving fraudulent or dishonest dealing, or a final
9 judgment has been entered against a student loan servicer in a civil
10 action upon grounds of fraud, misrepresentation or deceit.

11 2. The superintendent may, on good cause shown, or where there is a
12 substantial risk of public harm, suspend any license for a period not
13 exceeding thirty days, pending investigation. "Good cause", as used in
14 this subdivision, shall exist when a student loan servicer has defaulted
15 or is likely to default in performing its financial engagements or
16 engages in dishonest or inequitable practices which may cause substan-
17 tial harm to the persons afforded the protection of this article.

18 3. Except as provided in subdivision two of this section, no license
19 shall be revoked or suspended except after notice and a hearing thereon.
20 Any order of suspension issued after notice and a hearing may include as
21 a condition of reinstatement that the student loan servicer make resti-
22 tution to consumers of fees or other charges which have been improperly
23 charged or collected, including but not limited to by allocating
24 payments contrary to a borrower's direction or in a manner that fails to
25 help a borrower avoid default, as determined by the superintendent. Any
26 hearing held pursuant to the provisions of this section shall be
27 noticed, conducted and administered in compliance with the state admin-

29 4. Any student loan servicer may surrender any license by delivering
30 to the superintendent written notice that it thereby surrenders such
31 license, but such surrender shall not affect the servicer's civil or
32 criminal liability for acts committed prior to such surrender. If such
33 surrender is made after the issuance by the superintendent of a state-
34 ment of charges and notice of hearing, the superintendent may proceed
35 against the servicer as if the surrender had not taken place.

36 5. No revocation, suspension, or surrender of any license shall impair
37 or affect the obligation of any pre-existing lawful contract between the
38 student loan servicer and any person, including the department.

39 6. Every license issued pursuant to this article shall remain in force
40 and effect until the same shall have been surrendered, revoked or
41 suspended in accordance with any other provisions of this article.

42 7. Whenever the superintendent shall revoke or suspend a license
43 issued pursuant to this article, he or she shall forthwith execute in
44 duplicate a written order to that effect. The superintendent shall file
45 one copy of such order in the office of the department and shall forth-
46 with serve the other copy upon the student loan servicer. Any such order
47 may be reviewed in the manner provided by article seventy-eight of the
48 civil practice law and rules.

49 § 717. Books and records; reports and electronic filing. 1. Each
50 student loan servicer and exempt organization shall keep and use in its
51 business such books, accounts and records as will enable the superinten-
52 dent to determine whether the servicer or exempt organization is comply-
53 ing with the provisions of this article and with the rules and regu-
54 lations lawfully made by the superintendent. Every servicer and exempt
55 organization shall preserve such books, accounts, and records, for at

14 3. Notwithstanding article three of the state technology law or any

17 or executed by electronic means if he or she deems it necessary to
18 ensure the efficient administration of this article.

19 § 718. Rules and regulations. 1. In addition to such powers as may
20 otherwise be prescribed by this chapter, the superintendent is hereby
21 authorized and empowered to promulgate such rules and regulations as may
22 in the judgment of the superintendent be consistent with the purposes of
23 this article, or appropriate for the effective administration of this
24 article, including, but not limited to:

25 (a) Such rules and regulations in connection with the activities of
26 student loan servicers and exempt organizations as may be necessary and
27 appropriate for the protection of borrowers in this state.

28 (b) Such rules and regulations as may be necessary and appropriate to
29 define unfair, deceptive or abusive acts or practices in connection with
30 the activities of student loan servicers and exempt organizations in
31 servicing student loans.

32 (c) Such rules and regulations as may define the terms used in this
33 article and as may be necessary and appropriate to interpret and imple-
34 ment the provisions of this article.

35 (d) Such rules and regulations as may be necessary for the enforcement
36 of this article.

37 2. The superintendent is hereby authorized and empowered to make such
38 specific rulings, demands and findings as the superintendent may deem
39 necessary for the proper conduct of the student loan servicing industry.

40 § 719. Prohibited practices. No student loan servicer shall:

41 1. Employ any scheme, device or artifice to defraud or mislead a
42 borrower.

43 2. Engage in any unfair, deceptive or predatory act or practice toward
44 any person or misrepresent or omit any material information in
45 connection with the servicing of a student loan, including, but not
46 limited to, misrepresenting the amount, nature or terms of any fee or
47 payment due or claimed to be due on a student loan, the terms and condi-
48 tions of the loan agreement or the borrower's obligations under the
49 loan.

50 3. Misapply payments to the outstanding balance of any student loan or
51 to any related interest or fees.

52 4. Provide inaccurate information to a consumer reporting agency.

53 5. Refuse to communicate with an authorized representative of the
54 borrower who provides a written authorization signed by the borrower,
55 provided that the servicer may adopt procedures reasonably related to

1 verifying that the representative is in fact authorized to act on behalf
2 of the borrower.

3 6. Make any false statement or make any omission of a material fact in
4 connection with any information or reports filed with a governmental
5 agency or in connection with any investigation conducted by the super-
6 intendent or another governmental agency.

7 § 720. Servicing student loans without a license. 1. Whenever, in the
8 opinion of the superintendent, a person is engaged in the business of
9 servicing student loans, either actually or through subterfuge, without
10 a license from the superintendent, the superintendent may order that
11 person to desist and refrain from engaging in the business of servicing
12 student loans in the state. If, within thirty days after an order is
13 served, a request for a hearing is filed in writing and the hearing is
14 not held within sixty days of the filing, the order shall be rescinded.

15 2. This section shall not apply to exempt organizations.

16 § 721. Responsibilities. 1. If a student loan servicer regularly
17 reports information to a consumer reporting agency, the servicer shall
18 accurately report a borrower's payment performance to at least one
19 consumer reporting agency that compiles and maintains files on consumers
20 on a nationwide basis as defined in Section 603(p) of the federal Fair
21 Credit Reporting Act (15 U.S.C. Sec. 1681a(p)), upon acceptance as a
22 data furnisher by that consumer reporting agency.

23 2. (a) Except as provided in federal law or required by a student loan
24 agreement, a student loan servicer shall inquire of a borrower how to
25 apply a borrower's nonconforming payment. A borrower's direction on how
26 to apply a nonconforming payment shall remain in effect for any future
27 nonconforming payment during the term of a student loan until the
28 borrower provides different directions.

29 (b) For purposes of this subdivision, "nonconforming payment" shall
30 mean a payment that is either more or less than the borrower's required
31 student loan payment.

32 3. (a) If the sale, assignment, or other transfer of the servicing of
33 a student loan results in a change in the identity of the person to whom
34 the borrower is required to send subsequent payments or direct any
35 communications concerning the student loan, a student loan servicer
36 shall transfer all information regarding a borrower, a borrower's
37 account, and a borrower's student loan, including but not limited to the
38 borrower's repayment status and any borrower benefits associated with
39 the borrower's student loan, to the new student loan servicer servicing
40 the borrower's student loan within forty-five days.

41 (b) A student loan servicer shall adopt policies and procedures to
42 verify that it has received all information regarding a borrower, a
43 borrower's account, and a borrower's student loan, including but not
44 limited to the borrower's repayment status and any borrower benefits
45 associated with the borrower's student loan, when the servicer obtains
46 the right to service a student loan.

47 4. If a student loan servicer sells, assigns, or otherwise transfers
48 the servicing of a student loan to a new servicer, the sale, assignment
49 or other transfer shall be completed at least seven days before the
50 borrower's next payment is due.

51 5. (a) A student loan servicer that sells, assigns, or otherwise
52 transfers the servicing of a student loan shall require as a condition
53 of such sale, assignment or other transfer that the new student loan
54 servicer shall honor all borrower benefits originally represented as
55 being available to a borrower during the repayment of the student loan
56 and the possibility of such benefits, including any benefits that were

1 represented as being available but for which the borrower had not yet
2 qualified.

3 (b) A student loan servicer that obtains the right to service a
4 student loan shall honor all borrower benefits originally represented as
5 being available to a borrower during the repayment of the student loan
6 and the possibility of such benefits, including any benefits that were
7 represented as being available but for which the borrower had not yet
8 qualified.

9 6. A student loan servicer shall respond within thirty days after
10 receipt to a written inquiry from a borrower or a borrower's represen-
11 tative.

12 7. A student loan servicer shall preserve records of each student loan
13 and all communications with borrowers for not less than two years
14 following the final payment on a student loan or the sale, assignment or
15 other transfer of the servicing of a student loan, whichever occurs
16 first, or such longer period as may be required by any other provision
17 of law.

18 § 722. Examinations. 1. The superintendent may at any time, and as
19 often as he or she may determine, either personally or by a person duly
20 designated by the superintendent, investigate the business and examine
21 the books, accounts, records, and files used therein of every student
22 loan servicer. For that purpose the superintendent and his or her duly
23 designated representative shall have free access to the offices and
24 places of business, books, accounts, papers, records, files, safes and
25 vaults of all student loan servicers. The superintendent and any person
26 duly designated by him or her shall have the authority to require the
27 attendance of and to examine under oath all persons whose testimony he
28 or she may require relative to such business.

29 2. No person subject to investigation or examination under this
30 section may knowingly withhold, abstract, remove, mutilate, destroy or
31 secrete any books, records, computer records or other information.

32 3. The expenses incurred in making any examination pursuant to this
33 section shall be assessed against and paid by the student loan servicer
34 so examined, except that traveling and subsistence expenses so incurred
35 shall be charged against and paid by servicers in such proportions as
36 the superintendent shall deem just and reasonable, and such propor-
37 tionate charges shall be added to the assessment of the other expenses
38 incurred upon each examination. Upon written notice by the superinten-
39 dent of the total amount of such assessment, the servicer shall become
40 liable for and shall pay such assessment to the superintendent.

41 4. In any hearing in which a department employee acting under authori-
42 ty of this chapter is available for cross-examination, any official
43 written report, worksheet, other related papers, or duly certified copy
44 thereof, compiled, prepared, drafted, or otherwise made by such depart-
45 ment employee, after being duly authenticated by the employee, may be
46 admitted as competent evidence upon the oath of the employee that such
47 worksheet, investigative report, or other related documents were
48 prepared as a result of an examination of the books and records of a
49 servicer or other person, conducted pursuant to the authority of this
50 chapter.

51 5. Unless otherwise exempt pursuant to subdivision two of section
52 seven hundred eleven of this article, affiliates of a student loan
53 servicer are subject to examination by the superintendent on the same
54 terms as the servicer, but only when reports from, or examination of, a
55 servicer provides evidence of unlawful activity between a servicer and

1 affiliate benefitting, affecting, or arising from the activities regu-
2 lated by this article.

3 § 723. Penalties for violation of this article. 1. In addition to such
4 penalties as may otherwise be applicable by law, the superintendent may,
5 after notice and hearing, require any person found violating the
6 provisions of this article or the rules or regulations promulgated here-
7 under to pay to the people of this state a penalty for each violation of
8 the article or any regulation or policy promulgated hereunder a sum not
9 to exceed an amount as determined pursuant to section forty-four of this
10 chapter for each such violation.

11 2. Nothing in this article shall limit any statutory or common-law
12 right of any person to bring any action in any court for any act, or the
13 right of the state to punish any person for any violation of any law.

14 § 724. Severability of provisions. If any provision of this article,
15 or the application of such provision to any person or circumstance,
16 shall be held invalid, illegal or unenforceable, the remainder of the
17 article, and the application of such provision to persons or circum-
18 stances other than those as to which it is held invalid, illegal or
19 unenforceable, shall not be affected thereby.

20 § 725. Compliance with other laws. 1. Student loan servicers shall
21 engage in the business of servicing student loans in conformity with the
22 provisions of the financial services law, this chapter, such rules and
23 regulations as may be promulgated by the superintendent thereunder and
24 all applicable federal laws and the rules and regulations promulgated
25 thereunder.

26 2. Nothing in this section shall be construed to limit any otherwise
27 applicable state or federal law or regulations.

28 § 2. Subdivision 10 of section 36 of the banking law, as amended by
29 chapter 182 of the laws of 2011, is amended to read as follows:

30 10. All reports of examinations and investigations, correspondence and
31 memoranda concerning or arising out of such examination and investi-
32 gations, including any duly authenticated copy or copies thereof in the
33 possession of any banking organization, bank holding company or any
34 subsidiary thereof (as such terms "bank holding company" and "subsidi-
35 ary" are defined in article three-A of this chapter), any corporation
36 or any other entity affiliated with a banking organization within the
37 meaning of subdivision six of this section and any non-banking subsid-
38 iary of a corporation or any other entity which is an affiliate of a
39 banking organization within the meaning of subdivision six-a of this
40 section, foreign banking corporation, licensed lender, licensed casher
41 of checks, licensed mortgage banker, registered mortgage broker,
42 licensed mortgage loan originator, licensed sales finance company,
43 registered mortgage loan servicer, licensed student loan servicer,
44 licensed insurance premium finance agency, licensed transmitter of
45 money, licensed budget planner, any other person or entity subject to
46 supervision under this chapter, or the department, shall be confidential
47 communications, shall not be subject to subpoena and shall not be made
48 public unless, in the judgment of the superintendent, the ends of
49 justice and the public advantage will be subserved by the publication
50 thereof, in which event the superintendent may publish or authorize the
51 publication of a copy of any such report or any part thereof in such
52 manner as may be deemed proper or unless such laws specifically author-
53 ize such disclosure. For the purposes of this subdivision, "reports of
54 examinations and investigations, and any correspondence and memoranda
55 concerning or arising out of such examinations and investigations",
56 includes any such materials of a bank, insurance or securities regulato-

1 ry agency or any unit of the federal government or that of this state
2 any other state or that of any foreign government which are considered
3 confidential by such agency or unit and which are in the possession of
4 the department or which are otherwise confidential materials that have
5 been shared by the department with any such agency or unit and are in
6 the possession of such agency or unit.

7 § 3. Subdivisions 1, 2, 3 and 5 of section 39 of the banking law,
8 subdivisions 1, 2 and 5 as amended by chapter 123 of the laws of 2009
9 and subdivision 3 as amended by chapter 155 of the laws of 2012, are
10 amended to read as follows:

11 1. To appear and explain an apparent violation. Whenever it shall
12 appear to the superintendent that any banking organization, bank holding
13 company, registered mortgage broker, licensed mortgage banker, licensed
14 student loan servicer, registered mortgage loan servicer, licensed mort-
15 gage loan originator, licensed lender, licensed casher of checks,
16 licensed sales finance company, licensed insurance premium finance agen-
17 cy, licensed transmitter of money, licensed budget planner, out-of-state
18 state bank that maintains a branch or branches or representative or
19 other offices in this state, or foreign banking corporation licensed by
20 the superintendent to do business or maintain a representative office in
21 this state has violated any law or regulation, he or she may, in his or
22 her discretion, issue an order describing such apparent violation and
23 requiring such banking organization, bank holding company, registered
24 mortgage broker, licensed mortgage banker, licensed student loan servi-
25 cer, licensed mortgage loan originator, licensed lender, licensed casher
26 of checks, licensed sales finance company, licensed insurance premium
27 finance agency, licensed transmitter of money, licensed budget planner,
28 out-of-state state bank that maintains a branch or branches or represen-
29 tative or other offices in this state, or foreign banking corporation to
30 appear before him or her, at a time and place fixed in said order, to
31 present an explanation of such apparent violation.

32 2. To discontinue unauthorized or unsafe and unsound practices. When-
33 ever it shall appear to the superintendent that any banking organiza-
34 tion, bank holding company, registered mortgage broker, licensed mort-
35 gage banker, licensed student loan servicer, registered mortgage loan
36 servicer, licensed mortgage loan originator, licensed lender, licensed
37 casher of checks, licensed sales finance company, licensed insurance
38 premium finance agency, licensed transmitter of money, licensed budget
39 planner, out-of-state state bank that maintains a branch or branches or
40 representative or other offices in this state, or foreign banking corpo-
41 ration licensed by the superintendent to do business in this state is
42 conducting business in an unauthorized or unsafe and unsound manner, he
43 or she may, in his or her discretion, issue an order directing the
44 discontinuance of such unauthorized or unsafe and unsound practices, and
45 fixing a time and place at which such banking organization, bank holding
46 company, registered mortgage broker, licensed mortgage banker, licensed
47 student loan servicer, registered mortgage loan servicer, licensed mort-
48 gage loan originator, licensed lender, licensed casher of checks,
49 licensed sales finance company, licensed insurance premium finance agen-
50 cy, licensed transmitter of money, licensed budget planner, out-of-state
51 state bank that maintains a branch or branches or representative or
52 other offices in this state, or foreign banking corporation may volun-
53 tarily appear before him or her to present any explanation in defense of
54 the practices directed in said order to be discontinued.

55 3. To make good impairment of capital or to ensure compliance with
56 financial requirements. Whenever it shall appear to the superintendent

1 that the capital or capital stock of any banking organization, bank
2 holding company or any subsidiary thereof which is organized, licensed
3 or registered pursuant to this chapter, is impaired, or the financial
4 requirements imposed by subdivision one of section two hundred two-b of
5 this chapter or any regulation of the superintendent on any branch or
6 agency of a foreign banking corporation or the financial requirements
7 imposed by this chapter or any regulation of the superintendent on any
8 licensed lender, registered mortgage broker, licensed mortgage banker,
9 licensed student loan servicer, licensed casher of checks, licensed
10 sales finance company, licensed insurance premium finance agency,
11 licensed transmitter of money, licensed budget planner or private banker
12 are not satisfied, the superintendent may, in the superintendent's
13 discretion, issue an order directing that such banking organization,
14 bank holding company, branch or agency of a foreign banking corporation,
15 registered mortgage broker, licensed mortgage banker, licensed student
16 loan servicer, licensed lender, licensed casher of checks, licensed
17 sales finance company, licensed insurance premium finance agency,
18 licensed transmitter of money, licensed budget planner, or private bank-
19 er make good such deficiency forthwith or within a time specified in
20 such order.

21 5. To keep books and accounts as prescribed. Whenever it shall appear
22 to the superintendent that any banking organization, bank holding compa-
23 ny, registered mortgage broker, licensed mortgage banker, licensed
24 student loan servicer, registered mortgage loan servicer, licensed mort-
25 gage loan originator, licensed lender, licensed casher of checks,
26 licensed sales finance company, licensed insurance premium finance agen-
27 cy, licensed transmitter of money, licensed budget planner, agency or
28 branch of a foreign banking corporation licensed by the superintendent
29 to do business in this state, does not keep its books and accounts in
30 such manner as to enable him or her to readily ascertain its true condi-
31 tion, he or she may, in his or her discretion, issue an order requiring
32 such banking organization, bank holding company, registered mortgage
33 broker, licensed mortgage banker, licensed student loan servicer, regis-
34 tered mortgage loan servicer, licensed mortgage loan originator,
35 licensed lender, licensed casher of checks, licensed sales finance
36 company, licensed insurance premium finance agency, licensed transmitter
37 of money, licensed budget planner, or foreign banking corporation, or
38 the officers or agents thereof, or any of them, to open and keep such
39 books or accounts as he or she may, in his or her discretion, determine
40 and prescribe for the purpose of keeping accurate and convenient records
41 of its transactions and accounts.

42 § 4. Paragraph (a) of subdivision 1 of section 44 of the banking law,
43 as amended by chapter 155 of the laws of 2012, is amended to read as
44 follows:

45 (a) Without limiting any power granted to the superintendent under any
46 other provision of this chapter, the superintendent may, in a proceeding
47 after notice and a hearing, require any safe deposit company, licensed
48 lender, licensed casher of checks, licensed sales finance company,
49 licensed insurance premium finance agency, licensed transmitter of
50 money, licensed mortgage banker, licensed student loan servicer, regis-
51 tered mortgage broker, licensed mortgage loan originator, registered
52 mortgage loan servicer or licensed budget planner to pay to the people
53 of this state a penalty for any violation of this chapter, any regu-
54 lation promulgated thereunder, any final or temporary order issued
55 pursuant to section thirty-nine of this article, any condition imposed
56 in writing by the superintendent in connection with the grant of any

1 application or request, or any written agreement entered into with the
2 superintendent.
3 § 5. This act shall take effect on the one hundred eightieth day after
4 it shall have become a law.

8 ARTICLE 7

10 Section 701. Definitions.

15 706. Rules and regulations.

16 § 701. Definitions. (a) The term "advertisement" shall include, but
17 is not limited to, all forms of marketing, solicitation, or dissem-
18 ination of information related, directly or indirectly, to securing or
19 obtaining a student debt consulting contract or services. Further, it
20 shall include any and all commonly recognized forms of media marketing
21 via television, radio, print media, all forms of electronic communi-
22 cation via the internet, and all prepared sales presentations given in
23 person or over the internet to the general public.

24 (b) "Borrower" means any resident of this state who has received a
25 student loan or agreed in writing to pay a student loan or any person
26 who shares a legal obligation with such resident for repaying a student
27 loan.

28 (c) "FSA ID" means a username and password allocated to an individual
29 by the federal government to enable the individual to log in to certain
30 United States department of education websites, and may be used to sign
31 certain documents electronically.

32 (d) "Student loan" means any loan to a borrower to finance post-secon-
33 dary education or expenses related to post-secondary education.

34 (e) "Student debt consulting contract" or "contract" means an agree-
35 ment between a borrower and a consultant under which the consultant
36 agrees to provide student debt consulting services.

37 (f) "Student debt consultant" or "consultant" means an individual or a
38 corporation, partnership, limited liability company or other business
39 entity that, directly or indirectly, solicits or undertakes employment
40 to provide student debt consulting services. A consultant does not
41 include the following:

42 (1) a person or entity who holds or is owed an obligation on the
43 student loan while the person or entity performs services in connection
44 with the student loan;

45 (2) a bank, trust company, private banker, bank holding company,
46 savings bank, savings and loan association, thrift holding company,
47 credit union or insurance company organized under the laws of this
48 state, another state or the United States, or a subsidiary or affiliate
49 of such entity or a foreign banking corporation licensed by the super-
50 intendent of financial services or the comptroller of the currency;

51 (3) a bona fide not-for-profit organization that offers counseling or
52 advice to borrowers; or

1 (4) such other persons as the superintendent prescribes or interprets
2 by rule.

3 (g) "Student debt consulting services" means services that a student
4 debt consultant provides to a borrower that the consultant represents
5 will help to achieve any of the following:

6 (1) stop, enjoin, delay, void, set aside, annul, stay or postpone a
7 default, bankruptcy, tax offset, or garnishment proceeding;

8 (2) obtain a forbearance, deferment, or other relief that temporarily
9 halts repayment of a student loan;

10 (3) assist the borrower with preparing or filing documents related to
11 student loan repayment;

12 (4) advise the borrower which student loan repayment plan or forgive-
13 ness program to consider;

14 (5) enroll the borrower in any student loan repayment, forgiveness,
15 discharge, or consolidation program;

16 (6) assist the borrower in re-establishing eligibility for federal
17 student financial assistance;

18 (7) assist the borrower in removing a student loan from default; or

19 (8) educate the borrower about student loan repayment.

20 § 702. Prohibitions. A student debt consultant is prohibited from
21 doing the following:

22 (a) performing student debt consulting services without a written,
23 fully executed contract with a borrower;

24 (b) charging for or accepting any payment for student debt consulting
25 services before the full completion of all such services, including a
26 payment to be placed in escrow or any other account pending the
27 completion of such services;

28 (c) taking a power of attorney from a borrower;

29 (d) retaining any original loan document or other original document
30 related to a borrower's student loan;

31 (e) requesting that a borrower provide his or her FSA ID to the
32 consultant, or accepting a borrower's FSA ID;

33 (f) stating or implying that a borrower will not be able to obtain
34 relief on their own;

35 (g) misrepresenting, expressly or by implication, that:

36 (1) the consultant is a part of, affiliated with, or endorsed or spon-
37 sored by the government, government loan programs, the United States
38 department of education, or borrowers' student loan servicers; or

39 (2) some or all of a borrower's payments to the consultant will be
40 applied towards the borrower's student loans.

41 (h) inducing or attempting to induce a student debtor to enter a
42 contract that does not fully comply with the provisions of this article;
43 or

44 (i) engaging in any unfair, deceptive, or abusive act or practice.

45 § 703. Disclosure requirements. (a) A student debt consultant shall
46 clearly and conspicuously disclose in all advertisements:

47 (1) the actual services the consultant provides to borrowers;

48 (2) that borrowers can apply for and obtain consolidation loans from
49 the United States department of education at no cost, including provid-
50 ing a direct link in all written advertising to the application materi-
51 als for a Direct Consolidation Loan from the U.S. department of educa-
52 tion;

53 (3) that consolidation or other services offered by the consultant may
54 not be the best or only option for borrowers;

1 (4) that a borrower may obtain alternative federal student loan repay-
2 ment plans, including income-based programs, without consolidating
3 existing federal student loans; and

4 (5) that borrowers should consider consulting their student loan
5 servicer before signing any legal document concerning a student loan.

6 (b) The disclosures required by subsection (a) of this section, if
7 disseminated through print media or the internet, shall be clearly and
8 legibly printed or displayed in not less than twelve-point bold type,
9 or, if the advertisement is printed to be displayed in print that is
10 smaller than twelve point, in bold type print that is no smaller than
11 the print in which the text of the advertisement is printed or
12 displayed.

13 (c) The provisions of this section shall apply to all consultants who
14 disseminate advertisements in the state of New York or who intend to
15 directly or indirectly contact a borrower who has a student loan and is
16 in New York state. Consultants shall establish and at all times maintain
17 control over the content, form and method of dissemination of all adver-
18 tisements of their services. Further, all advertisements shall be
19 sufficiently complete and clear to avoid the possibility of deception or
20 the ability to mislead or deceive.

21 § 704. Student debt consulting contracts. (a) A student debt consult-
22 ing contract shall:

23 (1) contain the entire agreement of the parties;

24 (2) be provided in writing to the borrower for review before signing;

25 (3) be printed in at least twelve-point type and written in the same
26 language that is used by the borrower and was used in discussions
27 between the consultant and the borrower to describe the borrower's
28 services or to negotiate the contract;

29 (4) fully disclose the exact nature of the services to be provided by
30 the consultant or anyone working in association with the consultant;

31 (5) fully disclose the total amount and terms of compensation for such
32 services;

33 (6) contain the name, business address and telephone number of the
34 consultant and the street address, if different, and facsimile number or
35 email address of the consultant where communications from the debtor may
36 be delivered;

37 (7) be dated and personally signed by the borrower and the consultant
38 and be witnessed and acknowledged by a New York notary public; and

39 (8) contain the following notice, which shall be printed in at least
40 fourteen-point boldface type, completed with the name of the Provider,
41 and located in immediate proximity to the space reserved for the
42 debtor's signature:

43 "NOTICE REQUIRED BY NEW YORK LAW

44 You may cancel this contract, without any penalty or obligation, at any
45 time before midnight of

46 (fifth business day after execution).

47 (Name of consultant) (the "Consultant") or anyone working for
48 the Consultant may not take any money from you or ask you for money
49 until the consultant has completely finished doing everything this
50 Contract says the Consultant will do.

51 You should consider contacting your student loan servicer before signing
52 any legal document concerning your student loan. In addition, you may
53 want to visit the New York State Department of Financial Services'
54 student lending resource center at www.dfs.ny.gov/studentprotection. The
55 law requires that this contract contain the entire agreement between you

1 and the Provider. You should not rely upon any other written or oral
2 agreement or promise."

3 The Provider shall accurately enter the date on which the right to
4 cancel ends.

5 (b) (1) The borrower has the right to cancel, without any penalty or
6 obligation, any contract with a consultant until midnight of the fifth
7 business day following the day on which the consultant and the borrower
8 sign a consulting contract. Cancellation occurs when the borrower, or a
9 representative of the borrower, either delivers written notice of

46 § 705. Penalties and other provisions. (a) If the superintendent
47 finds, after notice and hearing, that a consultant has violated any
48 provision of this article, the superintendent may: (1) make null and
49 void any agreement between the borrower and the consultant; and (2)
50 impose a civil penalty of not more than ten thousand dollars for each

Every approved management plan shall set forth requirements and standards relating to stocking, cutting, forest management access, and any specified use of the eligible tract other than for the production of a merchantable forest crop which is desired by the owner and compatible with or supportive of the continuing production of a merchantable forest crop. Such plan shall include provisions accommodating endangered and threatened animals and plants. Such plan must be prepared by or under the direct supervision of a department approved forester who may be the owner or an agent of the owner, including an industrial forester or a cooperating consultant forester~~[-or~~

~~(ii) participation in a forest certification program (such as Forest Stewardship Council certification, Sustainable Forestry Initiative, American Tree Farm Program, etc.) recognized in the regulations of the department]~~.

(b) "Commitment" shall mean a declaration to the ~~[department]~~ assessor and county clerk made on an annual basis by the owner of a certified eligible tract committing such tract to continued forest crop production for the next succeeding ten years under an approved management plan. The document on which the commitment is made shall be known as the "commitment form" and shall include the "verification of continued eligibility" as defined by paragraph (i) of this subdivision. A commitment form without a properly completed verification of continued eligibility shall have no legal effect.

(c) "Cooperating consultant forester" shall mean a qualified forester who, or a qualified forestry consultant firm which, has entered into an agreement with the department under the New York state cooperating consultant foresters program pursuant to section 9-0713 of the environmental conservation law.

(d) "Department" shall mean the department of environmental conservation.

(e) "Eligible tract" shall mean a tract of privately owned forest land of at least fifty contiguous acres, exclusive of any portion thereof not devoted to the production of forest crops. Lands divided by federal, state, county or town roads, easements or rights-of-way, or energy transmission corridors or similar facilities will be considered contiguous for purposes of this section, unless vehicular access for forest management purposes is precluded. Lands from which a merchantable forest crop

1 has been cut or removed within three years prior to the time of applica-
2 tion for certification under this section will be ineligible unless such
3 cutting or removal was accomplished under a forest management program
4 designed to provide for the continuing production of merchantable forest
5 crops as determined by the state forester or his or her designee.

6 (f) "Forest land" shall mean land exclusively devoted to and suitable
7 for forest crop production through natural regeneration or through fore-
8 station and shall be stocked with a stand of forest trees sufficient to

35 the forest land exemption entered on the assessment roll pursuant to
36 subdivision four of this section for the current year and the prior
37 years in which such an exemption was granted, utilizing the applicable
38 tax rate for the current year and for such prior years, not to exceed a
39 total of ten years.

40 (e) The penalty imposed under paragraph (c) of this subdivision appli-
41 cable to converted land which constitutes only a portion of a certified
42 eligible tract shall be twice the amount determined under paragraph (d)
43 of this subdivision. In calculating such penalty, only that portion of
44 the tract that was actually converted to a use that precludes management
45 of the land for forest crop production shall be used as the basis for
46 determining the penalty.

47 (f) A notice of violation issued under this subdivision shall be given
48 by the department to the owner and to the county treasurer of the county
49 or counties in which such tract is located, and the penalty and interest
50 charges shall be computed for each of the municipal corporations in
51 which such tract is located by such county treasurer. Upon completion of
52 the computation of the penalty and interest, the county treasurer shall
53 give notice to the owner of the amount of the penalty and interest, and
54 the amount shall be entered on the next completed tax roll of such coun-
55 ty or counties. Such penalties and interest shall be levied and
56 collected in the same manner and at the same time as other taxes are

1 imposed and levied on such roll. Upon collection of such penalties and
2 interest, such county treasurer shall pay the amounts due to each of the
3 appropriate municipal corporations.

4 (g) Upon receipt of proof satisfactory to the department that all
5 penalties[~~, stumpage taxes~~] and interest imposed by this section have
6 been fully paid or satisfied, the department shall revoke the certifi-
7 cate of [~~approval~~] eligibility issued pursuant to subdivision two of
8 this section, and notice of such revocation shall be given to the owner
9 and to the county clerk of the county or counties in which the tract is
10 located. Upon receipt of such notice of revocation, the county clerk
11 shall record the same in the books kept for the recording of deeds and
12 shall index the same in the deed index against the name of the owner of
13 the property. The county clerk shall also note on the face of the last
14 certificate of [~~approval or certified~~] eligibility and commitment form
15 previously recorded pursuant to this section the word "REVOKED" followed
16 by a reference to the liber and page where the notice of revocation is
17 recorded pursuant to this subdivision.

18 (h) The certificate of [~~approval~~] eligibility of a certified tract for
19 which no notice of violation has been issued shall be revoked without
20 penalty upon receipt of proof satisfactory to the department that nine
21 years have passed from the year of the last [~~certified~~] commitment form
22 filed with the assessor by the owner pursuant to subdivision three of
23 this section. Notice of such revocation shall be recorded and indexed
24 as provided in paragraph (g) of this subdivision.

25 (i) No fee, penalty or rollback of taxes otherwise due pursuant to
26 this section may be imposed upon the city of New York for failure to
27 comply with [~~a-certified~~] an approved management plan for an eligible
28 tract that the city acquires for watershed purposes.

29 8. (a) The owner of a certified tract shall not be subject to any
30 penalty under this section that would otherwise apply because such tract
31 or any portion thereof is converted to a use other than forest crop
32 production by virtue of: (i) an involuntary taking by eminent domain or
33 other involuntary proceeding, except a tax sale, or (ii) a voluntary
34 proceeding, providing such proceeding involves the establishment of
35 rights-of-way for public highway or energy transmission purposes wherein
36 such corridors have been established subsequent to public hearing as
37 needed in the public interest and environmentally compatible, or (iii)
38 oil, gas or mineral exploration, development or extraction activity
39 undertaken by an independent grantee pursuant to a lease or other
40 conveyance of subsurface rights recorded more than ten years prior to
41 the date of the certificate of [~~approval~~] eligibility issued by the
42 department under subdivision two of this section, or (iv) where all or a
43 substantial portion of the certified tract is destroyed or irreparably
44 damaged by reason of an act of God or a natural disaster.

45 (b) In the event the land so converted to a use other than forest crop
46 production constitutes only a portion of such tract, the assessor shall
47 apportion the assessment, and enter that portion so converted as a sepa-
48 rately assessed parcel on the appropriate portion of the assessment
49 roll. The assessor shall then adjust the forest land exemption attribut-
50 able to the portion of the tract not so converted by subtracting the
51 proportionate part of the exemption of the converted parcel.

52 (c) If the portion so converted divides the tract into two or more
53 separate parcels, such remaining parcels not so converted will remain
54 [~~certified~~] eligible under this section, regardless of size, except that
55 should any remaining parcel be no longer accessible for continued forest
56 crop production, the department shall, after notice and hearing, revoke

1 the [~~certification~~] certificate of eligibility of the inaccessible
2 parcel or parcels, and notice of such revocation shall be recorded and
3 indexed as provided in subdivision seven of this section. Such revoca-
4 tion shall not subject the owner of the tract to penalty, but the
5 exemption under this section shall no longer apply to the tract or
6 portion thereof no longer accessible.

7 (d) The owner of a certified eligible tract shall not be subject to
8 penalty under this section that would otherwise apply because the forest
9 crop on the certified eligible tract or portion is, through no fault of
10 the owner, damaged or destroyed by fire, infestation, disease, storm,
11 flood, or other natural disaster, act of God, accident, trespass or war.
12 If a merchantable forest crop is to be cut or removed in connection with
13 necessary salvage operations resulting from any such event, the owner
14 shall give notice of cutting[~~, the department shall certify the stumpage~~
15 ~~value, and stumpage tax shall be payable, collected and enforced as~~
16 ~~provided in subdivisions five and seven of this section~~]. Nothing in
17 this paragraph shall be construed to subject any person to penalty under
18 subdivision seven of this section for immediate action taken in good
19 faith in the event of an emergency.

20 9. All [~~stumpage tax,~~] penalties and interest charges thereon
21 collected pursuant to subdivisions five, six and seven of this section
22 shall be apportioned to the applicable municipal corporations in which
23 such tract is situated.

24 10. (a) Management plans approved pursuant to this section shall not
25 be deemed to authorize or permit any practice or activity prohibited,
26 restricted or requiring further approval under the environmental conser-
27 vation law, or any other general or special law of the state, or any
28 lawful rule or regulation duly promulgated thereunder.

29 (b) No otherwise eligible tract, or portion thereof, shall be deemed
30 to be ineligible for certification or qualification under this section,
31 and no certificate of [~~approval~~] eligibility shall be revoked or penalty
32 imposed, solely on the ground that any such law, rule or regulation
33 partially restricts or requires further approval for forest crop
34 production practices or activities on such tract or portion.

35 11. The owner of an eligible tract certified under an approved manage-
36 ment plan under this section as of March first, two thousand nineteen
37 may withdraw such eligible tract from commitment, without penalty or
38 obligation to follow the approved management plan for the remaining
39 commitment term, until February twenty-eighth, two thousand twenty. The
40 owner of an eligible tract certified under an approved management plan
41 under this section may withdraw such eligible tract from commitment,
42 without penalty, upon commitment to sustainable forest management under
43 a forest certification program of such eligible tract or implementing an
44 approved forest management practice on a qualifying portion under
45 section four hundred eighty-b of this title at any time.

46 12. Notwithstanding any law to the contrary, in the event that lands
47 subject to an approved management plan and a certificate of eligibility
48 pursuant to this section of law are:

49 (a) transferred or sold to family members of the landowner, as defined
50 by regulations of the department, such lands may continue to be eligible
51 to participate in the program and all management obligations of such
52 lands may also be transferred if such new landowner desires to continue
53 participation in such program. If such landowner does not want to
54 continue to participate in the program authorized by this section, such
55 lands shall no longer be eligible for the program and such landowner
56 shall be responsible for the remaining nine years of the commitment

1 including all management obligations or such new landowner may apply for
2 a program pursuant to section four hundred eighty-b of this title at any
3 time.

4 (b) transferred or sold to non-family members of the landowner, such
5 lands shall no longer be eligible for participation in the program.
6 However, such new landowner shall be responsible for the remaining nine
7 years of the commitment including all management obligations or such new
8 landowner may apply, if desired, under section four hundred eighty-b of
9 this title.

10 (c) the subject of an application for eligibility under a forest
11 management practice plan pursuant to section four hundred eighty-b of
12 this title after the sale or transfer of land as listed in paragraphs
13 (a) and (b) of this subdivision, such landowners shall not be required
14 to conduct a qualifying management practice to be eligible for the
15 program authorized pursuant to section four hundred eighty-b of this
16 title.

17 13. (a) Any county, town or school district in which the total
18 assessed value exempted by this section and sections four hundred eighty
19 and four hundred eighty-b of this title represents one percent or more
20 of the total taxable assessed value on the final tax roll, as computed
21 and verified by the department of taxation and finance, shall be eligi-
22 ble to receive forestry exemption assistance.

23 (b)(i) The county treasurer of any eligible county shall annually
24 submit to the department of taxation and finance a list of any changes
25 to the assessed value, taxable status or acreage of all lands made
26 subsequent to the filing of those assessments rolls upon which county
27 taxes are extended, and the county tax rate and town tax rate extended
28 against any parcel receiving one of those exemptions. Such list shall
29 include a statement of the total taxable assessed value, both before and
30 after application of the exemption, of the county and of each listed
31 town and parcel.

32 (ii) The business manager of any eligible school district shall annu-
33 ally submit to the department of taxation and finance a list of any
34 changes to the assessed value, taxable status or acreage of all lands
35 made subsequent to the filing of those assessment rolls upon which
36 school taxes are extended, and the school tax rate extended against any
37 parcel receiving one of those exemptions. Such list shall include a
38 statement of the total taxable assessed value, both before and after
39 application of the exemption, of the school district and of each listed
40 parcel.

41 (iii) Lists prepared pursuant to this paragraph shall be filed with
42 the department of taxation and finance within thirty days of the levy of
43 taxes each year. In the event that a tax roll or final roll is revised,
44 corrected, or altered for any reason within thirty-six months of the
45 filing of such list, a county, town or school district shall so notify
46 the department of taxation and finance. The department of taxation and
47 finance shall thereupon increase or decrease the next payment of such
48 assistance to the affected county, town and/or school district to the
49 extent the prior payment was too low or too high in light of such
50 revision, correction, or alteration.

51 (c) The department of taxation and finance shall annually compute the
52 amount of forestry exemption assistance payable to or for the benefit of
53 a county, town or school district.

54 (d) (i) Subject to appropriation, the amount of forestry exemption
55 assistance paid to a county, town or school district pursuant to this
56 subdivision in any year shall equal the tax exempt value that exceeds

1 one percent of the reduced total taxable assessed value, as computed by
2 paragraph (a) of this subdivision, multiplied by the applicable tax
3 rate, as determined by the commissioner of taxation and finance, in such
4 town, county, or school district.

5 (ii) Any forestry exemption assistance provided to a county or school
6 district under this subdivision in any year shall be reduced by the
7 amount of small government assistance paid to such county or school
8 district in the current state fiscal year, and, in the case of a town,
9 shall be reduced by the amount of small government assistance paid to
10 such town in state fiscal year two thousand four-two thousand five
11 pursuant to chapter fifty of the laws of two thousand four, and shall be
12 further reduced by the amount that was added to the base level grant for
13 such town pursuant to subparagraph eight of paragraph b of subdivision
14 ten of section fifty-four of the state finance law as added by section
15 two of part M of chapter fifty-six of the laws of two thousand five, as
16 reported to the department of taxation and finance by the division of
17 the budget.

18 (e) The department of taxation and finance shall annually certify to
19 the state comptroller the amount of forestry exemption assistance paya-
20 ble pursuant to this subdivision, and shall mail a copy of such certif-
21 ication to the county treasurer of each county and business manager of
22 each school district containing eligible private forest tracts. Such
23 forestry exemption assistance shall be paid on audit and warrant of the
24 comptroller out of monies appropriated by the legislature, provided that
25 if an appropriation does not fully reimburse all impacted towns, coun-
26 ties and school districts, the amount shall be provided on a pro rata
27 basis to each eligible town, county and school district.

28 § 4. The real property tax law is amended by adding a new section
29 480-b to read as follows:

30 § 480-b. Taxation of forest land under a forest practice program or
31 forest certification program. 1. As used in this section:

32 (a) "Agricultural land" shall mean land that has received an agricul-
33 tural assessment pursuant to section three hundred five or section three
34 hundred six of the agriculture and markets law, provided that farm wood-
35 land that has received an agricultural assessment in each of the previ-
36 ous five years may qualify for the exemption provided by this section.
37 Farm woodland that qualifies for and receives this exemption shall not
38 also receive an agricultural assessment.

39 (b) "Commitment" shall mean a declaration to the assessor and county
40 clerk made on an annual basis by the owner of a certified eligible tract
41 either (i) committing such tract to sustainable forest management for
42 the next succeeding ten years under a forest certification program, or
43 (ii) committing such tract to sustainable forestry and open space pres-
44 ervation for the next succeeding ten years under a forest management
45 practice plan. The commitment made shall be on a commitment form
46 prescribed by the department, and shall include the verification of
47 continued eligibility. A commitment form without a properly completed
48 verification of continued eligibility shall be of no legal effect.

49 (c) "Certificate of eligibility" shall mean a certificate issued by
50 the department and sent to the landowner of an eligible tract that
51 demonstrates such tract meets all requirements of a forest certification
52 program or forest management practice plan in which it is enrolled.

53 (d) "Department" shall mean the department of environmental conserva-
54 tion.

55 (e) "Eligible tract" shall mean a tract of privately owned land of at
56 least twenty-five contiguous acres, exclusive of any portion thereof not

1 devoted to forest or other open space, as defined in regulations, of
2 which at least half of the acres must be forest land. Lands divided by
3 federal, state, county or town roads, easements or rights-of-way, or
4 energy transmission corridors or similar facilities will be considered
5 contiguous for purposes of this section, unless vehicular access for
6 forest management purposes is precluded. Lands from which a merchantable
7 forest crop, as defined in section four hundred eighty-a of this title,
8 has been cut or removed within three years prior to the time of applica-
9 tion for certification under this section will be ineligible unless such
10 cutting or removal was accomplished under a forest management practice
11 plan designed to provide for sustainable forestry as determined by the
12 state forester or his or her designee. Agricultural land is not eligi-
13 ble for enrollment under this program.

14 (f) "Forest land" shall mean land suitable for forest crop production
15 through natural regeneration or through forestation and shall be stocked
16 with a stand of forest trees sufficient to produce a merchantable forest
17 crop in the future.

18 (g) "Forest certification program" shall mean a forest certification
19 program, selected by the owner, and which is administered by a qualified
20 third party to ensure sustainable forest management is practiced on the
21 land, as specified in regulations promulgated by the department.

22 (h) "Qualifying forest management practice" shall mean any cutting of
23 trees related to commercial harvesting including regeneration harvest-
24 ing; timber stand improvement including weeding, thinning, or crop tree
25 release; site preparation for planting; invasive and/or competing vege-
26 tation control; riparian buffer establishment or enhancement; or other
27 activities as specified in regulations promulgated by the department.

28 (i) "Forest management practice plan" shall mean a plan approved by
29 the department for one or more qualifying forest management practice to
30 be conducted on a combined total of at least ten acres of forest land of
31 an eligible tract which shall set forth requirements and standards as
32 defined in regulations to ensure and enhance the future productivity and
33 sustainability of the forest treated, and ensure successful regeneration
34 of desirable species, when planned. Such plan must be prepared by or
35 under the direct supervision of a department approved forester as speci-
36 fied in regulations promulgated by the department.

37 (j) "Verification of continued eligibility" shall mean a portion of
38 the commitment form prepared and signed by the landowner which certifies
39 that such landowner continues to satisfy all conditions and requirements
40 of his or her initial enrollment under this section.

41 2. (a) An owner of an eligible tract may apply to the department for a
42 certificate of eligibility under a forest management practice plan or
43 forest certification program pursuant to this section on forms
44 prescribed by the department. If the department finds that such tract
45 is an eligible tract, it shall forward a certificate of eligibility to
46 the owner thereof.

47 (b) The department shall, after public hearings, adopt and promulgate
48 rules and regulations necessary for the implementation of this section,
49 including specifying forest management practices which would qualify a
50 tract for certification.

51 (c) Any tract certified pursuant to this subdivision shall be subject
52 to the provisions of this section. The obligations of this section shall
53 devolve upon and the benefits inure to the owner, his or her heirs,
54 successors and assigns.

55 3. (a) To qualify for a forest land exemption under this section the
56 owner of a certified eligible tract shall:

(i) file the certificate of eligibility in the office of the clerk of the county or counties in which such tract is situated. Such certificate shall specify that the tract described therein is committed to either (A) sustainable forest management under a forest certification program or (B) sustainable forestry and open space preservation under an approved forest management practice plan, whichever is applicable, for an initial period of ten years. Upon receipt of such certificate, the county clerk shall record the same in the books kept for the recording of deeds and shall index the same in the deed index against the name of the owner of the property; and (ii) prior to the taxable status date for the first assessment roll upon which such exemption is sought, file an initial application for exemption with the appropriate assessor on forms prescribed by the commissioner. Such application must be accompanied by a certificate of eligibility issued by the department and the commitment form; (iii) prior to the taxable status date for each subsequent assessment roll upon which such exemption is sought, file with the appropriate assessor the commitment form for such tract to either (A) sustainable forest management under a forest certification program or (B) sustainable forestry and open space protection under an approved forest management practice plan, whichever is applicable, for the next succeeding ten years; and (iv) conduct an approved initial qualifying forest management practice on a combined total of at least ten acres of forest land of an eligible tract.

(b) If the requirements of this section are met, the assessor shall approve the application and such eligible tract shall be exempt from taxation pursuant to subdivision four of this section to be effective as of the first taxable status date occurring subsequent to such approval, and shall continue to be so exempt thereafter upon receipt by the assessor of a commitment form filed in accordance with subparagraph (iii) of paragraph (a) of this subdivision and so long as the certification of the eligible tract has not been revoked by the department.

(c) Failure on the part of the owner to file the commitment form in any year following initial certification will result in the termination of the forest land exemption under this section applicable to the property for that and each succeeding taxable years. Failure to file a commitment form will not constitute a conversion of the tract or breach of the commitment, pursuant to subdivision seven of this section, and the commitment of the property to either (i) sustainable forest management under a forest certification program or (ii) sustainable forestry or open space preservation through the approved forest management practice plan option, whichever is applicable, shall remain in force for the next succeeding nine years following the last taxable year for which a commitment form was filed.

(d) Following failure to file a commitment form in one or more years, in order to obtain a forest land exemption under this section, an owner of a certified tract may submit a commitment form to the assessor before the taxable status date in any subsequent year, except that a new application under paragraph (a) of subdivision two of this section and subparagraph (i) of paragraph (a) of this subdivision also shall be required if more than five years have elapsed since the owner's last commitment form and verification of continued eligibility was filed. Such new application also shall be required whenever, during the preceding year, the approved forest management practice plan has been amended with respect to the acreage of land committed to sustainable forestry, under a forest certification program or sustainable forestry and open space preservation under this section.

1 4. (a) Certified eligible tracts approved for exemption under this
2 section shall be exempt from taxation to the extent of (i) seventy per
3 centum of the assessed valuation thereof in the case of an eligible
4 tract enrolled under a department recognized forest certification
5 program, or (ii) forty per centum of the assessed valuation thereof in
6 the case of an eligible tract enrolled through a forest management prac-
7 tice plan.

8 (b) The assessed value of the exemption granted pursuant to this
9 section shall be entered by the assessor on the assessment roll in such
10 manner as shall be prescribed by the commissioner.

11 5. (a) For lands eligible pursuant to a forest management practice
12 plan, whenever any forest management practice on any certified eligible
13 tract is proposed during the period of commitment pursuant to subdivi-
14 sion three of this section, the owner shall submit a forest management
15 practice plan to the department for approval no less than thirty days
16 prior to the anticipated commencement of such plan and in a manner and
17 upon such form as may be prescribed by the department.

18 (b) Notwithstanding the foregoing provisions of this subdivision and
19 the provisions of subdivision six of this section, the owner of any land
20 certified under this section may annually cut, in accordance with sound
21 forestry practices, not more than ten standard cords or the equivalent
22 for such owner's own use, without notice.

23 6. Any qualifying forest management practice under this subdivision
24 must be conducted within two years from the date of department approval
25 of the forest management practice plan.

26 7. (a) The department shall, after notice and hearing, issue a notice
27 of violation of this section for any certified tract whenever it finds
28 that:

29 (i) any tract or portion thereof is converted to a use which precludes
30 management of the land for sustainable forestry or open space; or

31 (ii) the owner fails to submit a forest management practice plan to
32 the department for approval prior to commencing such practice; or

33 (iii) the owner fails to maintain their participation in a department
34 recognized forest certification program during the commitment period; or

35 (iv) the owner fails to carry out a forest management practice in
36 accordance with the specifications of the qualifying forest management
37 practice plan.

38 (b) Notwithstanding the finding of an occurrence described by subpara-
39 graph (ii), (iii) or (iv) of paragraph (a) of this subdivision, the
40 department, upon prior notice to the appropriate assessor, may determine
41 that a violation has not occurred if the failure to comply was due to
42 reasons beyond the control of the owner and such failure can be
43 corrected forthwith without significant effect on the overall purpose of
44 the commitment.

45 (c) The owner of such tract, following the issuance of such notice by
46 the department for one or more of the reasons set forth in paragraph (a)
47 of this subdivision, shall be subject to a penalty as provided in para-
48 graph (d) or (e) of this subdivision, whichever applies. Penalties
49 imposed by this section shall be subject to interest charges at the rate
50 established pursuant to section nine hundred twenty-four-a of this chap-
51 ter for each applicable year. Such interest shall accrue in the year
52 with reference to which a penalty, or portion thereof, is attributed.

53 (d) Except as otherwise provided in paragraph (e) of this subdivision:

54 (i) the penalty imposed under paragraph (c) of this subdivision for a
55 parcel that has been enrolled under this section for less than ten years
56 shall be computed by multiplying by two and one-half the amount of taxes

1 that would have been levied on the forest land exemption entered on the
2 assessment roll pursuant to subdivision four of this section for the
3 current year and any prior years in which such an exemption was granted,
4 utilizing the applicable tax rate for the current year and for such
5 prior years.

6 (ii) the penalty imposed under paragraph (c) of this subdivision for a
7 parcel that has been enrolled under this section for a minimum of ten
8 years but less than twenty years shall be computed by multiplying by one
9 and one-half the amount of taxes that would have been levied on the
10 forest land exemption entered on the assessment roll pursuant to subdivi-
11 vision four of this section for the current year and prior years in
12 which such an exemption was granted, utilizing the applicable tax rate
13 for the current year and for such prior years, not to exceed a total of
14 ten years.

15 (iii) the penalty imposed under paragraph (c) of this subdivision for
16 a parcel that has been enrolled under this section for a minimum of
17 twenty years shall be the amount of taxes that would have been levied on
18 the forest land exemption entered on the assessment roll pursuant to
19 subdivision four of this section for the current year and prior years in
20 which such an exemption was granted, utilizing the applicable tax rate
21 for the current year and for such prior years, not to exceed a total of
22 ten years.

23 (e) The penalty imposed under paragraph (c) of this subdivision appli-
24 cable to converted land which constitutes only a portion of a certified
25 eligible tract shall be twice the amount determined under paragraph (d)
26 of this subdivision. In calculating such penalty, only that portion of
27 the tract that was actually converted to a use that precludes either (i)
28 sustainable forest management under a forest certification program or
29 (ii) management of the land for sustainable forest management and open
30 space, shall be used as the basis for determining the penalty, unless
31 the remaining portion no longer meets the minimum acreage requirements
32 of paragraph (e) of subdivision one of this section, in which case the
33 entire tract shall be deemed ineligible and subject to revocation and
34 penalties.

35 (f) A notice of violation issued under this subdivision shall be given
36 by the department to the owner and to the county treasurer of the county
37 or counties in which such tract is located, and the penalty and interest
38 charges shall be computed for each of the municipal corporations in
39 which such tract is located by such county treasurer. Upon completion of
40 the computation of the penalty and interest, the county treasurer shall
41 give notice to the owner of the amount of the penalty and interest, and
42 the amount shall be entered on the next completed tax roll of such coun-
43 ty or counties. Such penalties and interest shall be levied and
44 collected in the same manner and at the same time as other taxes are
45 imposed and levied on such roll. Upon collection of such penalties and
46 interest, such county treasurer shall pay the amounts due to each of the
47 appropriate municipal corporations.

48 (g) Upon a finding of a violation, the department shall revoke the
49 certificate of eligibility issued pursuant to subdivision two of this
50 section, and notice of such revocation shall be given to the owner and
51 to the county clerk of the county or counties in which the tract is
52 located. Upon receipt of such notice of revocation, the county clerk
53 shall record the same in the books kept for the recording of deeds and
54 shall index the same in the deed index against the name of the owner of
55 the property. The county clerk shall also note on the face of the last

24 forest incentive program to landowners for the costs associated with
25 sound, scientifically based forest management practices on eligible
26 land. The program shall require a non-state match. The department may
27 contract with an independent third party organization to administer such
28 state assistance program, provided that not more than ten percent of all
29 funds may be made available to carry out the program for each fiscal
30 year for program administration and technical assistance under such

28 9. When a municipality develops and implements remediation to address
29 a drinking water contamination site, determined pursuant to subdivision
30 four of this section, and the plan is approved by the department, in
31 conjunction with the department of health, which is owned or has been
32 operated by such municipality or when the department, in conjunction
33 with the department of health, pursuant to an agreement with a munici-
34 pality, develops and implements such remediation, the commissioner
35 shall, in the name of the state, agree in such agreement to provide from
36 the drinking water response [account] program, within the limitations of
37 appropriations therefor, seventy-five percent of the eligible design and
38 construction costs of such program for which such municipality is liable
39 solely because of its ownership and/or operation of such site and which
40 are not recovered from or reimbursed or paid by a responsible party or
41 the federal government.

42 11. Moneys for actions taken or to be taken by the department, the
43 department of health or any other state agency pursuant to this title
44 shall be payable directly to such agencies from the drinking water
45 response [account] program pursuant to section ninety-seven-b of the
46 state finance law.

47 e. The expense of any such mitigation by the department or the depart-
48 ment of health shall be paid by the drinking water response [account]
49 program, but may be recovered from any responsible person in any action
50 or proceeding brought pursuant to the state finance law, this title,
51 other state or federal statute, or common law if the person so author-
52 ized in writing is an employee, agent, consultant, or contractor of a
53 responsible person acting at the direction of the department, then the
54 expense of any such sampling and analysis shall be paid by the responsi-
55 ble person.

§ 7. The section heading and subdivisions 2 and 3 of section 27-1207 of the environmental conservation law, as added by section 4 of part T of chapter 57 of the laws of 2017, are amended and a new subdivision 5 is added to read as follows:

Use and reporting of the solid waste mitigation ~~[account]~~ program and the drinking water response ~~[account]~~ program.

2. The solid waste mitigation ~~[account]~~ program shall be made available to the department and the department of health, as applicable, for the following purposes:

- a. enumeration and assessment of solid waste sites;
- b. investigation and environmental characterization of solid waste sites, including environmental sampling;
- c. mitigation and remediation of solid waste sites;
- d. monitoring of solid waste sites; and
- e. administration and enforcement of the requirements of section 27-1203 of this title.

3. The drinking water response ~~[account]~~ program shall be made available to the department and the department of health, as applicable, for the following purposes:

- a. mitigation of drinking water contamination;
- b. investigation of drinking water contamination;
- c. remediation of drinking water contamination; and
- d. administration and enforcement of the requirements of this title except the provisions of section 27-1203.

5. All moneys recovered pursuant to title twelve of article twenty-seven of this chapter shall be deposited into the capital projects fund (30000).

§ 8. This act shall take effect immediately.

PART BB

Section 1. Approximately 40 percent of the food produced in the United States today goes uneaten. Much of this organic waste is disposed of in solid waste landfills, where its decomposition accounts for over 15 percent of our nation's emissions of methane, a potent greenhouse gas. Meanwhile, an estimated 2.5 million New Yorkers are facing hunger and food insecurity. Recognizing the importance of food scraps on our environment, economy, and the health of New Yorkers, this act establishes a food scraps hierarchy for the state of New York. The first tier of the hierarchy is source reduction, reducing the volume of surplus food generated. The second tier is recovery, feeding wholesome food to hungry people. Third is repurposing, feeding animals. Fourth is recycling, processing any leftover food such as by composting or anaerobic digestion to create a nutrient-rich soil amendment. This legislation is designed to address each tier of the hierarchy by: encouraging the prevention of food scraps generation by commercial generators and residents; directing the recovery of excess wholesome food from high-volume commercial food scraps generators; and ensuring that a significant portion of inedible food scraps from high-volume food scraps generators is managed in a sustainable manner, and does not end up being sent to landfills or incinerators. In addition, the state is supporting the recovery of wholesome food by providing grants from the environmental protection fund to increase capacity of food banks, conduct food scraps audits of high-volume generators of food scraps, support implementation of pollution prevention projects identified by such audits, and expand capacity of generators and municipalities to donate and recycle food.

§ 2. Article 27 of the environmental conservation law is amended by adding a new title 22 to read as follows:

TITLE 22

FOOD RECOVERY AND RECYCLING

Section 27-2201. Definitions.

27-2203. Designated food scraps generator responsibilities.

27-2205. Transporter responsibilities.

27-2207. Transfer facility or other intermediary responsibilities.

27-2209. Food scraps disposal prohibition.

27-2211. Department responsibilities.

27-2213. Regulations.

27-2215. Exclusions.

27-2217. Preemption and severability.

§ 27-2201. Definitions.

1. "Designated food scraps generator" means a person who generates at a single location an annual average of two tons per week or more of excess food and food scraps, based on a methodology established by the department pursuant to regulations, including, but not limited to, supermarkets, restaurants, higher educational institutions, hotels, food processors, correctional facilities, sports or entertainment venues, and hospitals or other health care facilities. For a location with multiple independent food service businesses, such as a mall or college campus, the entity responsible for contracting with a transporter for solid waste transportation services is responsible for managing excess food and food scraps from the independent businesses for the purposes of determining if the generator is a designated food scraps generator.

2. "Excess food" means wholesome food that is not sold or used by its generator.

3. "Food scraps" means inedible solid or liquid food, trimmings from the preparation of food, food-soiled paper, and excess food that is not donated. Food scraps shall not include used cooking oil, yellow grease or food from residential sources or any food which is subject to a recall or seizure due to the presence of pathogens, including but not limited to: Listeria Monocytogenes, confirmed Clostridium Botulinum, E. coli 0157:H7 and all salmonella in ready-to-eat foods.

4. "Incinerator" shall have the same meaning as such term is defined in section 27-0707 of this article.

5. "Organics recycler" means a facility that recycles food scraps through use as animal feed or a feed ingredient, rendering, land application, composting, aerobic digestion, anaerobic digestion, or fermentation. Animal scraps, food soiled paper, and post-consumer food scraps are prohibited for use as animal feed or as a feed ingredient. The proportion of the product created from food scraps by a composting or digestion facility, including a wastewater treatment plant that operates a digestion facility, or other treatment system, must be used in a beneficial manner as a soil amendment and shall not be disposed of or incinerated. The department may designate other techniques or technologies by regulation, provided they do not include incineration or landfilling. If wastewater treatment plants recycling food scraps can demonstrate to the department's satisfaction that beneficial use of biosolids is not available or not economically feasible, the biosolids may be disposed of in a landfill or incinerated at a facility authorized to accept those wastes.

6. "Person" means any individual, business entity, partnership, company, corporation, not-for-profit corporation, association, governmental

1 entity, public benefit corporation, public authority, firm, organization
2 or any other group of individuals, or any officer or employee or agent
3 thereof.

4 7. "Single location" means contiguous property under common ownership,
5 which may include one or more buildings.

6 8. "Transfer facility" means a facility that receives solid waste for
7 the purpose of subsequent transfer to another facility for further proc-
8 essing, treatment, transfer, or disposal.

9 § 27-2203. Designated food scraps generator responsibilities.

10 1. Beginning January first, two thousand twenty-one:

11 (a) all designated food scraps generators shall separate their excess
12 food for donation for human consumption to the maximum extent practica-
13 ble, and in accordance with applicable laws, rules and regulations
14 related to food donation; and

15 (b) except as provided in paragraph (c) of this subdivision, each
16 designated food scraps generator that is within a forty-mile radius of
17 an organics recycler regulated by the department, to the extent that the
18 recycler has capacity to accept a substantial portion or all of the
19 generator's food scraps as determined by the department on a yearly
20 basis, shall:

21 (i) separate its remaining food scraps from other solid waste;

22 (ii) ensure proper storage for food scraps collection on site which
23 shall preclude such materials from becoming odorous or attracting
24 vectors such as a container that has a lid and a latch that keeps the
25 lid closed, is resistant to tampering by rodents or other wildlife and
26 has sufficient capacity;

27 (iii) have information available and provide training for employees
28 concerning the proper methods to separate and store food scraps; and

29 (iv) obtain a transporter that will deliver its food scraps to an
30 organics recycler, either directly or through an intermediary, self-haul
31 its food scraps to an organics recycler, either directly or through an
32 intermediary, or provide for organics recycling on-site.

33 (c) The provisions of paragraph (b) of this subdivision shall not
34 apply to any designated food scraps generator that has all of its solid
35 waste processed in a mixed solid waste composting or other mixed solid
36 waste organics recycling facility.

37 2. All designated food scraps generators shall submit an annual report
38 to the department on or before March first, two thousand twenty-two, and
39 annually thereafter, in an electronic format. The annual report must
40 summarize the amount of excess food and food scraps generated, the
41 amount of excess food donated, an outline of its efforts to establish a
42 relationship with a food recovery organization, the amount of food
43 scraps recycled, the organics recycler or recyclers and associated
44 transporters used, and any other information as required by the depart-
45 ment.

46 3. A designated food scraps generator may petition the department for
47 a temporary waiver from some or all of the requirements of this title.
48 The petition must include evidence of undue hardship based on: (a) the
49 organics recycler located within a forty-mile radius of the designated
50 food scraps generator not having sufficient capacity; or (b) the unique
51 circumstances of the generator.

52 The department shall issue a waiver from the recycling requirements of
53 this section pursuant to paragraph (b) of this subdivision if the desig-
54 nated food scrap generator demonstrates that the cost of recycling food
55 scraps is more than the cost of disposing of or incinerating solid waste
56 by providing estimates from two disposal facilities, three haulers, and

1 two recyclers that are representative of the costs that would be appli-
2 cable to the generator under normal circumstances. A waiver shall be no
3 longer than one year in duration; provided, however, the department may
4 renew such waiver.

5 § 27-2205. Transporter responsibilities.

6 1. Any transporter that collects source-separated food scraps for
7 recycling from a designated food scraps generator shall:

8 (a) deliver collected food scraps to a transfer facility or other
9 intermediary that will deliver such food scraps to an organics recycler;
10 or

11 (b) deliver collected food scraps directly to an organics recycler.

12 2. Any transporter that collects source-separated food scraps from a
13 designated food scraps generator shall not commingle the food scraps
14 with any other solid waste unless such waste can be processed by an
15 organics recycler.

16 § 27-2207. Transfer facility or other intermediary responsibilities.

17 Any transfer facility or other intermediary that receives source-sepa-
18 rated food scraps from a designated food scraps generator must ensure
19 that the food scraps are taken to an organics recycler. No transfer
20 facility or other intermediary may commingle the food scraps with any
21 other solid waste unless such waste can be processed by an organics
22 recycler.

23 § 27-2209. Food scraps disposal prohibition.

24 No incinerator or landfill shall knowingly accept or commingle with
25 solid waste source-separated food scraps from designated food scraps
26 generators required to send food scraps to an organics recycler as
27 outlined under section 27-2203 of this title, either directly or from an
28 intermediary, after January first, two thousand twenty-one, unless the
29 designated food scraps generator has received a temporary waiver under
30 subdivision three of section 27-2203 of this title.

31 § 27-2211. Department responsibilities.

32 1. The department shall publish on its website a list of all desig-
33 nated food scraps generators, organics recyclers, food recovery organ-
34 izations, and all transporters that manage source-separated food scraps.

35 2. No later than June first, two thousand twenty, the department shall
36 assess the capacity of organic recyclers and notify designated food
37 scraps generators if they are required to comply with the provisions of
38 paragraph (b) of subdivision one of section 27-2203 of this title.

39 3. The department shall develop and make available educational materi-
40 als to assist designated food scraps generators with compliance with
41 this title. The department shall also develop education materials on
42 food waste minimization and encourage municipalities to disseminate
43 these materials both on their municipal websites and in any relevant
44 future mailings to their residents as they may distribute.

45 § 27-2213. Regulations.

46 The department shall promulgate rules and regulations necessary to
47 implement the provisions of this title. At a minimum, the department
48 shall promulgate rules and regulations that set forth the methodology
49 the department will use to determine who is a designated food scraps
50 generator, after consulting with industry representatives, and what
51 process a designated generator must follow to dispute such determi-
52 nation, the waiver process, and how designated food scraps generators
53 shall comply with the provisions of paragraph (a) and subparagraph (i)
54 of paragraph (b) of subdivision one of section 27-2203 of this title.

55 § 27-2215. Exclusions.

1 1. This title shall not apply to any designated food scraps generators
2 located in a city with a population of one million or more which has a
3 local law, ordinance or regulation in place which requires the diversion
4 of excess food and food scraps from disposal.

5 2. This title does not apply to elementary and secondary schools.
6 § 27-2217. Preemption and severability.

7 1. Any provision of any local law or ordinance, or any regulation
8 promulgated thereto, governing the recycling of food scraps shall upon
9 the effective date of this title be preempted, except in a city with a
10 population of one million or more. However, local laws or ordinances,
11 or parts thereof, affecting the recycling of food scraps that include
12 generators not covered by this title shall not be preempted.

13 2. The provisions of this title shall be severable and if any portion
14 thereof or the applicability thereof to any person or circumstances is
15 held invalid, the remainder of this title and the application thereof
16 shall not be affected thereby.

17 § 3. This act shall take effect immediately.

19 Section 1. Subdivisions 10 and 11 of section 57-0107 of the environ-

40 112 to Horse Block Road (County Route 16); thence eastward along the
41 northerly boundary of County Route 16 to Maine Avenue; thence northward
42 along the westerly boundary of Maine Avenue to Fire Avenue; thence east-
43 ward along the northerly boundary of Fire Avenue to John Roe Smith
44 Avenue; thence southward along the easterly boundary of John Roe Smith
45 Avenue to Jeff Street; thence eastward along the northerly boundary of
46 Jeff Street to Hagerman Avenue; thence southward along the easterly
47 boundary of Hagerman Avenue to the Long Island Expressway (Route 495);
48 thence eastward along the northerly boundary of Route 495 to the wester-
49 ly side of Yaphank Avenue (County Road 21); thence southward along the
50 westerly side of Yaphank Avenue to the south side of the Long Island
51 Expressway (Route 495); thence eastward along the southerly side of the
52 Long Island Expressway (Route 495) to the easterly side of Yaphank
53 Avenue; thence southward along the easterly side of Yaphank Avenue,
54 crossing Sunrise Highway (Route 27) to the south side of Montauk Highway

1 (County Road 80); thence southwestward along the south side of Montauk
2 Highway (County Road 80) to South Country Road; thence southward along
3 the easterly side of South Country Road to Fireplace Neck Road; thence
4 southward along the easterly side of Fireplace Neck Road to Beaver Dam
5 Road; thence eastward along the northerly side of Beaver Dam Road to the

7 States known as Wertheim National Wildlife Refuge (the "Refuge"); thence
8 generally westerly and southerly to the waters of Bellport Bay; thence
9 generally easterly across the Bay and northerly along the easterly bound-

11 any lands which may become part of the Refuge in the future, to the east
12 side of the southern terminus of Smith Road; thence northward along the

15 eastward, northward and westward in a counter-clockwise direction along
16 the southern, eastern and northern boundaries of that property to the

19 side of Merrick Road to the easterly side of Surrey Circle and the
20 southwest corner of the property identified as District 200, Section

43 gross revenues from intrastate utility operations in excess of \$500,000
44 in the preceding calendar year, and the total amount which may be
45 charged to any gas corporation and any electric corporation shall not
46 exceed one cent per one thousand cubic feet of gas sold and .010 cent
47 per kilowatt-hour of electricity sold by such corporations in their
48 intrastate utility operations in calendar year 2016. Such amounts shall
49 be excluded from the general assessment provisions of subdivision 2 of
50 section 18-a of the public service law. The chair of the public service
51 commission shall bill such gas and/or electric corporations for such
52 amounts on or before August 10, 2018 and such amounts shall be paid to
53 the New York state energy research and development authority on or

49 develops, or that it procures, to any public entity or authority custom-
50 er. The authority shall be entitled to fully recover its costs, includ-
51 ing its acquisition, finance, planning, contracting, capital, operating
52 and maintenance costs, from the entities that purchase renewable power,
53 energy and related attributes from the authority.

1 (b) The source of any financing and/or loans provided by the authority
2 for the purposes of this subdivision may be the proceeds of notes issued
3 pursuant to section one thousand nine-a of this title, the proceeds of
4 bonds issued pursuant to section one thousand ten of this title, or any
5 other available authority funds.

6 (c) For purposes of this subdivision, the following terms shall have
7 the meanings indicated in this paragraph unless the context indicates
8 another meaning or intent:

9 (1) "Authority customer" means an entity located in the state that
10 purchases or is under contract to purchase power or energy from the
11 authority.

12 (2) "Public entity" has the meaning ascribed to that term by subpara-
13 graph five of paragraph (b) of subdivision seventeen of this section.

14 (3) "Renewable energy resources" means solar power, wind power, hydro-
15 electric, and any other generation resource authorized by any renewable
16 energy standard adopted by the state for the purpose of implementing any
17 state clean energy standard.

18 (4) "Renewable power and energy generating projects" means projects
19 that generate power and energy by means of renewable energy resources,
20 or that store and supply power and energy generated by means of renewa-
21 ble energy resources, and include the construction, installation and/or
22 operation of ancillary facilities or equipment done in connection with
23 any such renewable power and energy generating projects, provided,
24 however, that such term shall not include the authority's Saint Lawrence
25 and Niagara hydroelectric.

26 (5) "State" means the state of New York.

27 (d) Nothing in this subdivision is intended to limit, impair or affect
28 the authority's legal authority under any other provision of this title.

29 § 2. This act shall take effect immediately.

30 § 2. Severability clause. If any clause, sentence, paragraph, subdivi-
31 sion, section or part of this act shall be adjudged by any court of
32 competent jurisdiction to be invalid, such judgment shall not affect,
33 impair, or invalidate the remainder thereof, but shall be confined in
34 its operation to the clause, sentence, paragraph, subdivision, section
35 or part thereof directly involved in the controversy in which such judg-
36 ment shall have been rendered. It is hereby declared to be the intent of
37 the legislature that this act would have been enacted even if such
38 invalid provisions had not been included herein.

39 § 3. This act shall take effect immediately provided, however, that
40 the applicable effective date of Parts A through GG of this act shall be
41 as specifically set forth in the last section of such Parts.
