AN ACT to amend the vehicle and traffic law, in relation to "I Support Music Education" distinctive plates; and to amend the state finance law, in relation to establishing the "I support music education" fund

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-ee to read as follows:
- § 404-ee. Distinctive "I Support Music Education" license plates. 1. 3 4 Any person residing in this state shall, upon request, be issued a distinctive license plate bearing the phrase "I Support Music Educa-6 tion". Application for said license plate shall be filed with the 7 commissioner in such form and detail as the commissioner shall 8 prescribe.
- 9 2. A distinctive plate issued pursuant to this section shall be issued 10 in the same manner as other number plates upon payment of the regular registration fee prescribed by section four hundred one of this article; 11 12 provided, however, that an additional annual service charge of twentyfive dollars shall be charged for such plates. 13

- 3. Each twenty-five dollars received as the annual service charge 15 under this section shall be deposited to the credit of the "I support music education" fund established pursuant to section ninety-five-i of the state finance law and shall be used for music education programs undertaken pursuant to section ninety-five-i of the state finance law.
- 19 § 2. The state finance law is amended by adding a new section 95-i to 20 read as follows:
- 21 § 95-i. "I support music education" fund. 1. There is hereby estab-22 lished in the joint custody of the commissioner of taxation and finance 23 and the comptroller a fund to be known as the "I support music educa-24 tion" fund.
- 2. Such fund shall consist of all revenues received pursuant to 25 26 section four hundred four-ee of the vehicle and traffic law, and all other moneys appropriated, credited or transferred thereto from any

1 other fund or source pursuant to law. Nothing contained in this section shall prevent the state from receiving grants, gifts or bequests for the purposes of the fund as defined in this section and depositing them into the fund according to law.

- 2-a. On or before the first day of February each year, the comptroller shall certify to the governor, temporary president of the senate, speaker of the assembly, chair of the senate finance committee and chair of the assembly ways and means committee, the amount of money deposited in the "I support music education" fund during the preceding calendar year as the result of revenue derived pursuant to section four hundred fouree of the vehicle and traffic law and from grants, gifts and bequests.
- 3. Monies of the fund shall be expended only for music education projects approved by the department of education in New York state.
- 4. Monies shall be payable from the fund on the audit and warrant of the comptroller on vouchers approved and certified by the commissioner of education.
- § 3. 1. A distinctive plate established pursuant to section 404-ee of the vehicle and traffic law shall only be designed, produced and issued upon the delivery to the department of motor vehicles of a surety bond in the amount of six thousand dollars, which shall be executed by a surety company authorized by the department of financial services to transact business in this state. Provided, however, that if the commissioner of motor vehicles shall have received prior to plate design, production and issuance at least two hundred orders for such distinctive 24 plate together with the additional annual service charge applicable to each such order, which shall be non-refundable, no such surety bond shall be required. All service charges collected pursuant to this section shall be deposited pursuant to the provisions of section 404-oo the vehicle and traffic law to the credit of the department of motor vehicles distinctive plate development fund established by section 95-i the state finance law and shall be used for the design, production, advertising and distribution of distinctive license plates in accordance with such section 95-i.
 - 2. If, upon the expiration of two years following the date upon which distinctive plates in the series are first available for sale two hundred or more sets of such plates are sold, a bond delivered pursuant to this section shall be discontinued. If fewer than two hundred sets of such plates are sold by such time, the department of motor vehicles shall be entitled to recover against the bond in an amount proportionate to such shortfall.
- § 4. This act shall take effect immediately; provided, however, that sections one and two of this act shall take effect on the one hundred eightieth day after it shall have become a law; and provided further, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its 46 effective date are authorized and directed to be made and completed on 47 or before such effective date.
