AN ACT to amend the education law, in relation to state appropriations for increases in tuition credit

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph 4 of paragraph h of subdivision 2 of section 355 of the education law is amended by adding a new clause (vii) to read 3 as follows:

(vii) Beginning in state fiscal year two thousand nineteen -- two thou-5 sand twenty and thereafter, the state shall appropriate and make avail-6 able general fund operating support to cover any increase in the tuition credit pursuant to section six hundred eighty-nine-a of this title annually.

9 § 2. Subparagraph 4 of paragraph h of subdivision 2 of section 355 of 10 the education law is amended by adding a new closing paragraph to read 11 as follows:

Beginning in state fiscal year two thousand nineteen -- two thousand 13 twenty and thereafter, the state shall appropriate and make available general fund operating support to cover any increase in the tuition credit pursuant to section six hundred eighty-nine-a of this title annually.
