Introduced by M. of A. CARROLL -- read once and referred to the Committee on Transportation

AN ACT to amend the vehicle and traffic law, in relation to implementing escalating penalties for vehicles which have been documented multiple times by a photo violation monitoring device for failure to comply with traffic-control indications

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision (e) of section 1111-a of the vehicle and traf-  
2 fic law, as amended by chapter 479 of the laws of 1994, is amended to  
3 read as follows:

4 (e) 1. An owner liable for a violation of subdivision (d) of section  
5 eleven hundred eleven of this article pursuant to a local law or ordi-  
6 nance adopted pursuant to this section shall be liable for monetary  
7 penalties in accordance with a schedule of fines and penalties to be set  
8 forth in such local law or ordinance, except that in a city which, by  
9 local law, has authorized the adjudication of such owner liability by a  
10 parking violations bureau, such schedule shall be promulgated by such  
11 bureau. The liability of the owner pursuant to this section shall not  
12 exceed fifty dollars for [~~each violation~~] the first two violations with-  
13 in a two year period, one hundred fifty dollars for the third violation  
14 within a two year period, two hundred fifty dollars for the fourth  
15 violation within a two year period, three hundred dollars for the fifth  
16 violation within a two year period, and three hundred fifty dollars for  
17 the sixth violation within a two year period; provided, however, that  
18 such local law or ordinance may provide for an additional penalty not in  
19 excess of twenty-five dollars for each violation for the failure to  
20 respond to a notice of liability within the prescribed time period.

21 2. (i) The company by which a vehicle has been documented five times  
22 within a two year period by a photo violation monitoring device for  
23 failure of an operator thereof to comply with traffic-control indi-  
24 cations is insured shall be informed of all such documented violations  
25 over the past two years.

1 (ii) The registration of a vehicle which has been documented six times  
2 within a twenty-four month period by a photo violation monitoring device  
3 for failure of an operator thereof to comply with traffic-control indi-  
4 cations shall be suspended for a period of ninety days commencing ten  
5 days after the notice of liability for the sixth violation has been  
6 mailed.

7 (iii) This paragraph shall not apply to a rental vehicle, as defined  
8 in section one hundred thirty-seven-a of this chapter.

9 3. The department shall, by certified mail, alert the owner of a  
10 registered vehicle after the vehicle's fourth documentation in two years  
11 by a photo violation monitoring device for failure of an operator there-  
12 of to comply with traffic-control indications that the company by which  
13 such vehicle is insured will be informed of all such violations over the  
14 past two years and such vehicle shall be suspended for ninety days after  
15 two more documentations.

16 § 2. This act shall take effect immediately; provided, however, the  
17 amendments made to subdivision (e) of section 1111-a of the vehicle and  
18 traffic law made by section one of this act shall not affect the repeal  
19 of such subdivision and shall be deemed repealed therewith.
