AN ACT to amend the real property tax law, in relation to providing that state lands within the Eastport-South Manor Central School District are subject to taxation for school purposes

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraphs (e) and (f) of subdivision 1 of section 536 of the real property tax law, paragraph (e) as amended by section 4 of part CC of chapter 58 of the laws of 2018 and paragraph (f) as added by section 1 of part W of chapter 62 of the laws of 2006, are amended to read as follows:

(e) Lands owned by the state, within the core preservation area of the Central Pine Barrens area as described and bounded by subdivision eleven of section 57-0107 of the environmental conservation law, situate in the following school districts:

20 2018, takes effect.
