- AN ACT to amend the mental hygiene law, in relation to providing for identification cards for individuals with autism spectrum disorder

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The mental hygiene law is amended by adding a new section 13.43 to read as follows:

3 <u>§ 13.43 Autism spectrum disorder card.</u>

(a) The commissioner shall develop an identification card denoting
that a person has been medically diagnosed with an autism spectrum
disorder. Such identification card may be presented to law enforcement,
firefighters and emergency medical services personnel as necessary.

8 (b) Upon the request of a person with an autism spectrum disorder, or 9 the guardian or caregiver of such person, the office shall issue such

10 autism spectrum disorder card in accordance with eligibility and

11 documentation criteria established by the office for a fee not to exceed

12 five dollars.
