- AN ACT to amend the environmental conservation law, in relation to providing a safe harbor exemption to commercial fishing vessels in certain emergency situations

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 71-0907 of the environmental conservation law is
amended by adding a new subdivision 8 to read as follows:
<u>8. Notwithstanding section 13-0334 of this chapter to the contrary, a.</u>
where a commercial fishing vessel, lawfully operating under the fishing
permits of another state: (1) encounters or is forecasted to encounter
unsafe weather conditions defined as high winds thirty-five knots or
greater or waves ten feet or higher or ice or other adverse condition
that make the continuation of the voyage unsafe and poses a risk to life
and property, or (2) experiences a mechanical problem, that makes the

continuation of the voyage unsafe and poses a risk to life and property 1 including compromised hull integrity or pump failures or (3) experiences 2 3 a significant medical emergency which requires immediate medical attention necessary to protect the health of any person on board, or (4) 4 5 experiences loss of essential gear such as support systems that renders б the vessel unable to remain at sea said commercial fishing vessel may dock at a New York port. A sinking vessel or a vessel leaking oil or 7 8 fuel may be otherwise directed when the safety of persons is maintained 9 and the vessel poses a significant threat to the waters of New York. The commercial fishing vessel may be required by the department to independ-10 11 ently verify the reason for the unscheduled dockage with a mechanic deemed qualified by New York state, the National Weather Service or a 12 13 medical professional, as appropriate. b. The fishing vessel shall imme-14 diately notify the department and the permitting state as soon as the 15 danger is known and communication signals allow. The commercial fishing vessel shall provide the department with: (1) details on the vessel 16 17 including the vessel captain's name; (2) identity of the permitting state; (3) the nature of the problem; (4) identity of the intended dock-18 ing location, estimated time of arrival, and quantities and types of 19 20 fish on board and, (5) a call back phone number or other method of 21 contact. c. The commercial fishing vessel shall not offload cargo with-22 out the express authorization of and supervision by department personnel. Authorization to offload fish may be granted where the fish on 23 24 board the vessel will become unmarketable due to the duration of the 25 unscheduled dockage. Authorization may be limited according to the 26 willingness of the permitting state to accept the fish under that 27 state's fish allocation. 28 § 2. Severability. The provisions of this act shall be severable and

29 if any portion thereof or the applicability thereof to any person or 30 circumstances shall be held invalid, the remainder of this act and the 31 application thereof shall not be affected thereby.

32 § 3. This act shall take effect immediately.
