AN ACT to amend the economic development law and the public officers law, in relation to the establishment of regional economic development councils; and providing for the repeal of such provisions upon expiration thereof

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The economic development law is amended by adding a new

No officer or employee of a state agency employed on a full-time 3 basis nor any firm or association of which such an officer or employee 4 5 is a member nor corporation a substantial portion of the stock of which б is owned or controlled directly or indirectly by such officer or employ-7 ee or member of a regional economic development council, should sell 8 goods or services to any person, firm, corporation or association which 9 is licensed or whose rates are fixed by the state agency in which such 10 officer or employee serves or is employed.

11 4. Violations. In addition to any penalty contained in any other 12 provision of law any such officer, member or employee or member of a regional economic development council who shall knowingly and inten-13 14 tionally violate any of the provisions of this section may be fined, 15 suspended or removed from office or employment in the manner provided by 16 law. Any such individual who knowingly and intentionally violates the 17 provisions of paragraph b, c, d or i of subdivision three of this section shall be subject to a civil penalty in an amount not to exceed 18 ten thousand dollars and the value of any gift, compensation or benefit 19 20 received as a result of such violation. Any such individual who knowing-21 ly and intentionally violates the provisions of paragraph a, e or q of 22 subdivision three of this section shall be subject to a civil penalty in 23 an amount not to exceed the value of any gift, compensation or benefit 24 received as a result of such violation.

25 § 4. This act shall take effect immediately and shall expire and be 26 deemed repealed two years after such date.
