- AN ACT to prohibit public employers from diminishing the health insurance benefits and contributions of certain retired public employees

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. On and after the effective date of this act, a public 1 employer shall be prohibited from diminishing the health insurance bene-2 3 fits provided to retirees and their dependents or the contributions such 4 employer makes for such health insurance coverage below the level of 5 such benefits or contributions made on behalf of such retirees and their dependents by such employer as of the effective date of this act. For 6 the purpose of this act, "public employer" shall mean the following: (i) 7 8 the state; (ii) a county, city, town or village; (iii) any governmental entity operating a college or university; (iv) a public improvement or 9 10 special district including police or fire districts; (v) a public authority, commission or public benefit corporation; or (vi) any other 11 public corporation, agency, instrumentality or unit of government which 12 exercises governmental power under the laws of this state. The term 13 public employer shall not include any school district, board of cooper-14 ative educational services, vocational education and extension board or 15 16 school district as enumerated in section 1 of chapter 566 of the laws of 17 1977, as amended.

18 § 2. Nothing contained in this act shall supersede or diminish the 19 terms of a collective bargaining agreement.

1 § 3. Notwithstanding the provisions of section one of this act to the 2 contrary, a public employer shall be prohibited from diminishing the 3 health insurance benefits provided to retirees who retire after the 4 effective date of this act from positions not subject to a collective 5 bargaining agreement and their dependents, or the contributions such 6 employer makes for such health insurance coverage, below the level of 7 such benefits or contributions made on behalf of active employees in 8 such positions as of the retiree's date of retirement.

9 § 4. Nothing contained in this act shall require a public employer 10 which does not provide health insurance benefits to retirees and their 11 dependents as of the effective date of this act to offer such benefits. 12 § 5. This act shall take effect on the thirtieth day after it shall 13 have become a law.
