AN ACT to amend the penal law, in relation to unlawfully fleeing a police officer in a motor vehicle

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Sections 270.25, 270.30 and 270.35 of the penal law, as 2 added by chapter 738 of the laws of 2006, are amended to read as follows:

§ 270.25 [Unlawful] Unlawfully fleeing a police officer in a motor vehicle in the third degree.

A person is guilty of [unlawfully fleeing a police officer in a motor vehicle in the third degree when, knowing that he or she has been directed to stop his or her motor vehicle by a uniformed police officer or a marked police vehicle by the activation of either the lights or the lights and siren of such vehicle, he or she thereafter 11 attempts to flee such officer or such vehicle by driving at speeds which 12 equal or exceed twenty-five miles per hour above the speed limit or engaging in reckless driving as defined by section twelve hundred twelve 14 of the vehicle and traffic law.

[Unlawful] Unlawfully fleeing a police officer in a motor vehicle in the third degree is a class [A misdemeanor] E felony. 16 17

§ 270.30 [Unlawful] Unlawfully fleeing a police officer in a motor vehicle in the second degree.

A person is guilty of [unlawful] unlawfully fleeing a police officer in a motor vehicle in the second degree when he or she commits the offense of [unlawful] unlawfully fleeing a police officer in a motor 22 vehicle in the third degree, as defined in section 270.25 of this article, and as a result of such conduct a police officer or a third person 24 suffers serious physical injury.

1 [$\frac{Unlawful}{Unlawfully}$] fleeing a police officer in a motor vehicle in 2 the second degree is a class [$\frac{E}{2}$] \underline{D} felony.

§ 270.35 [Unlawful] Unlawfully fleeing a police officer in a motor vehicle in the first degree.

A person is guilty of [unlawful] unlawfully fleeing a police officer in a motor vehicle in the first degree when he or she commits the offense of [unlawful] unlawfully fleeing a police officer in a motor vehicle in the third degree, as defined in section 270.25 of this article, and as a result of such conduct a police officer or a third person is killed.

11 [$\frac{Unlawful}{Unlawfully}$] fleeing a police officer in a motor vehicle in 12 the first degree is a class [$\frac{D}{U}$] $\frac{C}{U}$ felony.

§ 2. This act shall take effect immediately.
