Introduced by M. of A. AUBRY -- read once and referred to the Committee on Education

AN ACT to amend the education law and the public health law, in relation to directing the commissioners of education and health to establish rules and regulations for the treatment and monitoring of students of school districts, boards of cooperative educational services and nonpublic schools who exhibit signs or symptoms of sudden cardiac arrest

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as  
2 the "Dominic Murray sudden cardiac arrest prevention act".

3 § 2. Section 305 of the education law is amended by adding a new  
4 subdivision 56 to read as follows:

5 56. a. The commissioner, in conjunction with the commissioner of  
6 health, shall promulgate and review as necessary rules and regulations  
7 relating to pupils who exhibit signs or symptoms of sudden cardiac  
8 arrest while receiving instruction or engaging in any school sponsored  
9 or related activity. In developing such rules and regulations, the  
10 commissioner shall consider comments from stakeholders and other inter-  
11 ested parties including but not limited to parents, teachers, students,  
12 school administrators, school athletic trainers, sport coaches, medical  
13 and health professionals, the public schools athletic league (PSAL), the  
14 New York state public high school athletic association (NYSPHSAA), and  
15 other athletic associations. Such regulations shall include, but not be  
16 limited to:

17 (i) requiring a course of instruction relating to recognizing pupils  
18 who exhibit signs or symptoms of sudden cardiac arrest and seeking prop-  
19 er medical treatment for such pupils. Such course of instruction shall  
20 be required to be completed on a biennial basis by all school coaches,  
21 physical education teachers, nurses and athletic trainers. The course of

1 instruction required by this subparagraph shall include, but not be  
2 limited to, the definition of a "sudden cardiac arrest," signs and symp-  
3 toms of sudden cardiac arrest, and the guidelines for the return to  
4 school and to certain school activities after a pupil has exhibited  
5 signs or symptoms of sudden cardiac arrest regardless of whether such  
6 sudden cardiac arrest occurred outside of school. Such training may be  
7 completed by means of courses of instruction, including but not limited  
8 to, courses provided online and by teleconference approved by the  
9 department;

10 (ii) providing that the department and the department of health shall  
11 post on their internet websites information relating to sudden cardiac  
12 arrest, which shall include but not be limited to, the definition of a  
13 "sudden cardiac arrest," signs and symptoms of sudden cardiac arrest,  
14 and the guidelines for the return to school and to certain school activ-  
15 ities after a pupil has exhibited signs or symptoms of sudden cardiac  
16 arrest regardless of whether such sudden cardiac arrest occurred outside  
17 of school. Schools shall be required to include such information in any  
18 permission form or parent or person in parental relation consent form or  
19 similar document that may be required for a pupil's participation in  
20 interscholastic sports and shall also include such information, or  
21 reference how to obtain such information from the department and the  
22 department of health internet websites, on the school's internet  
23 website, if one exists;

24 (iii) requiring the immediate removal from athletic activities of any  
25 pupil believed to exhibit signs or symptoms of sudden cardiac arrest. In  
26 the event that there is any doubt as to whether a pupil has exhibited  
27 signs or symptoms of sudden cardiac arrest, it shall be presumed that he  
28 or she has exhibited such signs or symptoms until proven otherwise. No  
29 such pupil shall resume athletic activity until he or she shall have  
30 been evaluated by and received written and signed authorization from a  
31 licensed physician. Such authorization shall be kept on file in the  
32 pupil's permanent health record. Furthermore, such rules and regulations  
33 shall provide guidelines for limitations and restrictions on school  
34 attendance and activities for pupils who have exhibited signs or symp-  
35 toms of sudden cardiac arrest, consistent with the directives of the  
36 pupil's treating physician;

37 (iv) authorizing each school or school district, in its discretion, to  
38 establish a sudden cardiac arrest management team which may be composed  
39 of the athletic director (if any), a school nurse, the school physician,  
40 a coach of the interscholastic team, an athletic trainer or such other  
41 appropriate personnel as designated by the school or school district.  
42 The sudden cardiac arrest management team shall oversee the implementa-  
43 tion of the rules and regulations promulgated pursuant to this subdivi-  
44 sion as it pertains to their associated school including the requirement  
45 that all school coaches, physical education teachers, nurses and athlet-  
46 ic trainers that work with and provide instruction to pupils engaged in  
47 school sponsored athletic activities complete training relating to  
48 sudden cardiac arrest. Furthermore, every sudden cardiac arrest manage-  
49 ment team may establish and implement a program which provides informa-  
50 tion on sudden cardiac arrest to parents and persons in parental  
51 relation throughout each school year.

52 b. The rules and regulations established pursuant to this subdivision  
53 shall be deemed to be the minimum standards that must be complied with  
54 by every public school relating to sudden cardiac arrest. Such rules and  
55 regulations may also be implemented by nonpublic schools if they so  
56 authorize. Nothing in this subdivision shall prohibit any public school

1 or nonpublic school from adopting and implementing more stringent stand-  
2 ards.

3 § 3. Section 206 of the public health law is amended by adding a new  
4 subdivision 31 to read as follows:

5 31. The commissioner shall assist the commissioner of education in  
6 developing rules and regulations, relating to pupils who exhibit signs  
7 or symptoms of sudden cardiac arrest, in accordance with subdivision  
8 fifty-six of section three hundred five of the education law, and  
9 provide for the posting on the department's internet website of such  
10 information as shall be required pursuant to such subdivision.

11 § 4. This act shall take effect on the first of July next succeeding  
12 the date on which it shall have become a law; provided, that, effective  
13 immediately, any rules and regulations necessary to implement the  
14 provisions of this act on its effective date are authorized and directed  
15 to be completed on or before such date.
