Introduced by M. of A. FINCH, BUTLER, HAWLEY, JOHNS -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the environmental conservation law, in relation to establishing a Senior Environmental Corps that would utilize the expertise of professional seniors for environmental and natural resource programs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The environmental conservation law is amended by adding a 2 new article 48 to read as follows:
