AN ACT to amend the vehicle and traffic law, in relation to requirements for licensing

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 4 of section 502 of the vehicle and traffic law 2 is amended by adding a new paragraph (c-3) to read as follows:

(c-3) "Motorcycle Safety" awareness component. The commissioner shall provide in the pre-licensing course, set forth in paragraph (b) of this subdivision, a mandatory component in "Motorcycle Safety" awareness education as a prerequisite for obtaining a license to operate a motor vehicle. The purpose of the component is to educate prospective licensees on the potential dangers to persons operating motorcycles on the roadway.

- § 2. Subparagraph (i) of paragraph (a) of subdivision 4 of section 502 of the vehicle and traffic law, as amended by chapter 97 of the laws of 11 2016, is amended to read as follows:
- 13 (i) Upon submission of an application for a driver's license, the 14 applicant shall be required to take and pass a test, or submit evidence of passage of a test, with respect to the laws relating to traffic, the 15 laws relating to driving while ability is impaired and while intoxicat-16 ed, under the overpowering influence of "Road Rage", [ex] "Work Zone 17 Safety" awareness and "Motorcycle Safety" awareness as defined by the 18 19 commissioner, the law relating to exercising due care to avoid colliding 20 with a parked, stopped or standing authorized emergency vehicle or 21 hazard vehicle pursuant to section eleven hundred forty-four-a of this chapter, the ability to read and comprehend traffic signs and symbols and such other matters as the commissioner may prescribe, and to satis-24 factorily complete a course prescribed by the commissioner of not less

1 than four hours and not more than five hours, consisting of classroom driver training and highway safety instruction or the equivalent thereof. Such test shall include at least seven written questions concerning 3 the effects of consumption of alcohol or drugs on the ability of a person to operate a motor vehicle and the legal and financial consequences resulting from violations of section eleven hundred ninety-two of this chapter, prohibiting the operation of a motor vehicle while under the influence of alcohol or drugs. Such test shall include one or 9 more written questions concerning the devastating effects of "Road Rage" 10 on the ability of a person to operate a motor vehicle and the legal and 11 financial consequences resulting from assaulting, threatening or interfering with the lawful conduct of another person legally using the road-12 13 way. Such test shall include one or more questions concerning the poten-14 tial dangers to persons and equipment resulting from the unsafe 15 operation of a motor vehicle in a work zone. Such test shall include one 16 or more questions concerning the potential dangers to persons operating 17 motorcycles on the road. Such test may include one or more questions concerning the law for exercising due care to avoid colliding with a 18 parked, stopped or standing vehicle pursuant to section eleven hundred 19 20 forty-four-a of this chapter. Such test shall be administered by the 21 commissioner. The commissioner shall cause the applicant to take a 22 vision test and a test for color blindness. Upon passage of the vision 23 test, the application may be accepted and the application fee shall be 24 payable.
