AN ACT to amend the general business law, in relation to human trafficking awareness and training

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The general business law is amended by adding a new section  
2 205 to read as follows:

3 § 205. Human trafficking awareness and training. 1. Human trafficking  
4 recognition training program. a. For purposes of this section, "lodging  
5 facility" shall mean any hotel, motel, motor court, apartment hotel,  
6 resort, inn, boarding house, rooming house or lodging house.

7 b. Every lodging facility shall require all employees to undergo a  
8 human trafficking recognition training program to provide training in  
9 the recognition of a human trafficking victim as defined in section four  
10 hundred eighty-three-aa of the social services law. Such training  
11 program shall be approved by the division of criminal justice services  
12 and the office of temporary and disability assistance in consultation  
13 with the New York state interagency task force on human trafficking. The  
14 training program may be developed by a federal, state, or non-profit  
15 organization, and may be incorporated as part of the lodging facility's  
16 existing training programs or may be provided by organizations or  
17 providers identified by the commissioner of the division of criminal  
18 justice services or the commissioner of the office of temporary and  
19 disability assistance, provided that the training includes all of the  
20 requirements of this section.

1 c. Any human trafficking recognition training program approved by the  
2 division of criminal justice services and the office of temporary and  
3 disability assistance in consultation with the New York state interagen-  
4 cy task force on human trafficking as required in this section shall  
5 address no less than the following issues:

6 (i) the nature of human trafficking;

7 (ii) how human trafficking is defined in law;

8 (iii) how to identify victims of human trafficking;

9 (iv) relief and recovery options for survivors; and

10 (v) social and legal services available to victims.

11 d. The commissioner of the division of criminal justice services and  
12 the commissioner of the office of temporary and disability assistance  
13 shall make available no more than six months after the effective date of  
14 this section a list of approved human trafficking recognition programs  
15 for use by a lodging facility.

16 2. Posting of notice concerning services for human trafficking  
17 victims. Every keeper of a lodging facility shall post in plain view and  
18 in a conspicuous place and manner in the lobby and in the public rest-  
19 rooms of such lodging facility a notice developed by the office of  
20 temporary and disability assistance in consultation with the New York  
21 state interagency task force on human trafficking which shall include  
22 the national human trafficking hotline telephone number.

23 § 2. This act shall take effect on the one hundred eightieth day after  
24 it shall have become a law; provided however, that effective immediate-  
25 ly, the commissioner of the division of criminal justice services and  
26 the commissioner of the office of temporary and disability assistance  
27 may make regulations and take other actions necessary to implement this  
28 act on its effective date.
