Introduced by M. of A. BRINDISI -- read once and referred to the Committee on Transportation -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the transportation law, in relation to establishing the temporary advisory board on upstate transit funding; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The transportation law is amended by adding a new article  
2 2-G to read as follows:

### ARTICLE 2-G

#### TEMPORARY ADVISORY BOARD ON UPSTATE TRANSIT FUNDING

3 Section 74-a. Temporary advisory board on upstate transit funding.

4 74-b. Assistance of other agencies.

5 § 74-a. Temporary advisory board on upstate transit funding. 1. There  
6 is hereby created in the department a board, to be known as the tempo-  
7 rary advisory board on upstate transit funding. Such board shall study,  
8 develop and make specific recommendations with respect to sustainable  
9 state funding options for the growth and stability of the public trans-  
10 portation systems operating assistance account, hereinafter referred to  
11 as "PTSOA account", of the mass transportation operating assistance  
12 fund. As part of such study, the board may provide an opportunity for  
13 public comment including public hearings.

14 2. Such board shall consist of the commissioner and nine other members  
15 to be appointed by the governor as follows: two upon the recommendation  
16 of the temporary president of the senate, two upon the recommendation of  
17 the speaker of the assembly, one upon the recommendation of the minority  
18 leader of the senate, one upon the recommendation of the minority leader  
19 of the assembly, and three without recommendation from any other person.  
20 Of the nine members appointed by the governor, at least two shall be  
21 representatives of local governments receiving PTSOA account funds, at

1 least two shall be representatives of public transportation authorities  
2 receiving PTSOA account funds, at least two shall be representatives of  
3 labor unions affiliated with public transportation systems receiving  
4 PTSOA account funds, and at least two shall be representatives of riders  
5 of public transportation systems receiving PTSOA account funds.

6 3. The commissioner shall serve as chair of the board, and personnel  
7 of the department shall provide, from existing staff, services to the  
8 board so that it may perform its duties.

9 4. Board members shall be appointed within thirty days after the  
10 effective date of this article; provided, however, that after the expi-  
11 ration of the thirty day period, the appointment of a majority of the  
12 members shall constitute a quorum. Board members shall serve without  
13 compensation.

14 5. The board shall prepare a report on or before December first, two  
15 thousand eighteen on its findings and specific recommendations for  
16 sustainable funding options for the growth and stability of the PTSOA  
17 account. Such report shall be delivered by such date to the governor,  
18 the temporary president of the senate, the speaker of the assembly, the  
19 chair of the senate finance committee, the chair of the assembly ways  
20 and means committee, the chair of the senate transportation committee,  
21 the chair of the assembly transportation committee, the chair of the  
22 senate corporations, authorities and commissions committee and the chair  
23 of the assembly corporations, authorities and commissions committee.

24 § 74-b. Assistance of other agencies. To effectuate the purposes of  
25 this article, the board may request and shall receive from any depart-  
26 ment, division, board, bureau, commission or other agency of the state  
27 or any state public authority such assistance, information and data as  
28 will enable the board properly to conduct its study and make its recom-  
29 mendations.

30 § 2. This act shall take effect immediately and shall expire and be  
31 deemed repealed on the one hundred twentieth day after the temporary  
32 advisory board on upstate transit funding has submitted its completed  
33 report as required by section one of this act, provided that the commis-  
34 sioner of transportation of the state of New York shall notify the  
35 legislative bill drafting commission upon the occurrence of the  
36 submission of the completed report as required by section one of this  
37 act in order that the commission may maintain an accurate and timely  
38 effective data base of the official text of the laws of the state of New  
39 York in furtherance of effectuating the provisions of section 44 of the  
40 legislative law and section 70-b of the public officers law.
