- AN ACT to amend the economic development law, in relation to developing a senior tourism program

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Legislative intent. The legislature recognizes that the 1 2 renewed focus on the tourism industry in New York state led to all-time 3 high levels of tourism. The legislature also recognizes that a large 4 portion of the state's population is aging. It is the intent of this legislature to create a state tourism program focused specifically on 5 6 seniors in an effort to encourage them to choose New York state as their vacation destination. This program will not only bolster the reputation 7 8 of New York as a tourist destination for all, but provide increased 9 employment opportunities in the tourism sector and encourage seniors to 10 age actively.

11 § 2. The economic development law is amended by adding a new article 12 5-F to read as follows:

"Senior friendly attraction" shall mean a tourism attraction that 1 2. 2 optimizes opportunities for seniors in order to enhance their quality of life. 3 4 <u>§ 181-g. Senior tourism program. 1. The commissioner, in conjunction</u> 5 with the commissioner of parks, recreation and historic preservation, б and the director of the office for the aging and in consultation with applicable local government officials shall develop and implement a 7 8 senior tourism program. Such program shall identify senior-friendly 9 tourism attractions in each of the state's tourism regions. In identify-10 ing specific tourism attractions to be included in the program, consideration shall be given to attractions that can be linked to surrounding 11 artistic, cultural, historical, and entertainment attractions or other 12 13 tourism destinations. 14 2. The senior tourism program shall identify for visitors of senior friendly attractions the surrounding attractions, restaurants, lodging 15 16 and other exhibits or places of entertainment. 17 3. The commissioner shall conduct a public outreach campaign to inform the public of the senior tourism program and the senior friendly 18

19 attractions in such program. Such information shall be publicly avail-20 able and posted on the websites of the department, the office of parks, 21 recreation and historic preservation, and the office for the aging.

22 § 3. This act shall take effect on the ninetieth day after it shall 23 have become a law.
