AN ACT to amend the public service law and the state finance law, in relation to instituting internet service neutrality

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The article heading of article 11 of the public service law, as added by chapter 83 of the laws of 1995, is amended to read as 2 3 follows: 4 PROVISIONS RELATING TO CABLE TELEVISION AND INTERNET 5 **SERVICE** COMPANIES б § 2. Section 212 of the public service law is amended by adding a new 7 subdivision 15 to read as follows: 15. "Internet service provider" shall mean any person, business or 8 organization qualified to do business in this state, including municipal 9 broadband providers, that provides individuals, corporations, or other 10 11 entities with the ability to connect to the internet. 12 3. The section heading of section 215 of the public service law, as S 13 added by chapter 83 of the laws of 1995, is amended and a new subdivision 14 is added to read as follows: 14 15 Duties of the commission in respect to cable television and internet

20	§ 231. Internet service neutrality. 1. For purposes of this section,
21	"reasonable network management" shall mean a network management practice
22	is a practice that has a primarily technical network management justi-
23	fication, but does not include other business practices. A network
24	management practice is reasonable if it is primarily used for and
25	tailored to achieving a legitimate network management purpose, taking
26	into account the particular network architecture and technology of the
27	broadband internet access service.
28	2. The commission shall certify annually that any internet service
29	provider qualified to do business in this state, does not:
30	(a) block lawful content, applications, services, or non-harmful
31	devices, subject to reasonable network management.
32	(b) impair or degrade lawful internet traffic on the basis of internet
33	content, application, or service, or use of a non-harmful device,
34	subject to reasonable network management.
35	(c) engage in paid prioritization, including, but not limited to,
36	traffic shaping, prioritization, resource reservation, or other forms of
37	preferential traffic management, either (i) in exchange for consider-
38	ation (monetary or otherwise) from a third party, or (ii) to benefit an
39	affiliated entity.
40	§ 6. This act shall take effect on the thirtieth day after it shall
