AN ACT to amend the education law, in relation to enacting the student journalist free speech act

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The education law is amended by adding a new article 18 to read as follows:

ARTICLE 18

STUDENT JOURNALIST FREE SPEECH ACT

- 10 <u>§ 860. Short title. This article shall be known and may be cited as</u>
 11 <u>the "student journalist free speech act".</u>
- 12 <u>§ 861. Definitions. For the purposes of this article the following</u>
 13 <u>terms shall have the following meanings:</u>
- 14 <u>1. "Educational institution" means a public or private educational</u>
 15 <u>institution or separate school or department of a public or private</u>
- 16 <u>educational institution, and includes: an academy; an elementary or</u> 17 <u>secondary school; an extension course; a kindergarten; a school system;</u>
- 18 a school district; an intermediate school district; a business, nursing,
- 10 a school district; an intermediate school district; a business, nursing,
- 19 professional, secretarial, technical, or vocational school; a college; a
- 20 <u>university; a public or private educational testing service or adminis-</u>
- 21 trator; and an agent of an educational institution. Educational insti-
- 22 tution shall be construed broadly to include public and private insti-
- 23 tutions of higher education to the greatest extent consistent with
- 24 <u>constitutional limitations</u>.
- 25 2. "School-sponsored media" means any material that is prepared,
- 26 <u>substantially written, published, or broadcast by a student journalist</u>
- 27 at an educational institution, distributed or generally made available
- 28 to members of the student body, and prepared under the direction of a

student media advisor. "School-sponsored media" shall not include media intended for distribution or transmission solely in the classroom in which the media is produced. 3

- 3. "Student journalist" means a student enrolled in an educational institution who gathers, compiles, writes, edits, photographs, records, or prepares information for dissemination in school-sponsored media.
- 4. "Student media advisor" means an individual employed, appointed, or designated by an educational institution to supervise or provide instruction relating to school-sponsored media.
 - § 862. Student journalist free speech rights. 1. Except as otherwise provided in section eight hundred sixty-three of this article, a student journalist shall have the right to exercise free speech and of the press school-sponsored media, regardless of whether the media is supported financially by the educational institution or by use of the facilities of an educational institution or produced in conjunction with a class in which the student is enrolled.
- 2. Subject to section eight hundred sixty-three of this article, the appropriate student journalist shall be responsible for determining the news, opinion, feature, and advertising content of school-sponsored media.
- 3. Nothing in this section shall preclude a student media advisor from teaching professional standards of English and journalism to student <u>journalists.</u>
- 4. There shall be no prior restraint of material prepared for official 24 25 publications of an educational institution except for the material 26 described in section eight hundred sixty-three of this article.
 - 5. Educational institution administrators shall have the burden of demonstrating justification without undue delay prior to a limitation of student expression under this article.
- 30 § 863. Exemptions. The following forms of expression shall not be 31 protected by this article:
 - 1. Expression that is libelous, slanderous or obscene;
 - 2. Expression that constitutes an unwarranted invasion of privacy;
 - 3. Expression that violates federal or state law; or
- 35 4. Expression that incites students to commit an unlawful act, to violate the policies of the educational institution, or to materially 36 and substantially disrupt the orderly operation of such educational 37 38 institution.
- § 864. Liability. No expression made by students in the exercise of free speech or freedom of the press protected by this article shall be deemed to be an expression of policy of the educational institution, and no educational institution, employee, parent, legal quardian or administrator of an educational institution shall be held liable in any civil or criminal action for any expression made or published by students, 44 except in cases of willful or wanton misconduct.
 - § 2. This act shall take effect immediately.
